



Learned counsel for the appellant argued that the appellant was appointed as Subject Specialist on the recommendation of Public Service Commission on 16 March, 2015 and was posted in GHSS Kalam District Swat. While referring to the advertisement dated 24.07.2013 the learned counsel for the appellant argued that there was no conditionality of school based appointment in the said advertisement adding further that this cadre was Provincial cadre and that there is no such provision in the Civil Servant Act 1973 for making appointment in the manner and mode as done in the instant case. He further argued that the appellant agitated the issue of school base appointment as given at serial No. 7 of terms and conditions of notification of appointment before the departmental authority on 04.06.2016 which was rejected through a non speaking order on 15.07.2016. He further added that identical case of principals of the Elementary and Secondary Education Department agitating against the school base appointment was recently admitted by this Service Tribunal for regular hearing and requested for admitting the instant case.

Points urged need consideration. Admit. Subject to deposit of security and process fee within 10 days, notices be issued to the respondents for written reply/comments for 14.12.2016 before S.B.









APPOINTMENT ORDER MAY BE DECLARED AS ILLEGAL,
UNLAWFUL, WITHOUT LAWFUL AUTHORITY AND AGAINST THE
PRINCIPLES GOVERNING PROVINCIAL CADRE POST. THE
RESPONDENTS MAY FURTHER BE DIRECTED TO
AMEND/WITHDRAW THE CONDITION NO.7 OF THE
APPOINTMENT ORDER DATED 10.12.2014 BY DECLARING THE
SUBJECT SPECIALIST POST AS TRANSFERABLE POST BEING
PROVINCIAL CADRE POST. ANY OTHER REMEDY WHICH THIS
AUGUST TRIBUNAL DEEMS FIT AND APPROPRIATE THAT MAY
ALSO BE AWARDED IN FAVOUR OF APPELLANT.

RESPECTFULLY SHEWETH:

FACTS:

1. That the posts of Subject Specialist were advertised by the Public Service Commission vide advertisement dated 24.7.2013. The specific condition mentioned is as noted in the advertisement that a person appointed as Subject Specialist shall be transferable only to the post relevant to his subject. It clearly shows that Subject Specialist is a Provincial cadre post which was required to be filled on zonal based quota. (Copy of advertisement is attached as Annexure-A)
2. That the appellant participated in a competitive exam and was finally appointed as Subject Specialist vide notification dated 10.12.2014. In the terms and conditions of the appointment order the appellant is declared as a regular civil servant of the Province and was made liable to be governed by such rules and regulations as may be issued from time to time by the Government for Civil Servants. (Copy of appointment order is attached as Annexure-B)
3. That in the appointment order, condition No.7 is also included wherein the appointment of the appellant as Subject Specialist was declared as School based and non transferable, which is certainly against the rule, regulation and cadre policy of the Government.
4. That against the said illegal condition whereby a Provincial cadre post has been given the status of School based non transferable, the appellant filed a departmental appeal for amendment and drawing of condition No.7, but the same has also been rejected without showing any reason on 15.7.2016. (Copies of departmental appeal and rejection order are attached as Annexure-C&D)
5. That now the appellant has no other remedy, but is constrained to file the instant appeal on the following grounds among others.

GROUND:

- A) That the impugned order dated 15.7.2016 is against the law, rules, facts and norms of justice. Therefore, it is not maintainable and liable to be set aside.
- B) That condition No.7 is also against the advertisement in which no such condition was specified, thus declaring the appointment

of the appellant as School based in condition No.7 of the appointment order is against the principle of promissory estoppel.

- C) That the seniority of Subject Specialist is maintained on Provincial bases which specifically proved that Subject Specialist is a Provincial cadre post and cannot be restricted to particular place and not transferable. Thus the condition No.7 of the appointment order is the violation of law, rules and regulation governing the cadre.
- D) That there is no official notification duly published in official gazette issued by the competent authority for declaring the Subject Specialist as School based non transferable post. Thus the condition No.7 of the appointment order issued by the respondents is total violation of Section-10 of Civil Servant Act 1973.
- E) That the treatment of the respondents including condition No.7 in the appointment order is also discriminatory because the officials who are posted as Subject Specialist are liable to transferable whereas the same benefit has been denied to the appellant despite the fact he also belongs to Subject Specialist cadre.
- F) That even in the recruitment rules made for Subject Specialist no such condition is available. Thus by inserting condition No.7 in the appointment order of the appellant, the respondents have exceeded from their legal ambit.
- G) That condition NO.7 which was not mentioned in the advertisement will also cause great hardship to the appellant because despite of post availability, the appellant could not be posted and would remain in far flung areas for ever.
- H) That even condition No.7 is not mentioned in the advertisement published in year 2014, 2015 and 2016 rather such condition (condition No.7) is also against the rules under which the appellant has to be promoted to BPS-18, because such promotion is to be made on seniority maintained at Provincial level and not on the basis of seniority on basis of School base appointment.
- I) That the appellant has not been treated according to law and rules governing the services of Civil servant.
- J) That the appellant seeks permission to advance other grounds and proofs at the time hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.
