COMMENTS ON BEHALF OF THE RESPONDENT NO. 4

Respectfully Sheweth:-

PRELIMINARY OBJECTION

- 1. That the appellant is not an aggrieved person, nor she has got the locus standi to file the present appeal as there is no irregularity in the transfer order.
- That the appellant is estopped by his own conduct to bring the present appeal.
- 3. That under the posting/transfer policy, the appellant has completed her tenure, so the transfer order is in conformity of the ibid rules and policy.
- 4. That no vested or accrued or legal right of the appellant has been infringed to warrant interference.
- 5. That the appeal of the appellant is neither maintainable in law nor on facts.
- That even otherwise, the official respondents are empowered under section 10 of Civil Servant Act,
 1973 for placing the services of the appellant

throughout the province, wherever required in the best public interest.

ON FACTS:-

- 1. Pertains to record.

- 3. Proof of wedlock pertains to record. However even otherwise admittedly the spouse of the appellant has also completed his two years of tenure.
- 4. Correct. Further to add that the appellant was first posted at GGDC Gulshan Rehman vide order dated 11.06.2021 and after completion of her tenure under the posting/transfer policy, the appellant has now been transferred vide order dated 12.10.2023 after timespan of 2 years and 4 months. (Copy of order dated 11.06.2021 is attached as Annexure A)
- 5. Correct to the extent of posting/transfer, the last part is misleading as sanctioned posts based on a specific subject are in BPS-17 only while the posts of Assistant Professor, Associate Professor are sanctioned in Basic Pay Scale i.e. BPS-18, 19, 20 etc. irrespective of the specialized subject.
- 6. That the answering respondent has been recently promoted from Assistant Professor BPS-18 to Associate Professor BPS-19 vide order dated

30.05.2023 and now has been posted at GGDC Gulshan Rehman, Peshawar.

- 7. Pertains to record and reply of official respondents.
- 8. That the appellant has completed her tenure at the GGDC Gulshan Rehman, Peshawar and now official respondents are empowered under section 10 of Civil Servant Act, 1973 to post the appellant or any civil servant anywhere in the province.
- 9. Already been answered in para 4 and 8 of the comments.
- 10. Correct.
- 11. Incorrect, misleading, The referred corrigendum was rather a request moved by the Deputy Director (F) on behalf of the appellant to the Secretary Higher Education for retaining the services of the appellant at the same College which has not been answered.
- 12. Needs no reply.

ON GROUNDS:

- A. That the contents of ground A and B of the appeal are result of misconception of law, her plea for withdrawal of transfer order despite the completion of her tenure under rules/policy is not warranted by law.
- B. That contents of this Para C is the is result of misconception because spouse policy is not stricto

sensu but is subject to application and availability of the post.

- That contents of Ground D to K has already been C. answered in the preliminary objections as well as in reply on facts and grounds.
- That content of Ground L is discretion of honourable D. Tribunal, however, one cannot be allowed to take other by surprise.

It is, therefore, prayed that on acceptance of this appeal the appeal in hand being devoid of force be dismissed with cost.
