

Prayer:-

That on acceptance of the instant service appeal, the name of the appellant may please be included in the final seniority list of SCT/CT of District Kohat from the date of his regular appointment i.e. 30/08/2003 as per Rule 17(5) of the APT Rule, 1989. Any other remedy which this august Tribunal deem fit may also be awarded in favour of the appellant

R/SHEWETH:

ON FACTS:

- 1) That the appellant was initially appointed as PTC BPS-07 in the respondent department vide Office Order dated 28/08/1994. Copy of the office order is attached as annexure.....A

- 2) That subsequently the appellant was adjusted on the post of CT vide order dated 30/08/2003. Copy of order dated 30/08/2003 is attached as annexure.....**B**
- 3) That after promulgation of 25th Constitutional Amendment, FATA was merged in to KP and similarly FR Kohat was merged into District Kohat. Copies of the Service Books of the appellant maintained in defunct FATA as well as District Kohat are attached as annexure.....**C**
- 4) That the appellant was transferred to GCHS Kohat against vacant post vide order dated 04/11/2021 & 09/11/2021. Copies of orders are attached as annexure.....**D**
- 5) That astonishingly the name of the appellant has not been incorporated in the seniority list of SCT/CT of District Kohat till date. Copy of final seniority list of SCT/CT as stood on 31/12/2022 is attached as annexure.....**E**
- 6) That the appellant feeling aggrieved filed Departmental appeal before the competent authority, but no reply has been received so far. Copy of departmental appeal is attached as annexure.....**F**
- 7) That appellant having no other remedy, filed the instant service appeal on the following grounds amongst other:-

GROUND:

- A- That action and inaction of the respondents by not including the name of the appellant in the final seniority list of SCT/CT of District Kohat is against the law, facts, norms of natural justice and materials on the record hence not tenable and liable to be modified/rectified.
- B- That appellant has not been treated by the respondent Department in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C- That, the treatment meted out to the appellant is clearly based on discrimination and malafide and as such the respondents violated the principle of natural justice.

- D- That the name of the appellant is liable to be incorporated in the final seniority list of SCT/CT from the date of his regular appointment i.e. 30/08/2003 as per Rules 17(5) of APT Rules, 1989.
- E- That the respondents violated the Rule-17 of the APT Rules.
- F- That appellant seeks permission to advance other grounds and proofs at the time of hearing.


