The submissions are as under:

1) That the appellant was appointed against the post of Qari vide order dated 30.04.2007. (Copy is annexed as Annexure **A**)

2) That the appellant was also promoted from Qari to Senior Qari vide order dated 28.09.2015. (Copy is annexed as Annexure \mathbf{B})

3) That the appellant is senior most in the seniority list of Senior Qaris to be promoted against the post of SST(Math/Physics) BPS-16 being qualified duly. (Copy is annexed as Annexure $\mathbf{B/1}$)

3) That the appellant is qualified upto BSc(Math A&B and Physics). (Copies of DMCs & Degrees are annexed as Annexure C)

4) That the appellant has also obtained the degree of B.Ed. (Copy of Degree is annexed as Annexure \mathbf{D})

5) That for the promotion against the post of SST(Math/Physics), the BSc along with B.Ed is requisite qualification as per policy of the department which is fulfilled by the appellant.

6) That the department has allocated 75% share for promotion from junior cadres against the post of SST and remaining 25% share for initial/fresh recruitment.

7) That the department has also allocated 3% share for the promotion of Senior Qari to SST, as per notification dated 24-07-2014. (Copy of Notification/Policy is annexed as Annexure **D/1**)

8) That the department has showed 14 vacant posts of SST(Math/Physics) in year 2016 by reserving 03-posts for initial recruitment and 11-posts for the promotion, whereas only 3-persons were promoted. <u>And</u> the department has also showed 20 vacant posts of SST(Math/Physics) in year 2017 by reseving 04-posts for initial recruitment and 16-posts for the promotion, however surprisingly, only 3-persons were promoted and rest of the meritorious on the basis of seniority were ignored including the appellant. Hence, the appellant amongst others was liable to be promoted along with his batchmates. (Copy of notifications are annexed as Annexures E/1 & E/2)

9) That again more astonishingly, the department appointed 20 fresh candidates against the post of SST(Math/Physics) via an appointment order dated 20-04-2017 without fullfilment of 75% quota reserved for promotion against the post of SST (M/P) BPS-16. (Copy of order is annexed as Annexure $\mathbf{E/3}$)

10) That the department has appointed fresh candidates against the post of SST(Math/Physics) over and above the 25% share as per policy.

11) That the appellant is liable to be promoted with all back benefits being an employee of good as well as reputable attitude in providing his services.

12) That the appeal of appellant is liable to be accepted inter alia on the following grounds:

GROUNDS:-

That depriving the appellant from due promotion and not deciding the departmental appeal is against the law and spirit of justice, hence the instant appeal before this Hon'Tribunal is liable to be accepted.

- That appellant has not been treated in accordance with law and rules by the respondent Department on the subject noted above and as such the respondents violated A.04 & 25 of the Constitution of Islamic Republic of Pakistan,1973.
- c. That the respondents acted arbitrarily and malafidely by not promoting the appellant as per the notification dated 24-07-2014.

- That the department has appointed fresh candidates against the post of SST(Math/Physics) over and above the 25% share as per policy.
 - That the action of the respondents is discriminatory in nature as the promotion/recruitment policy is not being followed duly ever since 2014.
- That u/A. 38(e) of the Constitution of Islamic Republic of Pakistan,1973, the state is bound to reduce disparity in the income and earning of the individuals including persons in the various services of Pakistan.
- That the appeal is within time after the lapse of stipulated time period for the decision on the departmental appeal dated 11-07-2023. (Copy of the appeal is annexed as Annexure \mathbf{F})

h. That the matter contains terms and conditions of civil service, hence this Hon Tribunal has jurisdiction to entertain the instant appeal.

- That the seniority list is liable to be observed by considering the promotion.
- That the other grounds shall be argued at the time of arguments with the leave of this Honourable Tribunal.
- That if the instant appeal is not accepted, the petitioner will suffer an irreparable loss.





8) That the department has allocated 20-posts for the promotion against SST(Math/Physics) vide notification dated 27.07.2017, but, only 3 employees were promoted through ibid notification while rest of the meritorious on the basis of seniority were ignored including the appellant. Hence, the appellant amongst others was liable to be promoted along with his bagemates. (Copy of notification is annexed as Annexure E)

9) That the department has appointed fresh candidates against the post of SST(Math/Physics) over and above the 25% share as per policy.

10) That the appellant has already filed couple of applications before your good-self for the promotion from Senior Qari to SST(Math/Physics) along with bagemates granting all the back benefits which are remained undecided so far. (Copies of applications are annexed as Annexure F)

11) That the appellant is liable to be promoted with all back benefits.

Prayer:

Therefore, it is humbly prayed that the appellant kindly be promoted from Senior Qari to SST(Math/Physics) with all back benefits.
