



**APPEAL U/S.4 OF THE SERVICE TRIBUNAL ACT,1974
FOR PROMOTION FROM SENIOR QARI(BPS-15) TO
SST(Math/Physics,BPS-16) w.e.f 27-07-2017 ALONG
WITH ALL BACK BENEFITS.**

Respectfully Sheweth:-

The submissions are as under:

- 1) That the appellant was appointed against the post of Qari vide order dated 30.04.2007. (Copy is annexed as Annexure A)
- 2) That the appellant was also promoted from Qari to Senior Qari vide order dated 28.09.2015. (Copy is annexed as Annexure B)
- 3) That the appellant is senior most in the seniority list of Senior Qaris to be promoted against the post of SST(Math/Physics) BPS-16 being qualified duly. (Copy is annexed as Annexure B/1)
- 3) That the appellant is qualified upto BSc(Math A&B and Physics). (Copies of DMCs & Degrees are annexed as Annexure C)
- 4) That the appellant has also obtained the degree of B.Ed. (Copy of Degree is annexed as Annexure D)

5) That for the promotion against the post of SST(Math/Physics), the BSc along with B.Ed is requisite qualification as per policy of the department which is fulfilled by the appellant.

6) That the department has allocated 75% share for promotion from junior cadres against the post of SST and remaining 25% share for initial/fresh recruitment.

7) That the department has also allocated 3% share for the promotion of Senior Qari to SST, as per notification dated 24-07-2014. (Copy of Notification/Policy is annexed as Annexure **D/1**)

8) That the department has showed 14 vacant posts of SST(Math/Physics) in year 2016 by reserving 03-posts for initial recruitment and 11-posts for the promotion, whereas only 3-persons were promoted. And the department has also showed 20 vacant posts of SST(Math/Physics) in year 2017 by reseving 04-posts for initial recruitment and 16-posts for the promotion, however surprisingly, only 3-persons were promoted and rest of the meritorious on the basis of seniority were ignored including the appellant. Hence, the appellant amongst others was liable to be promoted along with his batchmates. (Copy of notifications are annexed as Annexures **E/1 & E/2**)

9) That again more astonishingly, the department appointed 20 fresh candidates against the post of SST(Math/Physics) via an appointment order dated 20-04-2017 without fullfilment of 75% quota reserved for promotion against the post of SST (M/P) BPS-16. (Copy of order is annexed as Annexure **E/3**)

10) That the department has appointed fresh candidates against the post of SST(Math/Physics) over and above the 25% share as per policy.

11) That the appellant is liable to be promoted with all back benefits being an employee of good as well as reputable attitude in providing his services.

12) That the appeal of appellant is liable to be accepted inter alia on the following grounds:

GROUND:-

- a. That depriving the appellant from due promotion and not deciding the departmental appeal is against the law and spirit of justice, hence the instant appeal before this Hon^rTribunal is liable to be accepted.
- b. That appellant has not been treated in accordance with law and rules by the respondent Department on the subject noted above and as such the respondents violated A.04 & 25 of the Constitution of Islamic Republic of Pakistan, 1973.
- c. That the respondents acted arbitrarily and malafidely by not promoting the appellant as per the notification dated 24-07-2014.

- d. That the department has appointed fresh candidates against the post of SST(Math/Physics) over and above the 25% share as per policy.
- e. That the action of the respondents is discriminatory in nature as the promotion/recruitment policy is not being followed duly ever since 2014.
- f. That u/A. 38(e) of the Constitution of Islamic Republic of Pakistan, 1973, the state is bound to reduce disparity in the income and earning of the individuals including persons in the various services of Pakistan.
- g. That the appeal is within time after the lapse of stipulated time period for the decision on the departmental appeal dated 11-07-2023. (Copy of the appeal is annexed as Annexure F)
- h. That the matter contains terms and conditions of civil service, hence this Hon Tribunal has jurisdiction to entertain the instant appeal.
- i. That the seniority list is liable to be observed by considering the promotion.
- j. That the other grounds shall be argued at the time of arguments with the leave of this Honourable Tribunal.
- k. That if the instant appeal is not accepted, the petitioner will suffer an irreparable loss.

PRAYER:-

Under the circumstances mentioned above, it is very humbly and respectfully prayed that the instant appeal may kindly be accepted and the appellant may kindly be promoted against the post of SST(M/P) BPS-16 w.e.f 27-07-2017 with all back benefits, in the best interest of justice.

Any other equitable relief which this Honourable Tribunal deems fit and appropriate may also be awarded in favour of the petitioner.



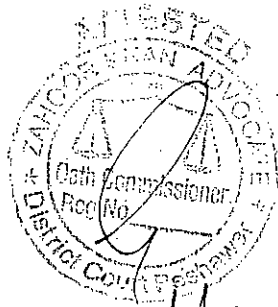

TERMS /CONDITIONS FOR ALL APPOINTEES ON REGULAR BASIS.

1. Their services will be considered regular but without pension or Gratuity in terms of Section -19 of the NWFP Civil Servant Act, 1973 as amended vide NWFP Civil Servant (Amendment) Act, 2005. They will however be entitled to Contributory Provident Fund in such a manner and at such rates as may be prescribed by the Government.
2. Their Services will be liable to termination on one month's prior notice from either side. In case of resignation without prior notice their one-month pay/allowances shall be forfeited to Government.
3. Their services can be terminated at any time, in case their performance is found unsatisfactory. In case of misconduct they will be proceeded against under the NWFP Removal from Service (Special Power Ordinance 2000) and rules framed from time to time.
4. The appointees should join their posts within 15-days of the issuance of this order; in case of failure appointment of the concerned shall stand automatically cancelled/withdrawn. The Head of Institution/DDO should furnish a certificate to the effect that the appointees have joined the posts or otherwise, after 15 days of the issuance of this order.
5. They shall be required to furnish copies of all their Certificates/degrees along with the original receipts and photocopies thereof pertaining to the verification fee of the

- concerned examining body (Board/University) to the DDO concerned. The DDO shall arrange verification of all the certificates/degrees of the appointees. The DDO is directed, that pay bill should not be submitted to the District Accounts Officer till the verification of all certificates/degrees from the concerned Boards/University/Religious Institution of each candidate.
6. The Drawing & Disbursing Officers concerned should check their original Certificates/degrees before handing over charge.
 7. No TA/DA is allowed to the appointees.
 8. Charges reports should be sent to all concerned.
 9. Any candidate who applied for recruitment in response to the advertisement published in the News Paper in the month of December, 2006 by the Schools & Literacy Department Haripur feel some un-justice in the appointments, is allowed to file Review Petition with in Seven days of the issuance of this orders in the name of Chairman District Recruitment Committee i.e Executive District Officer schools & Literacy Haripur which will be decided by the Committee with in next seven Days Positively.
 10. They will sign the agreement form before joining service that will be arranged by D.D.O concerned.
 11. Their salaries are subject to execution of agreement deed based on the terms and conditions of the regular framed by the Provincial Government without Pension.
 12. They will get pay i.e. initial pay of BPS-07 of the post including usual allowances as admissible under the rules. They will be entitled to annual increment after completion of one year of service.
 13. The overage/under age candidates should not be handed over charge, till the provision of upper age relaxation by the competent authority.
 14. They should produce Health & Age Certificate issued by the Medical Superintendent District Head Quarter Hospital Haripur with in Seven days of taking over charge.
 15. The appointment for the Institution where a candidate has been appointed/posted and will be transferable/adjustable to any other Institution after three years.
 16. No pension/Gratuity facilities will be provided to the candidates appointed presently.
 17. The DDO concerned are responsible to the preparation of Service Books.


