SUBJECT: REPLY ON BEHALF OF RESPONDENTS

Respectfully Sheweth:-

Preliminary Objections

- 1. That framing, altering or amending the rules is the prerogative of the government reconcerning authority.
- 2. That the appellant as per his seniority will be promoted to the post of Agriculture Research Inspector (BS-11) and then to Research Supervisor (BS-14) as per Notification dated 20 August, 2015 (Annex-A), under which, others Field Assistants of the department got their promotions.
- 3. That vide order dated 20th September, 2022 passed in EP No. 389/2018 titled: Muhammad Iqbal vs Govt. of KP through Secretary Agriculture etc, this Hon'ble Tribunal had filed the execution petition of grounds mentioned therein (Annex-B). Consistency warrants disposal of this appeal also.
- 4. That the instant appeal is based on illegal demands against the respondents, hence, the instant appeal is not maintainable in its present form and liable to be dismissed with cost.
- 5. That the appellant wishes to waste the precious time of this Hon'ble Court by filing the instant appeal.
- 6. That the appellant has no locus standi and this instant appeal warrants dismissal in limine.
- 7. That the appellant has deliberately concealed the important facts from this Hon'ble Court.

ON FACTS: -

Para:1-2 No comments, it pertains to record.

Para:3-4 It is submitted for the convenience of this Hon'ble Tribunal that in the year 1981, the Rules of 1981 were framed by Government, wherein there was 25% quota reserved for promotion of Field Assistant to the post of Research Officer (BS-17). But, in the year 1987, service rules for the post of Research Officer were amended and the 25% quota reserved for promotion of Field Assistant to the post of Research Officer (BS-17) was deleted/omitted. Copy of Notification dated 27/10/1987 is attached as **Annex-C**.

Para:5-6 Not admitted and incorrect, hence denied with the remarks that if the appellant was aggrieved from the step taken by the Administrative Department, he should have submitted an appeal against that notification in the year 1987.

Similarly, in order to accommodate and protect the future of Field Assistants, the Government vide Notification dated 30.06.2011 (Annex-D) formulated proper service structure and the appellant has also got up-gradation from BS-06 to BS-09 through that very notification dated 30.06.2011. Moreover, approximately 47 Field Assistants had availed their promotions from the post Field Assistant to the post of Research Inspector (BS-11) vide Office Order dated 26.01.2016 and thereafter to Research Supervisor (BS-14) vide Officer Order dated 02.06.2017 and dated 26.05.2021 under the aforementioned rules notified on August 20, 2015 (copy of promotion orders are attached as Annex-E&F). Hence, the appellant too will have same line of promotion under the rules in vogue and will be granted natural justice accordingly.

Para-7 Not admitted, hence denied. The appellant along with others submitted appeal to the Director General Agriculture Research in the year 2023, which was accordingly forwarded to the Administrative Department on 12.04.2023.

The next submission is that necessary opinion was earlier solicited form the Establishment Department Khyber Pakhtunkhwa in the case of Mohammad Iqbal ex-Agriculture Research Inspector, Agriculture Department (Research Wing). The **ESTABLISHMENT DEPARTMENT** vide letter No. SOR-III (E&AD)/1-12/2021, dated 06.01.2022, has declared Muhammad Iqbal, Ex-Research Inspector un-fit for promotion to the post of Research Officer, BS-17. The operative part of the letter is reproduced as;

"the Service Rules for the post of Research Officer were amended through notification, dated 27.10.1987 and the 25% quota reserved for promotion of Field Assistant was deleted. If Muhammad Iqbal was aggrieved from the step taken by the Administrative Department, he should have submitted appeal against that notification in 1987. Moreover, as per seniority notified on 30.04.1991, Muhammad Iqbal was at serial No. 134 and based on that seniority he had availed promotion from Field Assistant to the post of Research Inspector (BS-11) vide office order dated 26.01.2016. Furthermore, through impugned notification dated 30.06.2011, the official has also got up-gradation from BS-06 to BS-09. It is also evident from the record that impugned notification dated 30.06.2011 was not main hurdle for his promotion rather his qualification is not fulfilling the requisite criteria for promotion which is M.Sc. Agriculture or B.Sc. (Hons) Agriculture from a recognized University for the post of Research Officer (BS-17) Therefore, in view of the above, Muhammad Iqbal, Ex-Research Inspector (BS-11) is not fit for promotion to the post of Research Officer (BS-17)" (Copy of letter dated 06.01.2022 is attached as Annex-G).

Para: 8

Not admitted, hence denied with the remarks that Agriculture Extension and Soil Conservation are entirely different entities/departments with their own Service Rules meant for their own employees. The same are not applied upon the employees of Agriculture Research Department. Moreover, the appellant's contention does not hold any ground as the Service Rules of all the three sister Departments have major differences like as for Research Officer (BS-17) in Agriculture Research Department, who gets two promotions to BS-19 (Principal Research Officer) must be having research publications as compulsory requirement for each promotion, besides M.Sc. (Hons) or B.Sc. (Hons) degree in Agriculture Sciences and length of service as utmost. While, there is no research publication requirement for promotion next higher grade as per APT Rules of Agriculture Extension and Soil Conservation. Hence, one department's rules are not applicable on the employees of another department.

Para: 9

Not admitted. As clearly mentioned in above para 7, his appeal was forwarded to the Competent Authority vide letter dated 12.04.2023.

Para: 10

Not admitted. The appellant being not genuinely aggrieved person from any act of the replying department and may not be allowed to raise any grounds whatsoever.

GROUNDS

Para:A-D Not admitted and not agreed. The Service Rules for the post of Research Officer were amended through notification, dated 27.10.1987 and in the said prevailing rules, the Research Officer is appointed through initial recruitment by the Khyber Pakhtunkhwa Public Service Commission. The qualification required for the post of Research Officer is M.Sc. or B.Sc. (Hons), Agriculture in the prescribed discipline as mentioned in Schedule II of the 1981 rules amended in 1987.

Thereafter, in suppression of all notifications, the Agriculture Department in consultation with the Establishment Department and the Finance Department framed and notified the Service Rules vide notification No. SOE(AD)2(2)429/2011; dated 20.01.2014, if the appellant was aggrieved from the step taken by the Administrative Department, he should have submitted an appeal against those notifications in the year 1987 and thereafter in the year 2014 & 2015.

It would also be beneficial to mention the method of recruitment, qualification and other conditions specified in column 3-5 of the Notification dated 30.08.2015, which shall be applicable to **FIELD TECHNICAL POSTS**;

From the bird's eye view of the above tabulated criteria, the appellant from his initial appointment as Field Assistant (BS-09) will be promoted to the post of Research Inspector (BS-11) and then further to Research Supervisor (BS-14) as per rules in vogue.

Hence, there is no element of mala fide or legal incompetence of the respondents in amending and formulating the Rules.

The next submission is that the Apex Court in number of Judgments held that framing, altering or amending the rules is the prerogative of the government or concerning authority. In case reported as **Zafar Iqbal and another vs Director Secondary Education Multan and 03 others (2006 SCMR 1427)**, the Hon'ble Supreme Court of Pakistan while discussing the legal competence of the executive authorities in amending rules or framing policies has held as under

"Government was always empowered to change the promotion policy and domain of the Government to prescribe qualification for a particular post through amendments in relevant rules was not challengeable"

A similar view has been expressed in case of Dr. Alyas Qadeer Tahir vs Secretary M/s Education (Now MO Cadd) Islamabad & others (2014 SCMR-997), wherein the august Apex Court has held as under;

"Enactments of Rules or amendments therein is the prerogative of the Government. It can enact and amend the Rules according to the needs and exigencies of the service".

This view finds further support from the case titled "Qazi Ghulam Sarwar & 3 others Vs. Azad Govt. and 6 others", reported as 2016 SCR 1737, the Hon'ble Supreme Court of Azad Jammu and Kashmir held as under: -

"The version of the petitioners is that Rules be amended and departmental promotion quota be provided. The Framing of Rules is a sole prerogative of the concerned authorities and no such direction can be issued that the Rules shall be framed according to the wishes of the Government Servants. This proposition has already been resolved by



this Court in a case reported as Syed Rasheed Hussain vs. Azad Govt. and 6 others [2014 SCR 883], wherein, it has been observed as under: -

".... Even otherwise, Rules cannot be framed/amended at the sweet-will of a party and it is the sole prerogative of the Authority concerned to frame or amend the same...."

Para: E Not admitted. Hence, denied as details are clearly in the preceding paras A-D.

Para: F-G Not admitted. It is against the natural principle of parity. The appellant's contention does not hold any ground. The post of Research Officer is a technical post and the qualification required for the post of Research Officer is M.Sc. or B.Sc. (Hons), Agriculture in the prescribed discipline as mentioned in schedule II of the service rules. While, the qualification for the post of Field Assistant is matric with science on account of enhancement of course duration from two to three years (diploma course) from an Agriculture Training Institute.

Therefore, the Department has proceeded and made amendments as per Law and Rules. The appellant has never been discriminated and his assertions are totally misconceived. Moreover, the appellant along with other colleagues are provided with progressive service structure and promotion chances in the department vide notification dated 30.06.2011. Similarly, as mentioned in para 8, Agriculture Extension and Soil Conservation are entirely different entities/departments with its own rules meant for their own employees.

Para: H Not admitted, hence denied with the remarks that the appellant will get his promotion benefits and will be promoted to the post of Agriculture Research Inspector (BS-11) and further to Research Supervisor (BS-14) as per aforementioned rules accordingly.

Para: I-J

Not admitted. As details are given in above paras. Moreover, the assertion of the appellant in this regard is against the ground realities. The respondent department took every step as per rules in vogue and framed necessary rules in consultation with the Establishment Department and the Finance Department.

Furthermore, The Hon'ble Tribunal will be further satisfied at the time of arguments.

It is therefore, most respectfully prayed that on acceptance of the submissions made herein above, the instant service appeal may please be dismissed having no legal footings





- 1. Appellant in person present. Mr. Kabirullah, Addl: AG for respondents present.
- The relief granted in the judgment was that the department 2. was directed to consider the petitioner for promotion if the only hurdle in his way was notification of 2011 and if found eligible and fit in accordance with the rules prior to amendments made vide notification dated 30.06.2011. Through the instant application the petitioner has requested for implementation of the judgment in letter and spirit. Today the respondents have produced copy of the minutes of departmental promotion committee wherein, in compliance with the judgment of the Tribunal, the case of the appellant was considered for promotion but he was not found eligible and fit for the desired promotion because the only hurdle was not notification of 2011 but also the required qualification of M.Sc Agriculture or B.Sc (Hons) Agriculture as per previous service rules prior to the notification dated 30.06.2011. The case was referred to Law and Establishment department for soliciting a clear cut opinion in the case. Copy of a letter from Director General to the Director Agriculture Station Buffa bearing No. 1203-6/I(Lit)/DGAR dated 10.02.2022 shows that the Law Department returned the case with the advice to submit implementation report before this Tribunal after placing the case before the Departmental Promotion Committee while the Establishment department letter No. SOR-III(E&AD)/1-12/2021 dated 06.01.2022 declared the petitioner unfit for promotion to the post of research officer and the operative part of the letter was as under:-

The service rules for the post of Research Officer were amended through notification, dated 27.10.1987 and the 25% quota reserved for promotion of Field Assistant was deleted. If Muhammad Iqbal was aggrieved from the step taken by the Administrative Department, he should have submitted appeal against that notification in

1987. Moreover, as per seniority notified on 30.04.1991. Muhammad Iqbal was at serial No 134 and based on that seniority he had availed promotion from Field Assistant to the post of Research Inspector (BS-11) vide office order dated 26.01.2016. Furthermore, through impugned notification dated 30.06.2011, the official has also got up-gradation from BS-06 to BS-09. It is also evident from the record that impugned notification dated 30.06.2011 was not main hurdle for his promotion rather his qualification is not fulfilling the requisite criteria for promotion which is M.Sc Agriculture or B.Sc (Hons) Agriculture from a recognized University for the post of Research Officer (BS-17).

- 3. Therefore the compliance of the judgment of the Tribunal seems to have been made and thus this petition is filed. Consign.





to refer to your office letter No.SOE(AD)Vdirected 8/RW/21/M.lqbai/1305 dated 23.09.2021 on the subject noted above and to state that the Service Rules for the post of Research Officer were amended through notification dated 27.10.1987 and the 25% quota reserved for promotion of Field Assistant was deleted. If Muhammad Iqbal was aggrieved from the step taken by the Administrative Department, he should have submitted appeal against that notification in 1987, however, no such record is found. Moreover, as per seniority list notified on 30.04.1991, Muhammad Iqbal was at Serial No. 134 and based on that seniority he had availed promotion from Field Assistant (BS-09) to the post of Research Inspector (BS-11) vide office order dated 26.01.2016. Furthermore, through impugned notification dated 30.06.2011, the official has also got up-gradation from BS-06 to BS-09. It is also evident from the record that impugned notification dated 30.06.2011was not main hurdle for his promotion rather his qualification is not fulfilling the requisite criteria for promotion which is M.Sc Agriculture or B.Sc (Hons) Agriculture from a recognized University for the post of Research Officer (BS-17).

Therefore, in view of the above, Muhammad Iqbal, Ex-Research Inspector (BS-11) is not fit for promotion to the post of Research Officer (BS-17) and the Hon'ble Court may be informed accordingly.
