




APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICES TRIBUNALS ACT 1974 AGAINST THE IMPUGNED SENIORITY LIST DATED 07.10.2022 AND 17.11.2022 WHICH IS NOT PREPARED AS PER SECTION 8 OF CIVIL SERVANT ACT, 1973 AND AGAINST THE DEPARTMENTAL APPEAL, WHICH WAS REJECTED ON DATED 10.10.2023, FOR NO GOOD GROUNDS.

PRAYER

THAT ON THE ACCEPTANCE OF THIS APPEAL, THE RESPONDENTS MAY PLEASE BE DIRECTED TO RECAST THE SENIORITY LISTS AND INCLUDE THE NAME OF THE APPELLANT AT THEIR PROPER PLACE AS PER NOTIFICATION DATED 05.10.212 IN HIS RESPECTIVE REGIONS. ANY OTHER REMEDY WITH THIS AUGUST TRIBUNAL DEEMS FIT AND PROPER MAY ALSO BE AWARDED THE FAVOR OF THE APPELLANT.

RESPECTFULLY SHEWETH

FACTS

1. That the appellant was initially appointed as a Forester(BPS-07) on dated 19.08.2009 ,and performing there duty with the entire satisfaction of his superior and never give a chance of complaint to his high ups , and having a good service record through out. Copy of order dated 19.08.2009 is attached as annexure A.
2. That the appellant was transfer through an order dated 16.12.2009,from demarcation Forest swat division to Demarcation Forest Division Peshawar . Copy of order dated 16 .12.2009 is attached as annexure B.
3. That during performing his official duties a notification No SO(Estt)Envvt/I-4/2K11/6475 on dated 5 .10 .2012 was passed by Secretary To Government Of Khyber Pakhtunkhwa Environment Department “ *the seniority of the forester and Deputy Rangers shall be determined and fixed in the respective Circle on the basis of there initial appointment*”. copy of notification dated 05.10.2012 is attached as annexure C.
4. That a proposal for adjust of regular staff was forwarded by the Conservator Of Forester through letter dated 28.08.2014, to the Chief Conservator of Forests Central Southern Region-I Khyber Pakhtunkhwa, Peshawar wherein “it is requested to kindly adjust the above mentioned regular staff in the region anywhere else against the regular post please” while the appellant at Sr. No. 01. Copy of the memo/letter dated 28.08.2014 is attached as Annex-D.
5. That the order was issued on dated 02.11.2005 in the light of letter No. 1279/E dated 27.11.2014 where in they stated that “the following staffs is hereby adjusted against the vacant post on the strength of Forestry Planning & Monitoring Circle Peshawar working Plan Units as noted against each with immediate effect in the interest of public service, wherein the appellant was adjusted against the vacant post of Forestry in Working Plan Unit-IV Abbottabad. C opy of office order dated 02.11.2015 is attached as Annex-E.
6. That the order was issued on 03.12.2015 in which the appellant was transferred from working Plan Unit-IV Abbottabad to Working Plan

Unit-V Mansehra. Copy of the order dated 03.12.2015 is attached as Annex-F.

- 7. That the order was issued on 16.05.2019 in which the appellant was transferred from Working Plan Unit-V Mansehra to Forestry Planning & Monitoring Circle Peshawar. Copy of the transfer order dated 16.05.2019 is attached as Annexure-G.
- 8. That the seniority list of the Foresters Peshawar Circle was issued on 12.11.2021 wherein they give the seniority to the appellant from year 2015 which was again taken back by the respondent department. Copy of the seniority list is attached as Annex-H
- 9. That the final seniority list was issued of malakand region(III) on dated 30-06-2022 in which they had not include the name of the appellant , meanwhile an other final seniority list was issued of Peshawar region(I) on dated 17 .11.2022 where in they also did not include the name of the appellant copy of the seniority lists of malakand and Peshawar region is attached as annexure I& J
- 10. That the appellant feeling aggrieved from the impugned final seniority lists and file departmental appeal on dated 10.07.2023 before the competent authority for the inclusion of his name in the seniority list at their proper place but despite the fact that the departmental appeal of the appellant was rejected on dated 10.10.2023 without showing a legal justification. Copy of the departmental appeal and rejection order dated is annexure K & L.
- 11. That the appellant come to this august tribunal on the following grounds amongst others.

GROUNDS

- A. That rejection of Departmental appeal and the impugned seniority lists is against the law, illegal, unlawful, without and lawful authority, thus calling interference of this learned tribunal.
- B. That the impugned seniority lists is against the norms of service law and principles of natural justice and dictums of the apex courts.
- C. That the impugned seniority list is the worst example of favoritism, nepotism and colorful exercise of powers which is not warranted under law.

- D. That according to Section-8 of the Civil Servant Act 1973 and section-17 of APT Rules 1989, it is the legal right of every civil servant to properly placed in seniority list according to his seniority position, but the same benefits was not extended to the appellant which is the violation of law and rules.
- E. That the appellant was not treated according to the law and rules and has been deprived from his legal right of seniority in arbitrary manner without fault on his part.
- F. That the appellant craves permission of this honorable tribunal to rely on other grounds at the time of arguments and produce any additional document if required in support of instant service appeal.
- G. Bashir Ahmad V/s Muhammad Ali Khan (2010 PLD 1960) seniority has been considered as the vested right of the seniority were determined as follows:-

Every officer in graded service has a vested right to a proper place in the seniority list.

This is of the highest importance to him, as well as to the maintenance of proper discipline and order within the service, and consequentially to the public interest which is deeply involved in the maintenance of a proper spirit of order and discipline within the service.


Seniority rules are not of the same nature and quality as the great body of departmental rules applicable to the conduct of officers and other such matters relating to the service as a whole, which are capable of being altered by the Government. These rules are of the highest validity and have the quality of settling the important matter of seniority among officers of service."



It is therefore most humbly prayed that the appeal of the appellant may be accepted as prayed for.
