**APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED ORDER DATED 06.12.2022 WHEREBY BACK BENEFITS WAS REFUSED TO THE APPELLANT AND AGAINST THE APPELLATE ORDER DATED 27.07.2023 COMMUNICATED TO THE APPELLANT ON 11.10.2023 WHEREBY THE DEPARTMENTAL APPEAL OF THE APPELLANT WAS REGRETTEED.**

**PRAYER:**

That on acceptance of this service appeal the impugned appellate order dated 27.07.2023 and order dated 06.12.2022 may kindly be modified/ rectified by granting/ allowing back benefits to the appellant. Any other remedy which this august Tribunal deems fit that may also be granted in favor of the appellant.

**R/SHEWETH:**

**ON FACTS:**

- 1- That the appellant is an employee of the respondents department and was performing her duty as LHW quite efficiently and whole heartedly and up to the entire satisfaction of his superiors.
- 2- That while performing her duty with devotion and honesty the appellant was dismissed from service vide order dated 17.10.2019. Copy of the order dated 17.10.2019 is attached as annexure ..... A.
- 3- That feeling aggrieved the appellant assailed the dismissal order through departmental appeal followed by service appeal No. 8826/2020 before this August service tribunal which was accepted vide judgment dated 13.10.2022 with the direction to

reinstate the appellant and conduct de-novo inquiry, the matter of back benefits was subjected to the outcome of inquiry. Copy of the judgment is attached as annexure .....**B.**

4- That appellant was re-instated in to service vide impugned order dated 06.12.2022, however the judgment was not implemented in its true letter and spirit, feeling aggrieved the appellant preferred execution petition No. 175/2023 which was, however, consigned vide order dated 03.07.2023 with the observation that the judgment has been implemented and the respondents were directed to decide the matter of back benefits. Copy of the order dated 06.12.2022 and order sheet dated 03.07.2023 are attached as annexure ..... **C&D.**

5- That appellant submitted an application on 11.07.2023 along with the order sheet mentioned above to decide the fate of back benefits and provision of the inquiry record if any but in vain. Copies of the applications are attached as annexure .....**E.**

6- That lastly the appellant approached to the Information Commission for the request information and vide letter dated 04.10.2023 the respondents were directed to provide the requisite documents to the appellant within five days and thereafter the appellate order dated 27.07.2023 was provided to the appellant whereby her departmental appeal was rejected. Copies of the letter dated 04.10.2023 and order dated 27.07.2023 are attached as annexure .....**F&G.**

7- That the appellant feeling aggrieved from the appellate order and having no other remedy but to file the instant service appeal on the following grounds amongst the others.

**GROUND:**

A- That the impugned order dated 06.12.2022 and appellate order appellate order dated 27.07.2023 whereby back benefits was refused to the appellant without any reasons and justification are against the law, facts, norms of natural justice and materials on the record, hence not tenable and liable to be set aside.

B- That appellant has not been treated by the respondent department in accordance with law and rules on the subjected noted above and as such respondents violated the Article 4 and 25 of the Constitution of Islamic Republic of Pakistan.

C- That no proper de-novo inquiry has been conducted in to the matter and the appellant had never been associated in it.

- D-That no chance of personal hearing and personal defense has been provided to the appellant before the issuance of the order dated 06.12.2022 whereby back benefits were refused to the appellant.
- E-That the appellant was not associated in the inquiry which is mandatory as per the direction of the judgment.
- F-That the impugned order to the extent of refusal of the back benefits is without any justification and the same part is also not a speaking order, thus violative of section 24-A of the General Clauses Act, 1897.
- G-That according to Article 38(e) of the constitution of the Islamic Republic of Pakistan, 1973 respondents are bound to reduce disparity in the income of individuals, including persons in various classes of service of Pakistan.
- H-That the appellant seeks permission to advance any other ground and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.


**MIAN MUHAMMAD, MEMBER(E):-** The instant service appeal has been instituted under Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974 with the prayer that "on acceptance of the instant service appeal the Honourable Tribunal would be pleased to set aside both the impugned orders and reinstate the appellant in her services with all back benefits."

02. Brief facts, as per memorandum of appeal, are that the appellant was appointed as Lady Health Worker (LHW) in 2002 and later on her services were regularized alongwith others vide Notification dated 24.09.2014. The appellant was imposed the major penalty of dismissed from service vide impugned order dated 17.10.2019. Feeling aggrieved, the appellant preferred department appeal on 05.03.2020 which was rejected on 13.07.2020. Thereafter, the appellant filed the instant service appeal on 23.07.2020.

03. On admission of the service appeal in preliminary hearing on 18.09.2020, the respondents were put on notice to submit written defence through reply/para-wise comments. Reply/Parawise comments were submitted on 05.01.2021. We have heard learned counsel for the appellant as well as learned Additional Advocate General for the respondents and gone through the record with their assistance.

04. Learned counsel for the appellant contended that the appellant was penalized vide impugned order dated 17.10.2019 on the allegation of absence from duty but all of a sudden it was converted in the allegation of poor performance. The charge of absence against the appellant had never been proved and no specific period of absence mentioned by the respondents. It was further argued that being a regular civil servant, the appellant has not been associated with the inquiry proceedings, if any, and she has been condemned unheard. The penalty was imposed on the

back of appellant because no proper inquiry was ever conducted with issuance of a charge sheet/statement of allegations to be served on the appellant. No Show Cause Notice had been served on the appellant before imposition of the penalty and no opportunity of personal hearing was afforded to the appellant. The major penalty of dismissal from service was imposed against the spirit and principles laid down in plethora of judgments rendered by the august Supreme Court of Pakistan. The golden principles of fair trial and due process have not been followed. He requested that the impugned orders may therefore be set aside and the appellant may kindly be reinstated in service with all back benefits.

05. Learned Additional Advocate General on the other hand, raised preliminary objection on maintainability of the service appeal on the ground that departmental appeal was filed by the appellant after one year of the impugned order and when departmental appeal is time barred then the subsequent service appeal shall also be considered as time barred. Moreso, no application has been submitted with the service appeal for condonation of the delay. He further contended that the appellant was not performing her duty being non-resident of the catchment area in utter violation of the guidelines contained in the programme policy. This fact has been established when her colleague submitted a report on 03.09.2019 intimating that the appellant was not performing the duty during Polio Vaccination

Campaign. It was further argued that the appellant had also been involved in dual job with Chip Training & Consulting (CTC) Pvt Ltd. Despite all these, the appellant had previously been reinstated in service on submission of an affidavit to the effect that she would be punctual in performing her duty in future. The appellant has also been issued explanations on various occasions as per record submitted by the respondent department but she did not even bother to submit reply to the explanations. The appeal being devoid of merits may be dismissed, he concluded.


06. Perusal of the record reveals that the services of appellant have been regularized as LHW (District Charsadda) with effect from 15.03.2002 under the Khyber Pakhtunkhwa Regulation of Lady Health Workers Programme and Employees (Regularization and Standardization) Act 2014, vide order dated 24.09.2014. It is evident as an allegation from the impugned order of respondent No. 1 dated 17.10.2019 that two colleagues of the appellant reported that she was absent from duty since her reinstatement i.e. 01.07.2019 without information/permission from the competent authority. But she was dismissed from service on account of "poor performance". It is also a matter of the record that explanations of the appellant on account of absence from duty, had been called on 13.08.2018, 30.01.2019 and 28.03.2019 whereafter the department was obligated to have initiated disciplinary proceedings against the appellant. We also enquired about the charge sheet to have been served on the

appellant and proceedings of the enquiry as well as enquiry report to have been conducted against the appellant but no such documentary evidence was available with the respondent department to be produced in support of the impugned order.

07. As a sequel to the above, we have arrived at the conclusion that the appellant has not been treated in accordance with law, rules and norms of natural justice. She has been condemned unheard without providing opportunity of self defence. The Tribunal is constrained to interfere with the impugned orders. The appellant is reinstated in service and the case is remitted to the respondent department with the direction to conduct proper inquiry strictly in accordance with the relevant rules within 60 days of receipt of the copy of judgement. The matter of back benefits shall be subject to the outcome of enquiry. Parties are left to bear their own costs. File be consigned to record room.




Husband of the petitioner alongwith learned counsel for the petitioner present. Mr. Asif Masood Ali Shah, Deputy District Attorney for the respondents present.

2. Petitioner through instant execution petition requested for implementation of this Tribunal judgment dated 13.10.2022 to the extent of grant of back benefits. Perusal of judgment dated 13.10.2022 reveals that petitioner was reinstated in service and case was remitted to the respondent department with direction to conduct proper inquiry strictly in accordance with law within 60 days of receipt of the copy of judgment. The matter of back benefits shall be subject to the outcome of inquiry. Although petitioner had mentioned in instant petition that said inquiry is not conducted within 60 days in accordance with direction of this Tribunal but perusal of page 10 of instant petition reveals that it is office order bearing No. 10952-58/DHO dated 06.12.2022 vide which the petitioner was reinstated into service but back benefits was not granted to her in light of inquiry report. Perusal of page 13 of instant petition also reveals that it is an application for departmental appeal/application for sympathetic consideration for grant of back benefits to the respondent department by the petitioner who had given reference of order bearing No. 10952-58/DHO dated 06.12.2022 by mentioning therein that through this order she was deprived from back benefits. This departmental appeal was received by the respondent on 18.01.2023, which is not yet decided. This office order was issued as result of conclusion of inquiry conducted by the department.

3. In my humble view inquiry was conducted as result of which order dated 06.12.2022 was issued, so judgment of this Tribunal is complied with, and there is no need to proceed further with the instant execution petition. If petitioner is dissatisfied/aggrieved from finding of inquiry committee to the extent of not granting back benefits to her, she will have to avail other remedies provided under the law/rules, if so advised. Before parting with instant execution petition respondents are directed to decided departmental appeal/application for sympathetic consideration for grant of back benefits within 30 positively after receipt of this order just for the interest of justice.

4. In view of the above, instant petition is disposed off. File be consigned to record room.
