ORDER

Qazi Faez Isa, CJ.

The learned counsel for the petitioner states that the petitioner was belatedly promoted and after his promotion he sought that it should take effect from the date the post had become vacant. However, the petitioner instead of filing appeal before the Khyber Pakhtunkhwa Services Tribunal ('the Tribunal') filed a writ petition before the High Court, which was dismissed on the ground that the High Court lacked jurisdiction. By the time the petitioner approached the Tribunal considerable time had elapsed. The Tribunal dismissed the petitioner's appeal on the ground that it was time barred, and did not concede to his request to condone the delay in filing the appeal.

2. The learned counsel relied upon a judgment of a two-member Bench of this Court whereby appeals filed by the then government of N.W.F.P. were dismissed. We also confronted the learned counsel with the 'Promotion Policy' contained in the Establishment Code of the Khyber Pakhtunkhwa wherein it is stipulated that promotion is to be notified with immediate effect, and not from the date the post had become vacant. The Promotion Policy has not been challenged. The referred to judgment is not applicable since in that case the persons were holding officiating charge of the post to which they were subsequently promoted. In the
