



PRAYER:

Upon acceptance of instant appeal, the respondents may graciously be directed to issue the salaries of the appellant since his adjustment onward, being wrongly withheld by the respondents and to treat the period of absence of appellant as Extra Ordinary Leave without pay in view of the recommendation of the Inquiry Committee and the Departmental Respondents.

Any other relief which this honorable Court deems appropriate may also be granted to the appellant, in the interest of justice.

Respectfully Submitted:

1. That consequent upon the recruitment process under due course, the appellant was appointed as Primary School Teacher in GPS Chiti Dhaki U/C Kholian Bala vide order Endst No. 18861-901 dated 31/08/2006. Thereafter, the appellant assumed the charge of said post on 01-09-2006. Copy of

appointment order and Charge Report are Annexure A and B respectively.

2. That after providing the services in the department for four years, the appellant, in 2010, applied for an Extra Ordinary leave for the circumstances beyond the control of the appellant, which was granted for 730 days as extra ordinary leave without pay. Copy of leave granting order is annexed as Annexure C.
3. That after the completion of the above mentioned leave, the appellant submitted an application for the Extension of Extra ordinary Leave without pay. Consequent to the application of the appellant for the extension of leave neither any rejection order pertaining to the said application was communicated to the appellant nor was the appellant communicated with any order as to joining of his service. Application for extension of Leave is annexed as annexure D.
4. That after his having been relieved from the hardships, the appellant approached the office of Respondent No. 03 on 26-02-2020 for resumption of his duty and submitted an application in this regard. Copy of application for resumption of duty is annexed as annexure E.
5. That consequent to the applications of the appellant an enquiry was conducted in the matter of the appellant and upon the recommendation of the Enquiry committee, the appellant was adjusted in service vide Office Order No 3100-3015 Dated 28-04-2020. Copy of Inquiry Report and copy of said office order are annexed as annexure F and G respectively.
6. That after the adjustment order of the appellant, he was adjusted as PST BPS-12 in Sarai Saleh Haripur, for which the appellant assumed the charge and started performing his duties with full zeal and zest. Copy of Adjustment order as PST in UC Sarai Saleh, Haripur, copy of charge report and copies of attendance register are annexed as annexure H, I and J respectively.
7. That consequent thereto, the Appellant submitted an application that the intervening period between 2012 to 2020

may be treated as extra ordinary leave without pay as he had been deprived of his salary since his adjustment in spite of the fact that he was adjusted under the due course and has been providing his services since his adjustment. The application remained unanswered resulting into violation of the valuable rights of the appellant. Copy of said application is Annexure K.


8. That the appellant filed departmental appeal on 26-07-2023 but no order has been passed upon the appeal of the appellant hence instant appeal. Copy of departmental appeal alongwith copy of postal receipt is Annexure L.
9. *The appellant seeks to invoke the jurisdiction of this Honorable Tribunal on following grounds inter alia:*

GROUND:


1. That the impugned acts of the respondents are illegal, unlawful, arbitrary and fanciful.
2. That the objections advanced by the Finance department or of any respondent are illegal, unlawful and unfounded. The appellant after being adjusted by his department was in no manner amenable to the stoppage of his salary in lieu of his duty continuously performed after his adjustment.
3. That the result of the Inquiry conducted by the department of the appellant cannot be challenged or disputed by the Finance department as the enquiry conducted by the department makes the appellant entitled for the salaries of the period for which he has been performing his duties. This is because the finance department is a financial regulator and when the absence of the appellant, prior to the adjustment has been proposed to be treated in a particular manner after inquiry is no more open to objection by the Respondent No. 04.
4. That the acts of the respondents are violative of the valuable and fundamental rights of the appellant.
5. That the respondents are in no manner authorized under the facts and law to withhold the salary of the appellant.

6. That the salary is detrimental for a civil servant and deprivation of same is inhumane and against the principles of natural justice and equity and is denial to right to life. Hence the respondents are bound to issue the salaries of the appellant, withheld since long without any viable reason.
7. That the impugned acts of the respondents are against the principles and law on the subject.
8. That impugned acts in the light of forgoing grounds necessitate to be declared illegal and unlawful and the appellant is entitled for relief as prayed for.
9. That the foregoing grounds are precise and succinct and having regard to the principle of brevity, further grounds if needed, will be raised during the course of arguments with the permission of this Honorable Court.
10. That the appeal is not hit by the bar of limitation and falls in the jurisdiction of this Honorable Court.

It is therefore, humbly prayed that the appeal may be accepted as prayed for.



TERMS/CONDITIONS FOR ALL APPOINTEES ON CONTRACT BASIS.

1. They will be governed by such rules and regulations enforce and as may be prescribed from time to time by the Govt: for the category of employees to whom they belong.
2. Their services will be liable to termination on one month's prior notice from either side. In case of resignation without prior notice their one-month pay allowance if any shall be forfeited to Government.
3. The appointees should join their posts within 15-days of the issuance of this order. In case of failure appointment of the concerned shall stand automatically cancelled/withdrawn. The Head of Institution/DDO should furnish a certificate to me effect that the appointees have joined the posts & their documents have been verified by the concerned Department.
4. Their services can be terminated at any time in case their performance is found unsatisfactory and they will be proceeded against under the Removal from Service (Special Power) Ordinance 2000-2001.
5. The Dy. DDO S&L Haripur is personally responsible to get verify the certificates/degrees from the concerned Board/Universities /RDE: Religious

- Institutions before the drawl of pay and report of their genius or otherwise be submitted to this office.
6. The Drawing & Disbursing Officers concerned should check their original Certificates/degrees before handing over charges.
 7. No TA/DA is allowed to the appointees.
 8. Charges reports should be sent to all concerned.
 9. Any candidate applied for recruitment in response to the advertisement published in the news paper in the month of ~~December~~ ^{October}, 2008 by the S & L Department Haripur feel some un-justice in the appointments is allowed to file Review Petition with in Seven days of the issue of this orders in the name of Chairman District Recruitment Committee through Executive District Officer schools & Literacy Haripur which will be decided by the Committee with in next seven Days Positively.
 10. Appointments of all the above said candidates on contract basis are provisionally till the decisions of Review Petitions and liable to amend/withdraw or cancelled in case of acceptance of any Review Petition by the Committee.
 11. They will sign the agreement form before joining service that will be arranged by Dy. D.O Male Haripur.
 12. The candidates will enter into an agreement with the Govt. and will be governed by the terms and conditions hereinafter mentioned in such agreement.
 13. Their salaries are subject to execution of agreement deed based on the terms and conditions of the contract through DDO concerned.
 14. They will get pay i.e. initial pay of BPS of the post including usual allowances as admissible under the rules. They will be entitled to annual increment after completion of one year of service.
 15. The DDO concerned should obtain Surety Bond as well as Agreement Bond executed by each candidate to obey contract policy and will have no right to challenge the policy in any court of Law. A sample of agreement can be obtained from the office of Dy. District Officers (MALE) Schools & Literacy Haripur.
 16. The initial period of their appointment shall be three years. After which the contract will be renewed or otherwise by the competent authority keeping in view the performance of the candidate concerned and Govt. policy.
 17. They will not be considered for regularization at any stage and they will not claim their seniority in cadre of appointment.
 18. They will not contribute any amount toward GP Fund. However they will contribute C.P Fund @ 5% of the minimum of pay and 5% contribution will be made by the Government.
 19. The overage/under age candidates should not be handed over charge.
 20. They should produce Health & Age Certificate issued by the Medical Superintendent District Head Quarter Hospital Haripur with in Seven days of taking over charge.
 21. The appointment on contract is only for the Institution where a candidate has been appointed/posted and not transferable/adjustable to any other Institution. No pension/Gratuity facilities will be provided to the candidates appointed on contract basis.

2. He remained under administrative control of ASDEO / SDEO (M) Haripur.
3. The relevant record in office of the SDEO (M) Haripur was checked in detail. He worked in the Deptt. With effect from 01.09.2006 to 31.08.2010 (4 Years regular service).
4. Mr. Muhammad Saeed father of the applicant was renowned educationist who Served the department for more than 40 years, after his retirement be suffered from a fatal disease.
5. On his request the applicant was granted two years / E.O.L without pay with effect from 01.09.2010 to 01.09.2012 for looking after of this ailing father.
6. On expiry of the leave, he applied for further leave with effect from 02.09.2012. His application could not be attended by the controlling officers and no response was conveyed to the applicant. As such he presumed that he had been granted the leave and so he remained away from duty till 26.02.2020. During the period his father died and his mother also suffered from paralysis, Due to this un avoidable circumstance, the teacher concerned could not attend his duties.

CONCLUSION:

That the then ASDEO/SDEO (M) now proceeded on retirement from service were required to had initiated disciplinary action against the absent teacher but they failed to mind their responsibility thus the teacher concerned remained on un authorized leave till he requested for adjustment on 26.02.2020. There appeared no fault on part of the absent teacher. The concerned officers of the department were accountable for the negligence in their duties.
