





APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT 1974 AGAINST THE APPELLATE ORDER DATED 24-08-2015 WHERE BY THE DEPARTMENTAL APPEAL OF APPELLANT FOR THE GRANT OF PROFORMA PROMOTION TO THE POST OF TECHNOLOGIST MULTI PURPOSE (BPS-17) WITH RETROSPECTIVE EFFECT I.E. FROM THE DATE WHEN APPELLANT COLLEAGUES AND JUNIOR COLLEAGUES WERE PROMOTED (29.8.2012) HAS BEEN REJECTED ON NO GOOD GROUNDS

PRAYER:

That on acceptance of this appeal the appellate order dated 24-08-2015 may very kindly be set aside and the Respondents may very kindly be directed to consider the appellant for pro-forma promotion to the post of technologist (M.P) BPS-17 from the date when appellant colleagues and junior colleagues were promoted i.e. 29.8.2012. Any other remedy which this august Tribunal deems fit may also be awarded in favor of appellant.

R/SHEWETH:

ON FACTS:

- 1- That appellant is the bonafide resident of Village Aimal Kala, Post Office Azim Kala, District Bannu and belongs to a respectable family.

- 2- That appellant having the requisite qualification for the post of Technician was appointed in the respondent Department as Technician (BPS-05) on the recommendations of proper Departmental Selection Committee vide order dated 22-01-1973. That in response to the appointment order dated 22-01-1973 the appellant submitted his arrival report vide dated 24-01-1973 and started performing his duty as BCG Technician. Copy of the service book is attached as annexure **A.**
- 3- That vide Government of NWFP now Khyber Pakhtunkhwa Health Department Notification dated 25-08-2006 the competent authority approve 08 stages paramedics Service structure of Khyber Pakhtunkhwa. That the post of the appellant was re-designated in BPS-12 from BPS-11 with nomenclature of technician. That the Executive District officer Health Karak vide his letter dated 23-04-2009 to respondent No.5 submitted the names of EPI Technicians for enlistment in the provisional seniority list of PHC Technicians (Multi-Purpose) BPS-12. That the name of the appellant was placed on serial No.1. Copies of Notification and letter along with seniority are attached as annex **B & C.**
- 4- That colleagues and junior colleagues of the appellant have been promoted to BPS-14 vide order dated 6.3.2010 while the appellant was ignored on no fault on his part. That feeling aggrieved appellant filed Departmental appeal which was accepted through notification dated 2.8.2010 whereby the appellant was promoted to the post Senior PHC Technician (BPS-14) w.e.f. 6.3.2010. Copy of the promotion order as Sr. PHC Technician (MP) is attached as annexure **D.**
- 5- That vide Notification dated 30-05-2012 the respondent No.5 notified the Provisional Seniority List of Sr. PHC Technician (MP) BPS-14 in Khyber Pakhtunkhwa. That astonishingly the name of the appellant was not included inspite of the EDO Health Karak letter dated 23-04-2009. That appellant filed application/ representation before the respondent No.5 for inclusion of his name in the seniority list of BPS-14 but in vain. Copies of the seniority list and forwarding letters are attached as annexure **E, F & G.**
- 6- That on the basis of that Seniority List the colleagues and junior colleagues of the appellant were promoted to BPS-17 vide order dated 29.8.2012 while the appellant was ignored on no fault on his part. Copy of the order is attached as annexure **H.**

- 7- That feeling aggrieved appellant preferred Departmental appeal through proper channel which was forwarded by Executive District Officer Health Karak vide dated 16-05-2012 to respondent No.5. Copies of the Departmental appeal and letters are attached as annexure **I & J.**
- 8- That finally the name of the appellant was included in the seniority list of Sr. Technician (MP) BPS-14 but unfortunately before the issuance of the said seniority list the appellant was retired from service vide Notification dated 24.12.2014. That in the last column of the said seniority list the authority i.e. respondent No.5 has clearly mentioned that the appellant was deferred due to non inclusion of his name in the seniority list of sr. technician M.P. Copies of the seniority list and retirement Notification are attached as annexure **K and L.**
- 9- That vide impugned order dated 24.8.2015 the Departmental appeal of the appellant for the grant of promotion was regretted by the respondent No.1. Copy of the order is attached as annexure **M.**
- 10- That having no other remedy the appellant filed the instant appeal on the following grounds amongst the others.

GROUND:

- A- That the inaction of the respondents by not allowing/ granting pro forma promotion to the post of PHC Technologist multy purpose (BPS-17) is against the law, facts and norms of natural justice.
- B- That the impugned appellate order dated 24.8.2015 issued by the respondent No.1 is against the law, facts, norms of natural justice and materials on the record hence not tenable and liable to be set aside.
- C- That the appellant has not been treated by the respondent Department in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of the constitution of Islamic Republic of Pakistan 1973.
- D- That the respondent Department acted in arbitrary and malafide manner by not allowing/ granting promotion to the appellant to the post of PHC Technologist M.P (BPS-17) in terms of consequential benefits.

- E-** That the appellant has been discriminated by the respondent Department on the subject noted above and as such the respondent violated the principle of natural justice.
- F-** That not allowing/ granting promotion to the appellant the respondents violated section-9 of the civil servant Act 1973 read with Rule-7 of the appointment, promotion and transfer Rules 1989.
- G-** That according to Article 38 sub Article e the state is bound to reduce disparity in the income and earnings of individuals, including persons in the various classes of the service of Pakistan.
- H-** That the appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore most humbly prayed that appeal of the appellant may be accepted as prayed for.

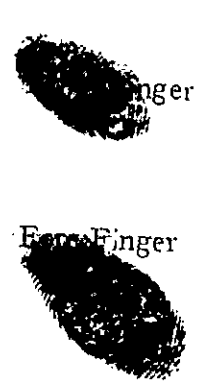
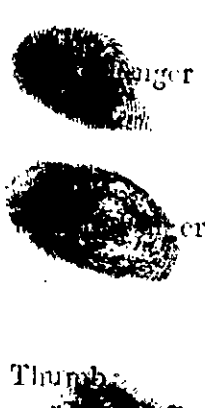



NO SOH-III /8-60/05 (Paramedics). In supersession of this Department's Notification of even number dated 10th May 2006 and in pursuance of the decision taken by the Provincial Cabinet in its meeting held on 27th December 2005, the Competent Authority is pleased to approve eight stage Paramedics Services Structure of NWFP as follows:-

- (1) The exiting 57 different categories of Paramedics at annex A are restructured into 14 cadres as annexure B.
- (2) In all the aforesaid cadres/specialties, the posts in various pay scales shall be integrated/categorized and re-designated as under:-

<u>S.No</u>	<u>Existing Posts</u>	<u>Re-designation</u>
i)	Posts in BPS-5 to BPS-9 in all specialties	Junior Technicians (BPS-9)
ii)	Posts in BPS-10 to BPS-12 in all specialties	Technicians (BPS-12)
iii)	Posts in BPS-13 to BPS-14 In all specialties	Senior Technicians (BPS-14)
iv)	Posts in BPS-15 to BPS-16 In all specialties	Chief Technicians (BPS-16)
v)	Posts in BPS-17 in all specialties	Technologist (BPS-17)
vi)	Posts in BPS-18 in all specialties	Senior Technologist (BPS-18)
vii)	Posts in BPS-19 in all specialties	Chief Technologist (BPS-19)
viii)	Posts in BPS-20 in all specialties	Principal Technologists (BPS-20)

The words "clinical" shall be mentioned with the categories of posts meant for Paramedics working in the hospitals and "Primary Health Care" with the paramedics working in the field alongwith mention of specific specialty (e.g. Junior Clinical Technician (Radiology) and Junior Primary Health Care Technician (Multi purpose).

- (3) The number of Posts in BPS-9, BPS-12, BPS-14, BPS-16, BPS-17, BPS-18, BPS-19 and BPS-20, in the service shall be worked out according to the following proportionate ratio:-

- (4) Seniority of the incumbents of the posts in the 14 cadres so merged shall be caused on the basis of scale wise seniority as well as date of regular appointment in the pay scale. (e.g. in joint seniority list of BPS-12, the officials already in BPS-12 will be senior and the officials in the lower pay scales shall be accordingly placed step by step in the list, invariably keeping intact the inter-se-seniority of the incumbents in the same pay scales).
- (5) Promotions to the posts in BPS-18, 19 and BPS 20 shall be made on the basis of joint seniority list. The joint seniority list of all the 14 cadres shall be caused at BPS-17 level, keeping in view, the principles laid down in section 3 of the NWFP Civil Servants Act, 1973 and Rule-17 of the NWFP Civil Servants (Appointment, Promotion and Transfer) Rules, 1989.
- (6) This eight stage Paramedics Service Structure will replace all existing categories, cadres, structures and nomenclatures and will cancel all such cadres/categories rules and regulations etc, which are in contravention to the approved Paramedics Service Structure.
- (7) The following four Cadres declared as dying cadre by the Provincial Cabinet vide its decision dated 22.06.2000 will be replaced with the following new cadres:-
