4. That any other ground any be raised at the time of arguments prior permission of this Service Tribunal KPK Bench Abbottabad.



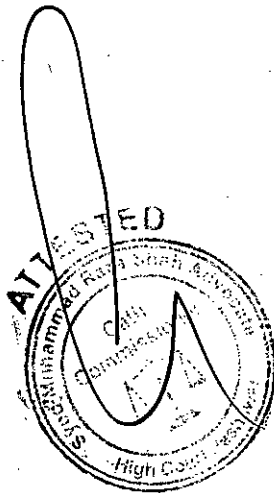
