1. Appointment of secretary village council bakki

One post of Secretary was placed before the Selection Committee for Selection against this post. The meeting started with the recitation of the Holy Quran. The Chair welcomed all the participants and briefed them that to dispose off the Judgment dated 20/6/2017, of Honorable Peshawar High Court, Abbottabad Bench, regarding the Writ Petition No. 879-A, of secretary village council Bakki, is lying vacant. For the smooth running og official business, this post needs to filling up.

In discussion it was observed that the post of village Bakki is vacant due to case file by the one Mr. Awais Fashi-ur – Rehman which was dismissed by the Honorable Peshawar High Court, Circuit Bench, Abbottabad being bereft of any merit. Also candidate apppeared before the DSC and interviewed by the DSC and recommended for appointment for the said post in compliance with judgment of Honorable High Court Circuit Bench, Abbottabad and in light of interview.

2. Appointment of Secretary on the basis of deceased son quota

The appointment case of Mr. Shamas Ud Din Khan as secretary on the basis of deceased son quota was placed before the DSC by the Assistant Director, LG & RDD Mansehra for discussion. After lengthy discussion and scrutiny the application along-with enclosures (Death Certificate of Applicant's father, pension Book and Academic Documents), the Departmental Selection & Recruitment Committee agrees upon the recommendation of the appointment of Mr. Shamas Ud Din Khan against the deceased son quota.

3. Appointment of Naib Qasid.

The post of Naib Qasid is vacant which needs to be fill up for the smooth running of official busines. Three candidated have applied for the post on the basis of Employment Certificates from which Mr. Muhammad Gufran S/O Gulzam has been recommended by the DSC for appointment as Naib Oasid against the vacant post at VC Danda kholian.

Enquiry report was placed before the Selection Committee for termination of appointment of candidated from outside village councils as it is a Government Polioicy that Class-IV, should be appointed from the village Council where vacancy exists. The chaired briefed them that to dispose off the CM directive according to record Note of the meeting to discuss the issues of Mansehra District Held on 7th March, 2016, vide Point No. I & ii. Of Record Note of above mentioned meeting.

In discussion it was observed that 17 Nos Naib Qasid were appointed outside from the concerned VC and 7 Nos Naib Qasid were also appointed outside from the concerned VC on the literate basis, which is unlawful and devoid of merit.

Also, Assistant Director, LG & RDD, Mansehra, brought into the notice of DSC, that the shalaries of the above mentioned Naib Qasid were stopped but some of them had knocked the door of courts for release of their salaries, which had been decided by the court that pay with arrear be paid to concerned employee only, there case has been submitted to DAO Office for payment in light of court decision. Also he has stated that there is no stay order from any court of law regarding the termination of the above mentioned employees who were appointed against the Government policy.

DSC agreed with the proposal of Assistant Director LG & RDD, Mansehra and recommended that termination orders of Naib Qasid of above mentioned list from Serial No. 1 to 24 except serial No. 6 be issued without any loss of time.

The meeting ended with a vote of thanks from the chair.


