DSC agreed with the proposal of Assistant Director LG & RDD, Mansehra and recommended that termination orders of Naib Qasid of above mentioned list from Serial No. 1 to 24 except serial No. 6 be issued without any loss of time.

The meeting ended with a vote of thanks from the chair.

However, later, his services were terminated by respondent No. 5 vide SO (LG-1)2impugned order bearing No. However, it. 343/recruit/2015 dated: 04.04,2016, transpires from the appointment order of the petitioner that his position and status was of civil servant, thus, the impugned orders of respondent No.5 directly relates to the terms and conditions of his services, which is not amenable to the writ jurisdiction of this Court under Article 199 of the Constitution in view of the bar contained in Article 212 of the Constitution of 1973.
