

#### PRELIMINARY OBJECTIONS

1. That the appellant has not approached this Hon'ble Tribunal with clean hands.

- 2. That the appellant has concealed the actual facts from this Hon'ble Tribunal.
- 3. That the appellant has got no cause of action or locus standi to file the instant appeal.
- 4. That the appellant is estopped by his own conduct to file the instant Service Appeal.
- 5. That the appeal is unjustifiable, baseless, false and vexatious and the same is liable to be dismissed with special compensatory cost in favour of respondents.
- 6. That the appeal is bad for miss-joinder and non-joinder of necessary parties.
- 7. That the appeal is barred by law & limitation.

#### **REPLY ON FACTS**

- 1. Para pertains to record needs no comments.
- 2. Incorrect. Stance taken by the appellant is not plausible, because every Police Officer is under obligation to perform his duty upto the entire satisfaction of his superiors. Moreover, the perusal of service record of the appellant revealed that due to his lethargic attitude his entire service record is tainted with bad entries (Copy of list of bad entries is attached as Annexure "A").
- 3. Correct to the extent that the appellant while postedat Guard Main Gate new Tehsil Katlang Logbook Entry Duty, Lady Constables Yusra No.2756, Shumaila No.2906, Fatima No.1315, Maria No.3275 & Aneela No.1328 made a complaint that an unknown person from Mobile Nos. 0315-8899993 & 0313-7592974 is making phone calls and teasing them by using objectionable language. The matter was initially enquired through DSP/HQrs Mardan, who held the appellant responsible of such misconduct recommended him for proper departmental action. In this regard the appellant was issued charge sheet alongwith statement of allegations and enquiry was entrusted to SDPO Rural, Mardan. The enquiry officer during the course of enquiry provided full-fledged opportunity and fulfilled all legal and codal formalities by extending right of self defense to the appellant. But he failed to satisfy the Enquiry Officer, hence, the appellant was recommended for Major punishment. In

light of the above, the appellant was called in Orderly Room on 09.12.2020, but this time too the appellant failed to produce anything in his defence hence, he was awarded major punishment of dismissal from service. Later on, the appellant preferred departmental appeal before the Regional Police Officer, Mardan but the same was rejected and filed being devoid of merit (Copies of dismissal order, rejection order, enquiry are attached as Annexure B, C, &D).

- 4. Correct to the extent that the appellant filed revision petition before the Inspector General of Police Khyber Pakhtunkhwa which was decided and the appellant was reinstated in service for the purpose of de-novo enquiry vide order No. 2671-80/21 dated 18.06.2021. Therefore, in light of the above mentioned order, the appellant was re-instated in service for the purpose of de-novo enquiry and the same was entrusted to Mr. Rokhanzeb Khan the then SDPO Takht Bhai, Mardan. The enquiry officer during the course of enquiry provided full-fledged opportunity to the appellant to produce evidence/grounds in his defense, but he failed. However, after fulfillment of all legal and codal formalities, the Enquiry Officer recommended the appellant for Minor Punishment. Hence, the appellant was summoned and heard in Orderly Room on 03.11.2021 by the District Police Officer, Mardan, but he failed to present any plausible reason in his defense. Therefore, the appellant was awarded minor punishment of forfeiture of 02 years approved service and was reinstated in service from the date of dismissal and counted his intervening/out of service period towards service as leave without pay(Copies of revision petition order& denovo enquiryare attached as Annexure E & F).
- 5. Para already explained needs no comments.
- 6. Correct to the extent that the appellant preferred departmental appeal which was decided while rest of the Para regarding no good grounds is totally baseless because the appellant has already been treated leniently.
- 7. That appeal of the appellant is liable to be dismissed on the following grounds amongst the others.

#### **REPLY ON GROUNDS:**

- A. Incorrect. Order passed by the competent authority as well as appellate authority are legal, lawful and according to rules, hence, liable to be maintained.
- D. Incorrect. Stance taken by the appellant is totally ill based, because the appellant was issued charge sheet alongwith statement of allegations and enquiry was entrusted to SDPO Rural Mardan hence, denied.
- E. Incorrect. Stance taken by the appellant is not plausible because he as called for personal hearing during the enquiry proceedings as well as during Orderly Room held on 03.11.2021 but the appellant has bitterly failed to justify his innocence.
- F. Incorrect. Stance taken by the appellant is not plausible because statements of Lady Constables namely Yusra No.2756, Shumaila No.2906, Fatima No.1315, Maria No.3275 & Aneela No.1328 were recorded as they had made a complaint that an unknown person from Mobile Nos. 0315-8899993 & 0313-7592974 is

making phone calls and teasing them by using objectionable/un-parliamentary language. Besides, the statement of appellant was also recorded wherein he categorically admitted his guilt that complaint made by the aforementioned lady constables is based on facts and he will not repeat the same wrong in future as use will remain cautious in future.

- G. Incorrect. Stance taken by the appellant is not plausible becausethe appellant himself has admitted his guilt in a categorical manner that he will not repeat the same wrong deed.
- H. Para already explained needs no comments.
- I. The respondents also seek permission of this honorable tribunal to adduce additional grounds at the time of arguments.

#### PRAYER:-

Keeping in view the above narrated facts, it is most humbly prayed that the appeal of the appellant being badly barred by law and limitation, may kindly be dismissed with costs please.



#### **DISCIPLINARY ACTION**

1, <u>DR. ZAHID ULLAH (PSP)</u>, District Police Officer Mardan, as competent authority am of the opinion that Constable Taxiq Gul No.2133, himself liable to be proceeded against, as the committed the following acts/omissions within the meaning of Police Rules 1975.

#### STATEMENT OF ALLEGATIONS


