

- 5- That appellant having no other remedy filed the instant appeal on the following grounds amongst the others.

## **GROUNDS:**

- A- That the action of the respondents by not fixing the pay of the appellant in BPS-15 from BPS-14 is against the law, facts and norms of natural justice.
- B- That appellant has not been treated in accordance with law and rules by the respondent Department on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C- That the respondents acted in arbitrary and malafide manner while fixing the pay of the appellant in BPS-15 from BPS-12 instead of from BPS-14 to BPS-15.
- D- That no notice has been issued to the appellant before fixation of his pay from BPs-12 to BPS-15.
