JUDGMENT

<u>NIAZ MUHAMMAD KHAN, CHAIRMAN</u>: - Arguments of the learned counsel for the parties heard and record perused.

# FACTS

2. The appellant was not promoted to the next higher grade in the meeting of the Departmental Promotion Committee held prior to his superannuation dated 30.01.2015 on the ground that he had not completed four years of required length of service necessary for promotion.

## ARGUMENTS

3. The learned counsel for the appellant has mainly relied on an order dated 08.12.2014 fixing inter-se seniority between present appellant and two other Deputy Rangers. According to learned counsel for the appellant this order dated 08.12.2014

had restored the seniority of the appellant from 21.12.2010 and if his length of service is reckoned from 21.12.2010 then on 30.1.2015 his length of service would be more than 4 years. The learned counsel for the appellant also referred to Working Papers prepared by the department for the Departmental Promotion Committee wherein the length of service of the appellant is shown more than four years. That in the DPC it was decided that the required length of service of the appellant is less than four years which according to learned counsel for the appellant is contrary to the Working Papers as well as the seniority restoration order dated 08.12.2014.

4. On the other hand, the learned Deputy District Attorney argued that the DPC had rightly decided that 4 years length of service for promotion to the next higher grade was not fulfilled.

## **CONCLUSION**

5. The prerequisites for the institution of the appeal before this Tribunal is that the appellant should have had submitted appeal/representation/review before the higher authority against the original order from which he is aggrieved but no departmental appeal/representation has been filed by the appellant nor there is any mention of such departmental remedy in the memorandum of appeal. In such situation, even the present appeal is not maintainable. Secondly, the very order dated 08.12.2014 is only with regard to the fixation of inter-se seniority of 3 employees namely Gul Zaman, the present appellant and Taj Muhammad. The reason is that in the final seniority list as it stood on 31.08.2014 the inter-se seniority of these persons was as under:-

1. Mr. Muhammad Hanif at S.No. 28.

2. Mr. Taj Muhammad, at S.No. 30.

3. Mr. Gul Zaman, at S.No. 31.

Vide order dated 08.12.2014, Muhammad Hanif, the present appellant has been shown junior to Gul Zaman which order is not in favour of the appellant but against him.

6. The length of service for next higher grade is another issue which according to decision of the DPC is less than four years. It has been admitted today by the appellant that he remained on acting charge basis from 08.12.2009 upto 08.10.2013 and according to him his this service on acting charge basis shall count towards promotion to the next higher grade. The learned counsel for the appellant has not been able to show any law where under the period spent on acting charge basis shall be counted towards length of service to the next higher grade. If any working paper prepared by the office has shown the appellant completed four years of service is not binding on the DPC.

7. Resultantly, the appeal is rejected being not maintainable and also on merit. Parties are left to bear their own costs. File be consigned to the record room.





2. The Departmental Promotion Committee considered promotion cases of the officials of Forest and Wildlife Departments and took decisions as reflected hereunder in each case:-

(A) FOREST DEPARTMENT: PROMOTION OF DEPUTY RANGERS (BPS-11) TO THE RANK OF FOREST RANGERS (BPS-16) ON REGULAR BASIS.

The Committee was informed that pursuant to the Peshawar High Court Abbottabad Bench Order dated 23/7/2015 in Writ Petition No.2615-P/2015, the subject working paper for promotion of Deputy Rangers to the rank of Forest Rangers was placed before the competent forum. It was intimated that both the Deputy Ranger(s), namely Mr. Muhammad Hanif Abbasi and Mr. Taj Muhammad had been retired from Govt: service on superannuation effective for 31/1/2015 & 1/8/2015 respectively. The case was examined in the light of the relevant rules/policy of the Provincial Government.

The committee decided that as both the Deputy Rangers have now been retired from service, they no longer held status of Civil Servants, whereas the Departmental Promotion Committee constituted by the Government for the consideration of promotion cases of regular serving civil servants. As such the forum could not consider the promotion cases of retired civil servants. Hence, both the retired officials could not be considered for promotion at this stage.
