RESPECTFULLY SHEWETH:-

PRELIMINARY OBJECTION:-

- **a)** The appeal is not based on facts and appellant has got no cause of action or locus standi.
- b) That appeal is not maintainable in the present form.
- c) The appeal is bad for non-joinder of necessary and mis-joinder of unnecessary parties.
- **d)** The appellant is estopped by his own conduct to file the appeal.
- e) The appeal is barred by the law and limitation.
- f) The appellant has not come to the Honorable Tribunal with clean hands.

FACTS:-

 The appellant was appointed as constable on 05-11-2003 in district Kohistan and presently serving in District Mansehra. His period of service is about 19 years.

- 2. The appellant while posted as incharge Police check post Toll Plaza, Police station Saddar Mansehra, was proceeded against with allegation that on 28-08-2022, a proclaimed offender Arslan S/O Farooq R/O Baila Subai Shankiari was stopped at Toll Plaza Check Post and released without taking any legal action. Due to his negligence the image of the local Police was badly damaged. The appellant was properly charge sheeted and departmental enquiry was entrusted to Additional Superintendent of Police Mansehra who after proper enquiry and after giving him opportunity of defence, held him guilty and recommended for suitable punishment. (Copy of enquiry file finding is enclosed as annexure "A")
- **3.** That this fact was not brought on record or into the notice of any responsible officer, Hence, denied.
- **4.** That the detail has been given in Para 02. However, the appellant was properly charge sheeted and he joined the whole enquiry proceedings.
- **5.** The appellant was dismissed from service after providing him chance of personal hearing.
- **6.** That departmental appeal was partially accepted and competent authority reinstated him into service and rewarded punishment of reduction in rank which fully commensurate with the gravity of allegations.
- 7. That the appellant has been granted relief by the appellate authority in first appeal therefore his revision petition was rejected being not maintainable.

That the instant appeal is not maintainable on the following grounds:-

A. Incorrect. All the impugned orders are legal fair and according to law.



- **B.** Incorrect. The impugned orders are suitable in the eye of law.

The departmental enquiry in hand was entrusted to the undersigned by the competent authority (District Police Officer, Mansehra) under KP Police E & D Rules 1975 (Amended-2014) to scrutinize the conduct of accused official ASI UMER ABDULLAH POLICE LINES MANSEHRA about the charges leveled against him that on 28.08.2022, proclaimed offender Arsalan s/o Farooq r/o Baila Subai Shinkiari was stopped at Check Post Toll Plaza and released. It shows extreme negligence and inefficiency on his part.

In this regard departmental enquiry against the delinquent official was initiated by the undersigned. For the purpose of transparent enquiry, the delinquent official was summoned, heard in person and his written statement was recorded which is attached herewith enquiry file for perusal and ready reference.

During the enquiry proceedings, the undersigned perused the statements of the delinquent official and observed that on 19.08.2022, he stopped a Toyota Hiace coming from Abbottabad and took the accused person sitting on the last seat out of the vehicle on suspicion. During comprehensive search, the delinquent official recovered a pistol 30 bore alongwith 02 rounds from him. The delinquent official further asked him about his arm license who replied that he is an employee of forest department will show his arm license inside the room. From where, the said accused person managed to escape from the delinquent official pretext of

Mede WE GAL MANSEHRA going to the room. He was also involved in a car theft and local police of Abbottabad informed you.

In view of forgoing, I being enquiry officer found irresponsibility, laxity and sluggish, casual behavior of delinquent official. Furthermore, the said accused person insisted him that he is an employee of forest department and he would show the arms license inside the room but being an incharge/ officer on spot, the delinquent official could not managed to assess the situation due to which said accused person managed to run away from the delinquent official by pretending to show the arms license in the room. Hence, the charges leveled against the delinquent official in the instant charge sheet are stand established therefore, he is recommended for suitable punishment as described in Police Efficiency and Disciplinary Rules 1975 (Amended-2014).
