JUDGMENT

ASHFAQUE TAJ, MEMBER:- Abid Ali Shaukat hereinafter called appellant has moved instant service appeal under section-4 of Service Tribunal Act, 1974 against impugned seniority list dated 07.02.2015 and impugned notification dated 27.07.2015 issued by respondent No. 3. And against inaction of respondent No. 3

against departmental appeal whereby promotion/up-gradation of appellant to BPS-15 was refused.

2. Facts in brief are that appellant joined Education Department as SPST on 04.09.1989. That initially the appellant was appointed in BPS-7 as untrained teacher but subsequently regularized against his post on completing the required training on his turn. That the appellant was ready for training from day first of his appointment but due to lack of institutions he could not do his training in time, so non-performance of training at earlier was not his fault. That in year 2015 seniority lists were prepared but the appellant was shown junior to many of his junior colleagues. Appellant objected to tentative seniority list for promotion to BPS-14/15 but the same was not considered. That on the basis of second seniority list notification No. 3641/46 was issued on 27.07.2015. The teachers junior to appellant were promoted. That appointment and retirement of the appellant are considered from the date of appointment as untrained teachers. That earlier appellant was granted promotion/up-gradation on the basis of same qualification length of service earlier to the respondents. The prayer of the appellant is that impugned notification and seniority list might be set-aside and that appellant be promoted from the date of his original appointment.

3. Learned counsel for appellant contended that in reply to letter dated 02.12.2008 Accountant General Office Peshawar gave opinion on up-gradation of various posts of teachers by submitting that temporary/officiating services followed by confirmation rendered on the relevant posts which are reckonable towards pension can also be counted for the purpose of length of service required for up-gradation. He added that question was asked in above mentioned letter that whether 10 years services will be counted from date of initial recruitment as untrained teacher from the date of passing PTC exam. He was of the view that on this analogy when his service was counted from the date of initial appointment as untrained teacher then his seniority also had to be determined from the date of initial appointment.

4. The learned Government Pleader for respondents controverted that it is a settled rule duly communicated to the Executive District Officer vide letter No. 2296/A-88/KC/SET(M&F)SL/Inform dated 31.08.2012, regard to guidance for preparation of seniority list/promotion/up-gradation of various cadres of teaching staff. The seniority cannot be considered from the date of appointment as untrained teacher. The seniority is considered from the date of regular appointment or from the date of passing the prescribed qualification in case of untrained appointment. Further at serial No. 3 of letter it is recorded that the name of the untrained teachers could not be enlisted in the seniority list unless he passes the prescribed rules. So, the rule is clear on the matter and on the basis of said rule the seniority list was prepared in year 2013 first time and many deserving were promoted which was never challenged. He also pointed that the above mentioned rules were also challenged before this Tribunal in Service Appeal No.1343/2012 dated 31.05.2016 titled "Javed Iqbal PST-vs-Government of Khyber Pakhtunkhwa, through Elementary & Secondary Education, Peshawar" was dismissed, meaning thereby appellant was praying for the matter which had already been decided by this Tribunal.

5. The Tribunal observed that appellant came up with prayer that since his service was counted from the date of initial appointment as untrained teacher for purpose of up-gradation, so on this analogy he is entitled to get seniority and further promotion. We are afraid that this matter has already been decided by this Tribunal vide judgment dated 31.05.2016 in Service Appeal No. 1343/2012. Over and above this, the Tribunal agrees with the arguments/stance of Additional Advocate General that rules on the subject were circulated vide letter dated 31.08.2012 inter-alia untrained teacher cannot be enlisted in the seniority list unless he passes the prescribed professional qualification are palpable and conspicuous reality. The appellant had not asserted that he had been not given due seniority after getting requisite professional training. At an end appellant


had likewise failed to point out that he had applied for training but was refused or kept waiting and that fault was not on his part.


6. In view of above the appeal in hand stands dismissed. Parties are left to bear their own costs. File be consigned to the record room.

That the appellant was entitled to promotion as PSHT in preference to his Junior colleagues and, therefore, the impugned notification dated 27.7.2015 is against facts and law and liable to be set-aside.



JUDGMENT

ABDUL LATIF, MEMBER:- Facts giving rise to the instant appeals are that the appellants are belonging to the Education Department and all are serving as PST posts and have got at their credit 20 to 40 years' service. That the basic qualification for the post of PST was duly enhanced with basic qualification from Matric to F.A/F.S.C in the year 2011 and

many other colleagues of the appellants were then appointed on the same posts of PST having their qualification of F.A/F.SC alongwith the PST certificate. That in the year 2007 a policy of up-gradation was promulgated by the than provincial Government, whereby the PTC, Teachers were upgraded from BPS-07 to BPS-12 on the basis of the length of the service. That again a similar summary was formulated at the initial stage by the Education Department that the PST Teachers will be upgraded to BPS-15 having 22 years' service, whereas the teachers having 15 years' service will be upgraded to BPS-14. That the above said policy was just as according to the justice and demand of the teachers community, however later on the said policy was converted from time scale to the education scale, whereby the promotion policy for the PST Teachers was formulated as under:

"Primary School Teacher
(PSIT) (BPS-15)

By promotion, on the basis of seniority-cum-Fitness from amongst senior primary school teachers with at least 10 years' service and having qualification prescribed for initial recruitment of primary school teacher.

Primary School Teacher
BPS-14

By promotion on the basis of seniority-cum-fitness from amongst school teachers with at least 05 years' service as such and having qualification prescribed for initial recruitment of primary school teachers".

That thereby all the fresh appointed F.A/PST have been given the BPS-12, whereas the holders of F.A certificate with 10 years length of service may be upgraded/promoted to BPS-15 and the PSTs with the F.A qualification having 05 years' service may be upgraded to BPS-14. That the appellant alongwith his other hundreds of the colleagues having their services extending from 20 to 40 years have been totally ignored and have not been given chance of up-gradation/promotion throughout their professional career in-spite of having such a long spotless tenure of service. That in this respect the appellants have also moved their representation to the concerned authorities which was not responded and hence the instant service appeals with a prayer that on acceptance of the instant service appeals the condition of F.A/F.SC from the

notification dated 13.11.2012 for the promotion of the PST Teachers may please be removed and the promotion may please be granted on seniority-cum-fitness basis.

2. The learned counsel for the appellant argued that act of the respondent-department depriving the appellants from the benefits of up-gradation/promotion was illegal, unlawful, without authority/jurisdiction and also based on malafide of the respondent-department which was liable to be set-aside. He further argued that a large number of teachers had been treated in a discriminatory manner and depriving them of the said benefits mere on the ground that they were having no qualification of F./F.SC was unjust and without reasonable ground as the basic qualification at the time of the appointment of the appellants was Matric with PST and similarly basic qualification at the time of appointment of the benefited teachers was F./F.SC with PST hence no preferential treatment could be granted to those who were initially appointed on the prescribed qualification. He further argued that the appellant had at their credit a long tenure of service ranging from 18 to 40 years and had legitimate expectations for promotion however were unlawfully deprived from such promotion by way of fixing higher qualification for appointment against the higher pay scale of PST. He further contended that it had never happened that in the case of up-gradation/promotion the factor of seniority should be abolished/ignored totally and ground of up-gradation/promotion should be made mere educational qualification whereas up-gradation/promotion had always been made on the basis of seniority-cum-fitness and had never been done on the basis of higher qualification. He further argued that benefit of up-gradation was extended to the Clerks Community who were placed in higher scale across the board without any change of qualification and also cited precedental case of PST teachers by the Federal Government where teachers were up-graded from BPS-9 to BPS-14 including the matriculate teachers and prayed that on acceptance of this appeal the respondents may be directed to set-aside the term of "having qualification prescribed for initial recruitment of Primary School Teachers" and the appellant may be considered equally for the above said promotion/up-gradation which the other colleagues who had been appointed as PST BPS-14/15 on F./F.SC basis. He relied on case law 1991 SCMR 1041.

3. The learned Additional Advocate General assisted by learned Senior Government Pleader and Government Pleader, resisted the appeals and argued that the government introduced incentive of higher pay scale for various cadre of the teaching community with a view to improve efficiency and performance of the Education Department. For the purpose a number of new tiers/cadres were introduced beside the existing cadre and amendments were also made in the service rules where the mode of appointment was made more competitive commensurate to the incentive of higher pay scale in the respective post/cadre. He further argued that while introducing the revised higher pay scale beside qualification length of service/experience was also given due weightage as was given on previous occasions vide notification dated 01.10.2007. He argued that framing of rules and introducing amendments therein was the executive domain of the government who in the larger interest of the public was mandated to prescribe the higher qualification and skill/experience for appointment against various posts and there was no malafide on the part of government in obliging/favouring any particular person or class of persons while introducing such reforms for improvement of performance of the department. He further argued that revised service structure vide impugned notification was legal, was done with lawful authority/jurisdiction and was based on bonafide and prayed that the appeal being devoid of any merits may be dismissed. He relied on case law 2015 P.L.C (C.S) 962.

4. Arguments of learned counsels for the parties heard and record perused.

5. From perusal of the record, it transpired that Provincial Government in the Education Department introduced incentive of higher pay scale alongwith new tiers/cadres for improvement of efficiency and performance of the Elementary and Secondary Education Department. During the process of such restructuring the method of appointment/promotion to the higher pay scales/posts was also revised and revised qualification, experience and length of service were prescribed for promotion against the posts carrying higher pay scale. The entire process was completed in the prescribed manners under rule 3 (2) of the Appointment, Promotion and Transfer Rules 1989 made under the Civil Servant Act 1973. The restructuring was duly completed in consultation with the relevant stake holders department such as Establishment, Finance and Law Departments and Public Service Commission also consulted

in the process. There was therefore no malafide on the part of the Provincial Government, the entire process was rather completed with bonafide. The record also reveals that the Provincial Government in the past had also introduced package of reform which comprised of higher pay scale with commensurate enhancement of qualification and experience as well as length of service in the next below cadres/tiers. The record also reveals that impression of discrimination aired by the learned counsel for the appellants was wrong and unfounded as no particular person or class of persons could be shown who were given preferential treatment at the cost of others including the appellants. It is also ironical that there was no provision in the existing rules prior to the introduction of the new structure where PST Teachers with existing qualification of Matric were to be elevated to higher posts/cadres which was now changed to the disadvantage of the appellant nor their terms and conditions of service were varied to their disadvantage. This being so, we are of the opinion that by introduction of the revised rules ^{Service} structure, the appellants and other similarly placed persons were not affected adversely nor were they discriminated against and such perception on their part is misplaced. While reaching such conclusion we agree to the arguments advanced by the learned Additional Advocate General that Provincial Government in the Education Department is mandated and it is the executive domain of the government to frame, revise or amend the rules and prescribe particular qualification/experience and skill etc for any post. In the circumstances, we do not find any force in the arguments of the learned counsel for the appellants and we do not deem it appropriate to interfere in the impugned notification dated 23.11.2012 made by the respondents. The appeal being devoid of any merits is therefore dismissed. Parties are, however, left to bear their own costs. File be consigned to the record room.



APPEAL U/S 4 OF THE SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED SENIORITY LIST DATED 07.02.2015 OF RESPONDENT NO.3 AND IMPUGNED NOTIFICATION NO.3641/46 DATED 27.07.2015 OF RESPONDENT NO.3 AND AGAINST THE IN ACTION OF RESPONDENT NO.3 IN RESPONSE TO DEPARTMENTAL APPEAL WHEREBY PROMOTION/ UP-GRADATION OF THE PETITIONER TO BPS-15 AS PSHT/ SPST HAS BEEN REFUSED.

Prayer:

On acceptance of the instant appeal, the impugned notification and seniority list mentioned above may kindly be set aside by rectifying/ amending the same and the

respondents may kindly be directed to promote the petitioner according to the law and rules as well as in light of the judgment of superior courts i.e. from the date of their original appointment.

Respectfully submitted;

- 1) That the petitioner has been working in the education department as SPST since 04.09.1989 vide order dated 734-787. (Copy of appointment letter is annexed).
- 2) That initially the petitioner was appointed in BPS-7 as untrained PTC teacher but subsequently regularized against his post on completing the required training on their turn due to lack of training institutions for teachers training.
- 3) That the petitioner from the day first of his appointment was ready for training but this was not possible due to the lack of training institutions and the petitioner was to wait for his turn of training, so there was no fault on the part of the petitioner for getting the required training later on, on his turn.
- 4) That during his service career, the petitioner was promoted from BPS-7 to BPS-12 on account of upgradation/ promotion of PST post to BPS-12 in the year 2008 on completion of 10 years service as trained/ untrained teacher earlier than the respondents. (Copy of letter is annexed).
- 5) That previously no annual increments were available to untrained PTC teachers, but later on the august Supreme Court of Pakistan in Appeals No.ALS 117-118 and 595 to 613 allowed annual increments and pay fixation to all the concerned/ teachers for the service period rendered by them as untrained teachers.

- 6) That in the light of the judgment of the Supreme Court in the above mentioned appeals, the Federal Govt. was kind enough to grant the benefits of annual increment and pay fixation to all the concerned teachers of Federal Govt. institutions vide a letter No.0409/4/93-FGE (M). (Copy of letter of GHQ is annexed).
- 7) That later on a letter/ policy No.2612-25-A dated 21.01.2013 was issued by the respondent department for promotion of PST teachers to BPS-15. (Copy of policy is annexed).
- 8) That the petitioner along with other similar teachers, was also qualified for promotion to the post of PHST BPS-15 and SPST B-14, therefore, he approached to the respondents for the same.
- 9) That in the year 2015, seniority lists were prepared but the petitioner was shown junior to the many of his junior colleagues, due to which the petitioner objected to the tentative seniority list for upgradation/ promotion to BPS 14/15 but the same was not considered. (Copy of appeal is annexed).
- 10) That in the meanwhile the impugned second seniority list was prepared by the respondent No.3 in which the petitioner was shown at serial No.179, as shown most junior to the respondents No.4 to 40. (Copy of impugned seniority list annexed).
- 11) That the same seniority list was also objected to by the petitioner/ appellant but his contention was not considered.
- 12) That in the light of the impugned seniority list, the impugned notification for promotion was issued vide No.3641/46 dated 27.07.2015 of respondent No.3, but unfortunately the name of the petitioner/ appellant was missing in the said notification for the reasons best known to the respondent No.3 whereas teachers junior than the appellant were shown upgraded/ promoted to BPS-15. (Copy of impugned notification is annexed).

- 13) That the petitioner/ appellant approached to respondents vide a departmental appeal dated 30.07.2015 but the same was not responded, hence the present service appeal before this Hon'ble Tribunal on the following grounds inter alia. (Copy of appeal is annexed).

GROUND:

- a. That the said acts of the respondents is against law, facts, constitution, illegal, unlawful and against the material available on record, hence untenable in the eyes of law and liable to be set aside.
- b. That the petitioner has not been treated in accordance to the law as against Article 4 of the Constitution.
- c. That the petitioner has been discriminated as against Article 25 of the Constitution as similar other teachers of the country has been granted the benefits of promotion/ upgradation and pay fixation for the period rendered by then as untrained teachers.
- d. That even the august Supreme Court of Pakistan has allowed the same benefits to the teachers like the petitioner and the decision of the supreme court is binding on the respondents.
- e. That appointment and retirement of the petitioner are considered from the date of original appointment i.e. appointment as untrained teacher.
- f. That the petitioner has earlier been granted promotion/ upgradation to BPS -12 on the basis of same qualification/ length of service and in the mentioned promotion to BPS-12, he was promoted earlier than respondents.
- g. That other grounds will be raised with the kind permission of this hon'ble Tribunal at the time of arguments.



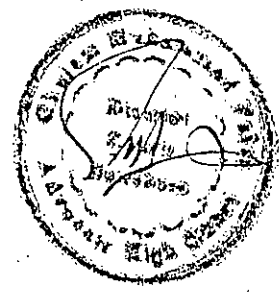
(b) Some confusion also exist about the grant of upgraded BPS 12 to PST, who were
iniatally appointed as untrained PST but latter on passed the requisite PTC exam
during services. The question is whether 10years services will be counted from
the date of initial appointment as untrained teacher or from the date of passing
PTC exam.

This office is of the view that the condition of 10years services is related
to services rendered as PST and the services rendered other than PST is not to be taken
into account for grant of BPS12. AS regard the query in Para (b) it is opined that such
teachers possessing 10years services as untrained /trained teacher are entitled to BPS 12.

The view of this office if correct may please be confirmed or the exact
intention of the expression of 10years services may please be clarified.

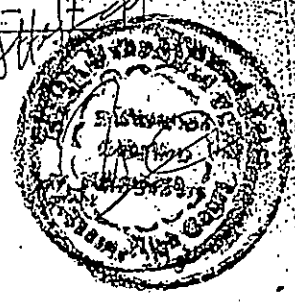

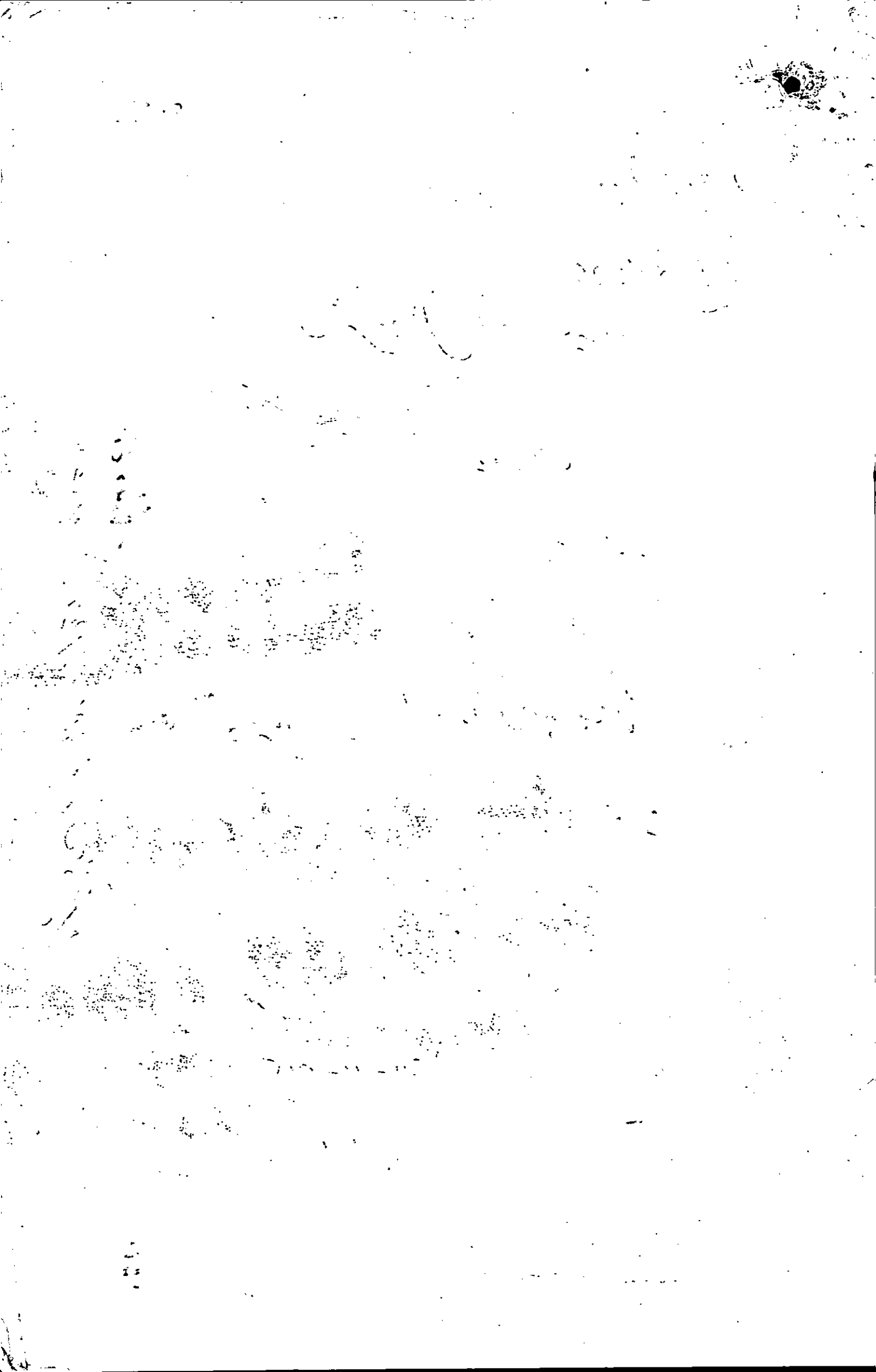

Written comments on behalf of respondents are as under.

Preliminary Objections

1. That the Appellant has no cause of action/locus standi to file the instant appeal.
2. That this honorable service tribunal has got no jurisdiction to entertain the present appeal.
3. That the present Appeal is bad for non-joinder and mis joinder of necessary parties.
4. That the instant appeal is barred by law and limitation.
5. That the appellant has concealed material facts from this honorable service tribunal.
6. That the appellant is estopped by his own conduct, by deed and by law to file the instant appeal.
7. That the instant appeal is not maintainable in its present form.

On Facts:-


1. Pertain to the appellant record.
2. Incorrect. There were sufficient training institutes for teacher training from the very start. However after completing the required training he was regularized.
3. Incorrect. The fault was on the part of appellant for not acquiring/getting training on time. There was no ban/turn for getting training. Each and every teacher was allowed to get training/short course any time.
4. Pertain to record.
5. No Comments.
6. Concerned with Federal Employees hence no comments.
7. Incorrect. The policy mentioned in Para-7 of the appeal is not for the promotion of Primary Teachers from BPS-12 to BPs-14 and 15, but only for the posting/adjustment of teachers. The promotion policy was introduced in November, 2012 Annexure-A and the seniority was prepared of different teaching cadres in the light of letter No. 2296 dated 31/08/2012.
8. Incorrect. On the basis of seniority cum fitness the appellant was not entitled for promotion to BPS-14 and 15.
9. Incorrect. The seniority list of Primary School Teachers was prepared in the year 2013 first time in the light of Director Establishment guidance/letter No. 2296 dated 31/8/2012 and many deserving teachers were promoted to BPS-14 and 15 in the year 2013. No objection was made on the first seniority list by the appellant.
10. Incorrect. The respondent No.4 to 40 were seniors as compared to the appellant.
11. Incorrect. The appellant never objected on the seniority list.
12. Incorrect. The teachers promoted were senior to the appellant. Further to state that if appellant considered himself aggrieved from the seniority list he should have challenge the same before proper forum. In the instant case he being junior having no locus standi to challenge promotion order
13. Incorrect. No departmental appeal was submitted by the appellant.



It is, therefore, requested before your honor that the present appeal is being without force against facts may kindly be dismissed with cost.







SUBJECT: Guidance for the preparation of seniority lists/promotion/upgradation of various cadres of teaching staff in Distt: Peshawar.

I am directed to refer to your letter No. 11005 dated 23-8-2012 on the subject noted above and to inform you as under:-


1. The seniority cannot be considered from the date of appointment as untrained teacher. The seniority is considered from the date of regular appointment post or from the date of passing the prescribed professional qualification in case of untrained appointment (copy of the Rules attached).
2. The name of the teacher transferred from one district cadre post to other Distt: cadre post on his own request will be placed at the bottom of the seniority list i.e according to the date of taking over charge after the date of issue of his inter Distt: transfer order.
3. The name of the untrained teacher cannot be enlisted in the seniority list unless he passes the prescribed professional qualification.
4. The seniority of the teacher who was transferred to his own District due to devolution of Divisional Directorate will not be disturbed.
5. The new upgraded posts i.e BPS-14, BPS-15 & BPS-16 will be filled by promotion etc as & when the new Service Rules are notified by the Govt: of Khyber Pakhtunkhwa. The notification for constitution of DPC will be issued soon after the new Service Rules.
6. The ACRs/PERs are not required in fixation of pay due to upgradation of scales of PST/Qari teachers (M&F) in BPS 12 as well as upgradation of scale of CT/DM/PET/AT/TA teachers (M & F) in BPS-15. The ACRs will be required for their promotion in next scale against the newly upgraded posts in BPS-14, BPS-15 & BPS-16.
7. The new service rules/ amendment are under process.
8. Before the Service Recruitment Rules 2011, the teachers having FA & F.Sc (in 3rd division) already appointed according to the prescribed rules at that time, will be considered for seniority, but their promotion against the newly upgraded posts will be considered if allow the new Service Recruitment Rules which is under process.
