JUDGMENT

**Mr. ATIQ UR REHMAN WAZIR MEMBER (E)**:- Brief facts of the case are that the appellant was appointed as PST on 20-03-2000. The appellant was transferred on deputation for three years to Federal Directorate of Education, Islamabad vide order dated 20-05-2010 and he was relieved by the respondents on 12-11-2010, whereupon he joined his new assignment in Islamabad and served there till 09-12-2014 with an overstay of more than one year. The appellant was repatriated by borrowing department on the request of parent department of the appellant vide order date 09-12-2014. Upon repatriation, the appellant reported his arrival on 31-01-2015 in his parent

department. The appellant was proceeded against on the charges of absence from duty and ultimately, major penalty of compulsory retirement from service was imposed upon the appellant vide order dated11-12-2015, against which the appellant filed service appeal No. 478/2016, which was decided in favor of the appellant vide judgment dated 17-10-2017. The respondent filed CPLA in the Supreme Court of Pakistan and the apex court vide judgment dated 16-02-2021 set aside the judgment of this Tribunal and remanded the case back to this Tribunal for decision afresh in accordance with law.

02. Written reply/comments were submitted by respondents.

03. Arguments heard and record perused.

Ó4. Learned counsel for the appellant has contended that while imposing major penalty of compulsory retirement from service, the appellant was issued only show cause notice and no regular inquiry was conducted, nor any charge sheet/statement of allegations was served upon the appellant. Learned counsel for the appellant further contended that the appellant was not treated in accordance with law, as the respondents did not bother to afford an opportunity of defense to the appellant and awarded major penalty in a slipshod manner, which is against law and rules. Learned counsel for the appellant argued that the appellant was proceeded against on the charges of absence from duty, but in fact the appellant performed his duty in Islamabad, which is evident from the relieving report dated 31-01-2015. Learned counsel for the appellant further argued that the appellant applied for extension in deputation, six months before expiry date of the deputation and series of correspondence took place between borrowing and lending department in a very positive manner and it was almost agreed to grant extension, but all of a sudden the appellant was repatriated. Learned counsel for the appellant

explained that during the whole process, the respondents never reprobated the request for extension in deputation, which however, was required by the respondents to refuse in the initial stage, but a lot of correspondence took place and the appellant was under impression that extension is being granted; that the appellant has been condemned unheard, hence the impugned order dated 11-12-2015 and not taking action on departmental appeal of the appellant within statutory period are against law, fact and norms of justice, therefore are not tenable and are liable to be set aside.

05. earned Additional Advocate General appeared on behalf of official respondent has contended that the appellant was transferred on deputation for three years w.e.f 12-11-2010 to 11-11-2013 and it is very clearly mentioned in the deputation order dated 12-02-2010 that no extension in deputation will be granted, but inspite of that the appellant overstayed till 30-01-2015 and absented from duty. Learned Additional Advocate General further contended that the appellant was not granted any extension in deputation, rather the appellant was asked during disciplinary proceedings to produce order regarding extension in deputation but the appellant did not produce any order regarding extension in deputation. Learned Additional Advocate General argued that the appellant was proceeded against by issuing directly a show cause notice, as the competent authority dispensed with the inquiry and upon submission of reply to the show cause notice, the appellant was awarded major penalty as he did not prove his innocence. Learned Additional Advocate General further argued that the penalty so awarded does commensurate with guilt of the appellant, hence his appeal being devoid of merit may be dismissed.

06. We have heard learned counsel for the parties and have perused the record. Record reveals that the appellant submitted an application for extension of his deputation vide appeal dated 04-05-2013, much earlier than the expiry

date of deputation i.e. 11-11-2013, upon which a series of correspondence took place between borrowing and lending departments. What we have gathered from such correspondence was that his appeal was properly processed by the respondents and the respondents principally agreed for grant of extension in his deputation, which is evident from the record. Record reveals that correspondence were held between lending and borrowing departments for grant of NOC in respect of the appellant, which also were granted reciprocally. It took almost two years lingering his case between the parties, but neither the respondents reminded or recalled him after expiry of deputation period, nor respondents sought extension in such period, which had created an impression in mind of the appellant that extension will be granted in due course. Record is silent as to what prompted the respondents to obliterate the whole process and all of a sudden, repatriated the appellant and initiated disciplinary proceedings on the charges of absence from duty, which however was not warranted in the manner and mood adopted by the respondents. Reliance was placed on 1990 SCMR 1170.

07. Main charges as per Show Cause notice are absence from duty w.e.f 12-11-2013 to 30-01-2015, whereas the appellant was performing duty with the borrowing department during this particular time, as is evident from the available record. Respondents were well in the knowledge about status of the appellant as is evident from series of correspondence between the parties. We are unable to understand as to how the appellant was declared absent, inspite of the fact that his case was under process between lending and borrowing departments and finally he was repatriated on the request of lending department. We are conscious of the fact that the appellant stayed beyond expiry of deputation period, but the appellant kept the respondents engaged during the whole process and respondents never objected his request for further extension, rather processed his case very positively and it was in the final stage of approval, when something went wrong and he was repatriated and awarded major punishment on the charges of absence, inspite of the fact that he was not on their strength yet and was not posted back in the parent department. While ignoring and closing eyes on lengthy correspondence for his further extension, the appellant was wrongly charged on account of absence, which however was not absence, rather it was an overstay beyond permissible time of deputation and that too, with tacit approval of the respondents, hence act of the respondents put the appellant in a disadvantageous position, which is contrary to the norms of natural justice.

08. While dispensing with the inquiry, the competent authority was required to record reasons in writing, which however, was not done in case of the appellant. It is a well-settled legal proposition backed by numerous judgments of the Apex Court that regular inquiry is must before awarding major penalty, but in case of the appellant, no regular inquiry was conducted, hence the appellant was deprived of availing appropriate opportunity of defense. One disadvantage of non holding of a regular inquiry was that alongwith penalty of compulsory retirement, the appellant was also awarded penalty of recovery of pay drawn during the absence period w.e.f 12-11-2013 to 31-01-2015, the period, when he was on the strength of Federal Directorate of Education and that the appellant had drawn salaries from there during the mentioned period, which means that the competent authority was altogether not aware of such fact that the appellant has drawn no salary from the respondents during the alleged period of absence. Had a regular inquiry been conducted, the blunder as mentioned above would not have happened. Needless to mention that the proceedings so conducted are also replete with deficiencies and the respondents have skipped mandatory provisions of law,

which made the whole process liable to be struck down. We are of the considered opinion that injustice was done to the appellant, as he was wrongly subjected to disciplinary proceedings for a charge, which was not committed by the appellant.

09. In view of the foregoing discussion, the instant appeal is accepted and the appellant is re-instated in service with all back benefits. Parties are left to bear their own cost. File be consigned to record room.

ORDER

<u>GULZAR AHMED, CJ.-</u> We have heard the learned counsel for the parties. The respondent was transferred on deputation vide letter dated 12.02.2010 from Elementary and Secondary Education Department, Government of NWFP to Federal Directorate of Education, Islamabad. The period of deputation was three years and also provided in this very letter that he will be repatriated to the parent department after completion of deputation period and no extension in deputation period will be granted. On completion of three years' deputation

period, the respondent did not join parent department. He was issued a Show Cause Notice dated 05.06.2015, to which he responded on 16.06.2015 and ultimately, the departmental proceeding was concluded against him and he was imposed penalty of compulsory retirement vide Notification dated 11.12.2015. He filed departmental appeal on 28.12.2015 which was not responded, upon which he filed the Service Appeal on 21.04.2016. By the impugned judgment dated 17.10.2017, the Khyber Pakhtunkhwa Service Tribunal, Camp Court, Abbottabad (**the Tribunal**) allowed the Service Appeal filed by the respondent and observed that the penalty is illegal with retrospective effect and thus, is *void* and illegal.

2. We note that though such decision has been reached by the Tribunal but in doing so it did not assign any reason as to how the penalty was illegal or got with retrospective effect and *void* and illegal.

3. No reasons whatsoever have been given in the judgment of the Tribunal for reaching such conclusion and apparently, it seems that it is not a speaking and reasoned judgment, which is the requirement of law.

4. We have asked the learned counsel for the respondent to show any evidence that after completion of three years deputation period, he continued to remain in the employment of borrowing department. The learned counsel for the respondent frankly conceded that no such evidence is available.

5. In the circumstances, we find that the judgment rendered by the Tribunal is not sustainable in the eyes of law and

the same is, therefore, set aside and the matter is remanded to the Tribunal for deciding the Service Appeal of the respondent afresh and in accordance with law.

6. As the matter is quite old, it is expected that the Tribunal shall hear and decide the appeal within three months from receipt of this order.

7. The petition is converted into appeal and allowed in the

JUDGMENT

NIAZ MUHAMMAD KHAN, CHAIRMAN: - Arguments of the learned

counsel for the parties heard and record perused.

#### FACTS

2. The appellant was compulsorily retired on 11.12.2015, against which he filed departmental appeal on 28.12.2015 which was not responded to and thereafter the present service appeal on 21.04.2016.

3. The charge against the appellant was that he was sent on deputation to Federal Government for a period of three years but he did not report to his parent department after the expiry of period of deputation.

### **ARGUMENTS**

4. The learned counsel for the appellant argued that the appellant was sent on deputation for three years but on the expiry of period of deputation, the appellant applied for extension of period of deputation and the borrowing department started correspondence with the lending department regarding extension of period of deputation. That he was finally repatriated by the borrowing department and he reported for duty to the parent department. That the appellant had been performing his duty in the borrowing department under the impression that his deputation period has been extended. That soon after his repatriation, the appellant reported to his parent department. That in similar situation, the august Supreme Court of Pakistan has ruled that the order of compulsory retirement was not justified under the law. In this regard, the learned counsel for the appellant relied upon judgments reported as 1990-SCMR-1170 and 1992-PLC(C.S) 782. The learned counsel for the appellant further argued that the impugned order is from back date and in view of judgment reported as 1985-SCMR-1178 such order is not only unlawful but void.

5. On the other hand, the learned Deputy District Attorney argued that in the very order of deputation it was specifically mentioned that the deputationist would report back to the parent department after expiry of the deputation period and that no further extension would be granted.

### CONCLUSION.

6. The appellant admittedly was on deputation for 3 years. It is also an admitted position that there had been correspondence between the borrowing department and lending department about the extension of time of deputation. That the appellant had been serving in the borrowing department till his repatriation by the borrowing department. In

view of the judgment referred to above such penalty is illegal and the retrospective effect of the order is also void and illegal.

7. As a sequel to the above discussion, this appeal is accepted, the impugned order is set aside and the appellant is reinstated in service. Parties are left to bear their own costs. File be consigned to the record room.



That the appellant is living in Islamabad with his family and his wife is also working as teacher in Federal Directorate of Education Islamabad which is evident from the certificate of Principal Islamabad Model School. Therefore the appellant applied for transfer on deputation to Federal Directorate of Education Islamabad for 3 years which was approved by the Federal Directorate of Education Islamabad on dated 12.2.2010 and on the basis of which KPK Education also allowed vide order dated 20.5.2010 and the appellant relieved on 12.11.2010 (copies of certificate and order dated 12.2.2010, 20.5.2010 and 12.11.2010 are attached as Annexure-B,C,D&E)
- 3. That the appellant applied for extension of deputation before 6 months of expiry of his transfer on deputation by letter dated 4.5.2013. (Copy of letter dated 4.5.2013 is attached as Annexure-F)
- 4. That on the basis of the application of the appellant, the SDEO (M) Abbottabad wrote an letter on 26.6.2013 to DEO M) Abbottabad for extension of appellant's deputation for two years for kind perusal and further necessary action and on the basis of that the Dy: DEO (M) Abbottabad wrote an letter on 2.7.2013 to SDEO(M) for submission of service book of the appellant on which the SDEO(M) submitted the photocopy of the service book of the appellant vide letter dated 22.7.2013. (Copies of letters 26.6.2013, 2.7.2013 and 22.7.2013 are attached as Annexure- G,H&I)
- 5. That on the same issue the Dy: DEO (M) wrote a letter to Director E&SE on 3.8.2013 and on 2.9.2013 the SO (Primary) wrote a letter to Director Federal Directorate of Education Islamabad with request that NOC/consent of the Federal Directorate of Education Islamabad may kindly be conveyed to this E&SE Department for further processing the case. On the basis of which the Federal Directorate of Education requested for NOC for extension in deputation period for 2 years with effect from 12.11.2013 to 11.11.2015 to process the case further vide-letter dated 11.12.2013. (Copies of letter 3.8.2013, 2.9.2013 and 11.12.2013 are attached as Annexure-J,K&L)

That on 15.8.2014, the Federal Directorate of Education wrote another letter to SO (Primary) Govt: of KPK E&SE Department for NOC extension in deputation period of the appellant and on the basis of which SO (primary) wrote letter on 3.3.2014 to Director E&SE Peshawar for request to furnish NOC/comments to his department for further processing the case and on that the Dy: Director (Estab) E&SE Edu: KPK Peshawar wrote a letter to DEO(M) Abbottabad on 25.3.2014 for further necessary act. The Dy: Director (Estab) E&SE Edu: KPK Peshawar also wrote a letter the SO (PE) Govt: of KPK, E&SE Edu: Department on 24.6.2014 for the same issue for further necessary action. (Copies of letter dated 15.8.2014, 3.3.2014, 25.3.2014 and 24.6.2014 are attached as Annexure-M,N,O&P)

- 7. That the appellant also submitted many applications to the department for extension of his deputation for 2 years. (Copy of that applications are attached as Annexure- Q)
- 8. That the Federal Directorate of Education repatriated the appellant to his parent department i.e E&SE Education Department Govt: of KPK, Peshawar vide order dated 9.12.2014. On the basis of which the appellant relived from Islamabad Model School and took charge in GPS Bostan Lora on dated 31.1.2015. (Copies of order dated 9.12.2014 and charge report dated 31.1.2015 are attached as Annexure R&S)
- 9. That show cause notice was issued to the appellant in which it was mentioned that there is no need of holding a formal inquiry in the case along with the allegations however the appellant submitted his detail reply to the show cause notice in which he cleared all the situation and denied all the allegations leveled therein. (Copies of show cause notice and reply are attached as Annexure-T&U)
- 10. That the major penalty of compulsory retirement was imposed upon the appellant along with the recovery of pay drawn during the period w.e.from 12.11.2013 to 31.1.2015 out of his emoluments/ pension/G.P fund vide order dated 11.12.2015 against which the appellant filed departmental appeal on 28.12.2015 which was not responded within the statutory period of ninety days. (Copies of order dated 11.12.2105 and departmental appeal area attached as Annexure-V&W)
- 6. That now the appellant come to this august tribunal on the following grounds amongst others.

### **GROUNDS:**

- A) That the impugned order dated 11.12.2015 and not taking action on the departmental appeal of the appellant within the statutory period are against the law, facts, norms of justice and material on record, therefore not tenable and liable to be set aside.
- B) That the appellant has been condemned unheard and has not been treated according to law and rules.
- C) That even no inquiry was not conducted against the appellant to dig out the real situation, rather the department did not bother to conduct inquiry and compulsorily retired the appellant in slipshod manner, which is against the law and law and rules.
- D) That no charge sheet and statement of allegation was served to the appellant which is the violation of law and rules.
- E) That in the show cause notice the main allegation is that the appellant's deputation was expired on 12.11 2013, but he failed to resume his duty after expiry of deputation period and remained absent from duty w.e.from 12.11.2013 to 30 01.2015, but in fact the appellant was not remained absent but he performed his duty in Islamabad Model school which is evident from the relieving receipt from the Islamabad Model school of the appellant. (Copy of relieving receipt is attached as Annexure-X)
- F) That appellant applied for his extension of his deputation six month before of expiry of the deputation, but the federal Directorate of Education and KPK E&SE Education department took about 2 years in the correspondence for issuance of NOC on his application and waited for the decision of the concerned departments. Therefore the appellant did not commit any fault on his part but was punished for the fault of others.
- G) That the appellant did not remain absent from his duty but he regularly perform his duty in Islamabad Model school till relieved by Federal Govt: and when he was repatriated, he immediately relieved from Islamabad Model school and took over charge in GPS Bostan Lora.

- H) That the penalty of compulsory retirement from service is very harsh which is passed in violation of law and, therefore, the same is not sustainable in the eyes of law.
- I) That not responding on the departmental appeal of the appellant is the violation of the Supreme Court judgment reported 2011 SCMR-01.
- J) That no chance of personal hearing was provided to the appellant and as such he has been condemned unheard throughout.
- K) That the appellant seeks permission to advance others grounds and proofs at the time of hearing.

It is, therefore most humbly prayed that the appeal of the appellant may be accepted as prayed for.



#### **Respectfully Sheweth:-**

Comments on behalf of respondents are submitted as under:-

#### **PRELIMINARY OBJECTIONS:-**

- 1. That the appellant has no cause of action to file the instant service appeal.
- 2. That the appellant has no locus standi.
- 3. That the appellant did not come to this Honorable Tribunal with clean hands.
- 4. That the appellant concealed and distorted the material facts from this Honorable Tribunal.
- 5. That the present appeal has been filed just to pressurize and blackmail the respondents.
- 6. That the instant service appeal is not maintainable in its present form.
- 7. That the instant appeal is hopelessly time barred.
- 8. That the appellant has suppressed the original facts from this Honorable Tribunal hence, not entitled for any relief & appeal is liable to be dismissed without any further proceeding.
- 9. That the appellant has given full opportunity of personal hearing but he failed to appear before the authority hence, the authority has passed the order dated 11-12-2015 after fulfillment all the formalities hence, the appeal is liable to be dismissed without further proceeding.

#### Factual objections:-

- 1. That Para No. 1, of the instant appeal relates to the service record of appellant hence, no comments.
- 2. In reply to para No. 2, of the instant appeal it is submitted that transfer of appellant on deputation for three (03) years w.e.f 12-11-2010 to 11-11-2013 was approved by the Government of Pakistan, Federal Directorate of Education Islamabad vide letter No. F.03-5/2010 (SA) FDE dated 12-02-2010, wherein it is clearly recorded/mentioned at serial No. (VIII) of the terms & conditions of said deputation letter which is reproduced as below:

"that he will repatriated to the parent department after the completion of deputation period & no extension in deputation period will be granted". (Copy of the said letter is appended as annexure "A".

- 3. In reply to Para No. 3, of the instant appeal it is submitted that the deputation period of appellant was expired on 11-11-2013, but he failed to join his parent department after expiry of deputation period & remained willful absent from duty w.e.f 12-11-2013 to 30-01-2015 & applied for adjustment on 02-02-2015 w.e.f 31-01-2015. (Copy of application regarding adjustment dated 02-02-2015 is appended as annexure "B".
- 4. That the Para no. 4 of the instant service appeal relates to record. Furthermore, appellant was directed to provide notification of extension in deputation period from 12-11-2013 to 12-11-2015 (02 years) vide office memo Nos. 1069 dated 12-02-2015, & 1195 dated 19-02-2015, but he badly failed to provide the same. Copies of the letters dated 12-02-2015 & 19-02-2015 are appended as annexure "C" & "D" respectively.
- 5. In reply to Para No. 5 of the instant service appeal it is submitted that as per Government of Khyber Pakhtunkhwa Elementary & Secondary Education Department letter No. SO (PE) 5-2//IPT/08/Batagram/2014 dated 03-04-2015, appellant was directed to report back but he did not comply with the direction of Department. Copy of the letter No. SO (PE) 5-2//IPT/08/Batagram/2014 dated 03-04-2015 is appended as annexure "E".
- 6. That the Para No. 6, of the instant appeal relates to record hence, no comments.
- 7. That the complete reply has already been given in the Para No. 2 of the factual objections.
- 8. That the Para No. 8, of the instant appeal relates to record.
- 9. That the Para No. 9 of the instant appeal is correct to the extent of issuance of the show cause notice while rest of the para as composed is incorrect hence, denied as the reply of the appellant was unsatisfactory.
- 10. In reply to para No. 10, of the instant appeal it is submitted that appellant was summoned for personal hearing on 27-06-2015, vide letter No. 5828 dated 24-06-2015 through SDEO (Male) Abbottabad but he did not appear for personal hearing on the scheduled and badly failed to defence the charges leveled against him. Therefore, respondent No. 3 imposed major penalty of **"COMPULSORY RETIREMENT"** with recovery of pay drawn during the absent period w.e.f 12-11-2013 to 31-01-2015 out of his emoluments/pension/G.P.Fund vide Endst No. 9665-68 dated 11-12-2015. Copies of the letter for personal hearing dated 24-06-2015 & order dated 11-12-2015 are appended as annexure "F", & "G" respectively.

#### **GROUNDS:-**

- A. That ground a, as composed is incorrect hence, denied. Appellant himself remained willful absent w.e.f 10-08-2010 to 30-06-2015 & illegally/ fraudulently amounting to Rs. 1602176/ as a salary from Govt: Exchequer during the absent period.
- B. That ground b, as composed is incorrect hence, denied. The opportunity of personal hearing was provided to appellant vide office letter No. 5828 dated 24-06-2015 but, he failed to appear on the scheduled date.

- C. In reply to ground c, it is submitted that there was no need to holding a formal inquiry as appellant himself remained on unauthorized deputation inspite of direction of department to report back but he did not comply with the direction of department and remain absent from duty w.e.f 12-11-2013 to 31-01-2015.
- D. In reply to ground d, it is submitted that there was no need to holding a formal inquiry as it is a prerogative of the competent authority under Rule 7 of the E&D Rules 2011, to dispense with the inquiry.
- E. That ground e, as composed is incorrect hence, denied as detailed reply has already been submitted in Para No. 3 & 4 of the factual objections.
- F. That ground f, as composed is incorrect hence, denied as comprehensive reply as already been given in above Paras No. 4 of the factual objections.
- G. That ground g, as composed is incorrect hence, denied an appellant remained unauthorized deputation without any extension notification regarding the deputation and willful absent from duty w.e.f 12-11-2013 to 30-01-2015.
- H. That ground h, as composed is incorrect hence, denied as order dated 11-12-2005 was issued after observing all the codal formalities as well as due process of law. That ground f, as composed is incorrect hence, denied.
- I. In reply to ground i, it is submitted that each case has its own facts and circumstances.
- J. That ground j, is incorrect hence, denied. The opportunity of personal hearing was provided to appellant vide office letter No. 5828 dated 24-06-2015 but, he failed to appear on the scheduled date.
- K. That the respondents seek permission of this Hon: Tribunal to advance further grounds during arguments.

It is, therefore, very humbly prayed that in the light of forgoing comments the appeal in hand may graciously be dismissed with cost throughout.



(1-9) All objections raised by the respondents are incorrect and baseless. Rather the respondents are estopped to raise any objection due to their own conduct.

### FACTS:

- 1. Admitted correct by the respondents as the service record of the appellant is present with the department.
- Incorrect. The appellant applied for extension of his deputation 2. before 6 months of expiry of his transfer which was duly forwarded by the SDEO (M) Abbottabad to DEO (M) Abbottabad for kind perusal and further necessary action on the basis of which the Dy: DEO (M) wrote a letter to Director E&SE on which the SO(Primary) wrote a letter to Director Federal Directorate of Education Islamabad with request NOC/ Consent of the Federal Directorate of Education may kindly be conveyed to the E&SE Department on which Federal Directorate of Education requested for NOC for extension in deputation period of 2 years w.e from 12.11.2013 to 11.11.2015 to process the case further. The Federal Directorate of Education wrote anther letter to SO(Primary) of KPK E&SE Deptt: for NOC extension in deputation of the appellant on which the SO (Primary) wrote a letter to Director E&SE Peshawar for request to furnish NOC/ Comments to his department for further processing the case on which the Dy: Director (Estab) E&SE Edu: Deptt: wrote a letter the SO (PE) Govt: of KPK, E&SE Edu: Deptt: for the same issue for further necessary action. Therefore the appellant waited for the decision of the concerned department and did not commit any fault on his fault.

- Incorrect. The appellant applied before 6 months of expiry of his deputation and waited for decision on his application which was corresponded between the concerned departments for about 2 years.
  Incorrect as replied in para 2 of the rejoinder.
- 5. Incorrect. The appellant applied before 6 months of expiry of his deputation and waited for decision on his application which was corresponded between the concerned departments for about 2 years, therefore it was fault of the department that they did not take action on the application of the appellant in one way or the other.
- 6. Admitted correct by the respondents as the service record of the appellant is present with the department.
- 7. Not replied according to para 7 of the appeal. Moreover para 7 of the appeal is correct.
- 8. Admitted correct by the respondents as the service record of the appellant is present with the department.
- 9. First portion of para 9 is admitted correct. Hence no comments while the rest of para is incorrect. Hence denied as the appellant in his reply to show cause cleared the entire situation and denied all the allegations.
- 10. Incorrect. The appellant appeared before the DEO (M) Abbottabad for personal hearing but the DEO (M) took only reply to show cause and told to the appellant this reply would be considered and did not give any chance of personal hearing to the appellant. Therefore imposing of major punishment of compulsory retirement without conducting inquiry and personal hearing is violation of law and rules and liable to be set aside. The appellant also filed departmental appeal against the impugned order which was rejected on 27.1.2017 after about more than one year. (Copy of rejection order is attached as annexure-R-1)

### **GROUNDS:**

A) Incorrect. The appellant did not remained absent from his duty but he performed his duty in Islamabad Model school and the appellant applied before 6 months of expiry of his deputation and waited for decision on his application which was corresponded between the concerned departments for about 2 years, therefore it was fault of the department that they did not take action on the application of the appellant in one way or the other. Therefore the impugned order is against the law, facts, norms of justice and material on record which is liable to be set aside.

- B) Incorrect. The appellant appeared before the DEO (M) Abbottabad for personal hearing, but the DEO (M) took only reply to show cause and told to the appellant this reply would be considered and did not give any chance of personal hearing to the appellant.
- C) Incorrect. According to rules, the competent authority should give reason for dispensing of inquiry but in the case of the appellant the competent authority did not give any reason for dispensing of inquiry which is the violation of law and rules.
- D) Not replied according to para D of the appeal. Moreover para D of the appeal is correct.
- E) Incorrect. The appellant did not remained absent from his duty but he performed his duty in Islamabad Model school and the appellant applied before 6 months of expiry of his deputation and waited for decision on his application which was corresponded between the concerned departments for about 2 years, therefore it was fault of the department that they did not take action on the application of the appellant in one way or the other.
- F) Incorrect. As detail reply has given in para 2 of the rejoinder.
- G) Incorrect. While para G of the appeal is correct.
- H) Incorrect. While para H of the appeal is correct.
- I) Not replied according to para I of the appeal. Moreover para I of the appeal is correct.
- J) Incorrect. The appellant appeared before the DEO (M) Abbottabad for personal hearing, but the DEO (M) took only reply to show cause and told to the appellant this reply would be considered and did not give any chance of personal hearing to the appellant.
- K) Legal.

It is, therefore, most humbly prayed that the appeal of appellant may kindly be accepted as prayed for.

- 3. AND WHEREAS. The District Education Officer (M) Abbottabad served show cause notice through the SDEO (M) concerned and unsatisfactory reply received dated 16.06.2015. He was called for personal hearing on 27.06.2015; the teacher concerned appeared for personal hearing on the schedule date and time but failed to defend the charges level against him. The charges level against the concerned teacher proved and the DEO (M) Abbottabad being competent authority imposed major penalty of "Compulsory Retirement".
- 4. AND WHEREAS, the aggrieved Teacher filed a departmental appeal to the Director E&SE Khyber Pakhtunkhwa (appellate authority) against the aforesaid major penalty imposed upon him by the DEO (M) concerned. The DEO (M) Abbottabad submitted his comments vide letter No.2897 dated 14.04.2016.
- 5. AND WHEREAS, the competent authority Director Elementary and Secondary Education Khyber Pakhtunkhwa) after having considered the charges and evidence on record, is of the view that charges against accused teacher have been proved.
- 6. NOW THEREFORE, in exercise of powers conferred under Khyber Pakhtunkhwa Servants (Efficiency & Discipline) Rules-2011 the appellate authority has decided to reject the appeal of Mr. Abdul Shakoor PST on the above mentioned grounds.





---S.4---Constitution of Pakistan (1973), Art.212(3)---Leave to appeal--Respondent, allowed to proceed abroad on deputation for two years, over-stayed period of deputation and remained abroad for about 11 years, but neither Authority reminded or recalled him after expiry of stay period nor respondent sought extension in such period---Service of respondent on return from abroad after 11 years, were terminated by Authority after observing show cause procedure on ground of overstaying period of deputation---Tribunal, however, accepted appeal against termination order, set aside same holding that failure of Authority to remind or recall respondent after expiry of stay period abroad, had created an impression in mind of respondent that he could remain on deputation till he was recalled or informed---Tribunal in setting aside termination order passed, <u>held</u>, was justified and could not be interfered with---No question of law of public importance having arisen in case, leave to appeal was refused.

#### JUDGMENT

SHAFIUR RAHMAN, J.--The Government of the Punjab seeks leave to appeal under Article 212(3) of the Constitution against the judgment of the Punjab Service Tribunal dated 22-9-1984 allowing the appeal of the respondent.

2. The respondent Mr. Zahid Beg was employed as Physiotherapy Aid in Mayo Hospital Lahore in 1972 when he was allowed to proceed on deputation to Libya. One of the conditions attaching to the deputation was expressed to be as hereunder:-

"Government will have the right to ask the official to return to duty on the expiry of the period of deputation (not exceeding five years) or to quit service, if he is unwilling to return to the country."

3. Neither the Government reminded or recalled him from deputation nor did the respondent seek the extension of it but on return from Libya in 1983 he sought restoration to office which was at first denied to him but later given to him. He was nevertheless charge-sheeted for having over-stayed the period of deputation without authority and after observing the show cause procedure his services were terminated. The Service Tribunal while allowing the appeal held as hereunder:--
