

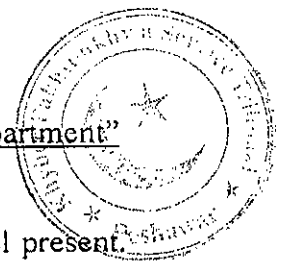
Respectfully shewth:.

ORDER


15th Nov. 2023 Kalim Arshad Khan, Chairman: Petitioner alongwith his counsel present.
