






15.09.2023		<p>Learned counsel for the appellant present and argued that initially appellant was appointed on 20.02.2003 and during service she improved her qualification by obtaining Master of public administration degree on 03.04.2013 the result of which she was promoted in BPS-16 with immediate effect. He further argued that appellant will have to be promoted with effect from 24.08.2021. When junior of appellant was promoted and appellant was ignored. He further argued that joint seniority list issued by the respondent is also not in accordance with law. He requested for Anti-dating promotion of the appellant with effect from 24.08.2021 instead of 06.01.2023. Appellant filed departmental appeal on 23.05.2023 which was not decided within stipulated period of 90 days. Therefore appellant filed instant service appeal on 13.09.2023 under Section 4 of Khyber Pakhtunkhwa Service Tribunal Act, 1974. Points raised need consideration, therefore, appeal is admitted for regular hearing subject to all legal objections. Appellant is directed to deposit security fee within 10 days. Thereafter notice be issued the respondents for submission of written reply/comments. Respondents be summoned through TCS the expenses of which be deposited by the appellant within 3 days.
