PARA WISE COMMENTS ON BEHALF OF RESPONDENTS NO. 01 TO 04

Respectfully Sheweth:

Para wise comments on behalf of respondents are submitted as under:

Preliminary Objections:

- 1. That this Honorable Tribunal has got nothing to do with the fitness for promotion case. In this respect a judgment reported as 2013-SCMR-99 is very much clear.
- 2. That the appellant did not come to this Honorable Tribunal with clean hands. Hence, not entitled for any relief.
- 3. As per Final Seniority List of SSTs (Female), the name of appellant falls at serial No. 961 and she will be considered for promotion to the post of Subject Specialist (SS) Biology BS-17 according to seniority-cum-fitness.
- 4. That the appellant is estopped to sue through her own conduct.
- 5. That the present service appeal is not maintainable due to non-joinder and mis-joinder of necessary parties.
- 6. That the appellant has no cause of action to file the instant appeal.
- 7. That the appellant has no locus standi to file the present appeal.
- 8. That the present appeal has been filed to pressurize the respondents.
- 9. That the instant appeal is not maintainable in its present form hence, liable to be dismissed.

- 10. That the impugned Notification was issued on dated 14-11-2017 whereas, Departmental Appeal was preferred on 09-02-2022 and appellant did not file application regarding condonation of delay hence, departmental appeal as well as service appeal are hopelessly time barred and not maintainable and liable to be dismissed without any further proceedings.
- 11. That the appellant has suppressed the material facts from this Honorable Tribunal, hence, not entitled for any relief and appeal is liable to be dismissed without any further proceedings.

Factual Objections:

- 1. That the Para No. 01, of the Service Appeal pertains to Academic record hence, need no further comment.
- 2. That the Para No. 02 of the service appeal pertains to service record.
- 3. That the Para No. 03, of the service appeal as composed is incorrect hence, denied and not admitted. As per Final Seniority List of SSTs (Female), the name of appellant falls at serial No. 961 and she will be considered for promotion to the post of Subject Specialist (SS) Biology BS-17 according to *seniority-cum-fitness*. (Relevant pages of Seniority List are annexed as **Annexure "A"**)
- 4. That the Para No. 04, of the instant service appeal relates to the recruitment rules/policy.
- 5. That the Para No. 05, of the instant Service Appeal pertains to the record.
- 6. That the Para No. 06 of the service appeal as composed is incorrect hence, denied. As per Final Seniority List of SSTs (Female), the name of appellant falls at serial No. 961 however, as per working papers vide No. 3362 dated 28-08-2023, of SST for promotion against the post of SS (Bio), 46 SSTs (Female) will be promoted as SS whereas, the name of appellant is mentioned at serial No. 02 of the said working papers and Departmental Promotion Committee is in pipeline and appellant will be promoted according to seniority cum fitness.

- (Copy of working papers dated 28-08-2023 and letter of DPC dated 28-09-2022 are annexed as **Annexure "B" & "C"** respectively)
- 7. That the Para No. 07, of the service appeal pertains to record hence, need no further comment.
- 8. That the Para No. 08 of the service appeal as composed is incorrect hence, denied. As the impugned Notification was issued on dated 14-11-2017 whereas, Departmental Appeal was preferred on 09-02-2022 and appellant did not file application regarding condonation of delay hence, departmental appeal as well as service appeal are hopelessly time barred and not maintainable and liable to be dismissed without any further proceedings.
- 9. That the Para No. 09 of the service appeal as composed is incorrect hence, denied as departmental appeal was preferred beyond the period of limitation.
- 10. That the Para No. 10 of the service appeal as composed is incorrect hence, denied.
- 11. That the Para No. 11 of the service appeal as composed is incorrect hence, denied. As this Honorable Tribunal has got nothing to do with the fitness for promotion case. In this respect a judgment reported as 2013-SCMR-99 is very much clear.

GROUNDS:

- 1. That ground 1, of the service appeal pertains to academic as well as service record of the appellant.
- 2. That ground 2, of the service appeal as composed is incorrect hence, denied. Comprehensive reply has already been given in Para No. 06 of the factual objections.
- 3. That ground 3, denied and not admitted.
- 4. In reply to ground 4, of the Service Appeal is denied and not admitted. Comprehensive reply has already been given in preceding paras.
- 5. That ground 5, of the Service Appeal as composed is incorrect hence, denied.


