This single judgment in the above captioned appeal, shall also dispose of appeals (1) bearing No. 20/2016 filed by Muhammad Anwar (2) bearing No. 21/2016 filed by Hayat Shah (3) bearing No.22/2016 filed by Tahir Ullah (4) bearing No. 23/2016</p>

3. The appellant has filed present appeal u/s 4 of Khyber Pakhtunkhwa Service Tribunal Act-1974 against the Notification No. SO (T)HE/17-2/2010 dated 18.08.2010 to the extent of its immediate operation and against the Seniority List dated 07.08.2015 in respect of 869 Lecturers B-17 of College Cadre in Higher Education Department.

4. Learned counsel for the appellant argued that the appellant joined his service in the Higher Education Department as Director Health & Physical Education (BS-16) and later on upgraded to BS-17; that the appellant alongwith his other colleagues were deprived of their due right of promotion due to lack of proper service

structure and accordingly the service appeals were preferred before this Service Tribunal in the year 2006 and resultantly this Service Tribunal vide common judgment dated 30.04.2007 passed in Service Appeal No. 148/2006 directed the respondent department as under:

"In view of the aforementioned discussion, the Tribunal remands the case back to the Respondent Department with the direction to consider the framing of service structure for the DPEs holding M.A/M.Sc. degrees, on the analogy/pattern either of the Governments of Punjab, Balochistan AJK and Federal Government within two months of the receipt of this Judgment. The Tribunal further directs that the inter-se seniority of the appellant and the private Respondents with the Lecturers of the other subjects should also be fixed on the analogy/pattern of the same Government whose service structure is followed/adopted."

5. Learned counsel for appellant further argued that the above mentioned judgment of this Tribunal was called in question by the Government before the august Supreme Court however the CP No.541 and 542 of 2007 filed by the Government were disposed off vide order dated 30.03.2009, on the ground that the department had started efforts to frame the service structure and therefore the appeals stood infructuous. Further argued that the respondent department then delayed the matter without any rhyme and reason and in violation of time line given in the common judgment dated 30.04.2007 of this Tribunal and it was then vide impugned

Notification dated 18.08.2010 that the post of the appellant and his other colleagues were re-designated as Lecturers in Health & Physical Education and they were absorbed in the General Cadre of the Lecturers (Collegiate Branch) Higher Education Department. Further argued that it was also noted in the impugned Notification that the appellant and his other colleagues shall be placed at the bottom of existing seniority list of the Lecturers (General Cadre). Further argued that the department notified the Seniority List on 07.08.2015 with the delay of five (05) years wherein the appellant was placed junior even to those respondents who were appointed as Lecturers in the year 2012. Learned counsel for the appellant stressed with vehemence that the seniority of the appellant is to be fixed from the time line given by the Service Tribunal vide common judgment dated 30.04.2007 passed in service appeal No.148/2006.

6. As against that learned Deputy District Attorney argued that the appellant was contended with the impugned Notification dated 18.08.2010 and therefore he has not challenged the same within the period prescribed under the law rather belatedly assailed the same on 23.12.2015 by filing the present service appeal hence the present service appeal against the impugned Notification is time barred. Further argued that the private respondents were appointed in pursuance of advertisement of the Public Service Commission made in the year 2005, 2008 and 2009 while the impugned Notification was issued in the year 2010 hence the private respondents have rightly been placed senior to the appellant.

7. Arguments heard. File perused.

8. The impugned Notification was issued on 18.08.2010 but the appellant filed departmental appeal there against on 01.09.2015 and then challenged the same before this Tribunal on 23.12.2015, as such the argument of learned Deputy District Attorney that the appellant was quite satisfied with the impugned Notification dated 18.08.2010 and that the present service appeal against the same is time barred is found genuine.


9. From the perusal of the impugned Notification dated 18.08.2010 it is evident that the respondents have clearly mentioned therein that the Directors of Physical Education shall be placed at the bottom of existing seniority list of the Lecturers general cadre. Meaning thereby that according to the impugned Notification the seniority of the Directors of Physical Education i.e. appellant and his colleagues is to be reckoned from the date of issuance of the impugned Notification. It may also be observed that as per minutes of meeting dated 24.02.2016 of Special Committee chaired by the Special Secretary Higher Education, available on file, it was proposed that the seniority of the Lecturers may be considered w.e.f the date of Notification dated 18.08.2010.

10. In the light of above the present service appeal as well as the connected appeals, as mentioned in para 2 of this judgment, are partially accepted in the terms that the seniority of the appellants vis a vis private respondents, shall be reckoned/determined with reference to the date of issuance of the impugned Notification i.e.

w.e.f 18.08.2010. Parties are left to bear their own costs. File be
consigned to the record room after its completion.

Bashir Ahmad vs Govt

Learned counsel for the appellant has submitted that on the strength of judgment of this Tribunal dated 30.4.2007 in Service appeal No. 148/2006 service structure of DPEs was ordered in line with other provinces where against appeal of the respondent department was disposed of by the August Supreme Court of Pakistan vide judgment dated 30.3.2009. That on the strength of the judgment of this Tribunal, the appellant was entitled to induction in the seniority list referred to above in accordance with rules in vogue but the matter was unreasonably delayed, and, finally, the seniority list was issued on 07.8.2015 thus placing the appellant and similarly placed employees at the bottom of the seniority list in violation of the spirit of the judgment of this Tribunal. Learned counsel for the appellant seeks restraint order to debar the official respondents from promotion of the private respondents to BPS-18 in violation of the judgment of this Tribunal.

Learned Senior Government Pleader and learned counsel for private respondents seeks adjournment.

Since the learned counsel for private respondents are seeking adjournment as such the appeal is adjourned for written statement/ comments by the respondents to 13.10.2016. Meanwhile it is directed that Lecturer appointed after notification dated 18.08.2010 through the process of initial recruitment as well as promotion shall not be considered for promotion in preference to appellant and similarly placed employees.




Respectfully Sheweth,





SERVICE APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNALS ACT, 1974 AGAINST THE IMPUGNED SENIORITY LIST NOTIFIED ON 07.08.2015 ISSUED BY RESPONDENT NO.2 WHEREBY RESPONDENTS NO.3 TO 685 WERE PLACED SENIOR TO THE APPELLANT

AS WELL AS THE IMPUGNED NOTIFICATION NO.SO(T)HE/17-2/2010 DATED 18.08.2010 TO THE EXTENT OF ITS IMMEDIATE OPERATION BEING IN VIOLATION OF THE JUDGMENT OF THIS HON'BLE TRIBUNAL RENDERED IN SERVICE APPEAL NO.148/2006 DECIDED ON 30.04.2007 AGAINST WHICH APPELLANT PREFERRED A DEPARTMENTAL REPRESENTATION ON 01.09.2015 BUT THE SAME WAS NOT DISPOSED OF WITHIN THE STATUTORY PERIOD OF 90 DAYS.

PRAYER:

On acceptance of the instant appeal, the impugned Seniority List dated 07.08.2015 issued by Respondent No.2 as well as the impugned Notification No.SO(T)HE/17-2/2010 dated 18.08.2010 to the extent of its immediate operation being in violation of the Judgment of this Hon'ble Tribunal rendered in Service Appeal No.148/2006 decided on 30.04.2007 may graciously be modified/set aside by placing the appellant senior to Respondents No.3 to 685 therein with any other relief as deemed appropriate in circumstances of the case be also awarded to the appellant.

Respectfully Sheweth,

Facts giving rise to the present appeal are as under:-

1. That the appellant joined the service of the Higher Education Department as Director Health & Physical Education (BPS-16) on the recommendations of the Khyber Pakhtunkhwa Public Service Commission on 17.11.1990 and later on upgraded to BPS-17. He has put in 25 years service as such to the entire satisfaction of the high-ups.
2. That the appellant and his other colleagues were subjected to utter discrimination as due to lack of proper service structure, they were deprived of their due right of promotion to the next higher grade in spite of long meritorious service. Accordingly, service appeals were preferred before this Hon'ble Tribunal in the year 2006 which were finally disposed of by a consolidated judgment dated 30.04.2007

(Annex:-A). The relevant portion of the Judgment is reproduced hereinbelow:-

“In view of the aforementioned discussion, the Tribunal remands the case back to the Respondent Department with the direction to consider the framing of service structure for the DPEs holding M.A/M.Sc. degrees, on the analogy/pattern either of the Governments of Punjab, Balochistan, AJK and Federal Government within two months of the receipt of this Judgment. This Tribunal further directs that the inter-se seniority of the appellant and the private Respondents with the Lecturers of the other subjects should also be fixed on the analogy/ pattern of the same Government whose is service structure is followed /adopted.”

The above cited Judgment of the Tribunal was called in question by the Government before the Apex Court in C.P.No.541 & 542 of 2007 but the same was disposed of vide order dated 30.03.2009 (Annex:-B) on the ground that the Department has started efforts to frame the service structure and therefore, the appeals stood infructuous. Thus the Judgment of this Hon'ble Tribunal attained finality.

3. That after the disposal of the C.Ps before the august Supreme Court of Pakistan, the Department then delayed the matter without any rhyme or reason in violation of the Judgment of the Tribunal and it was vide the impugned Notification dated 18.08.2010 (Annex:-C) that the post of the appellant and others were re-designated as Lecturers in Health and Physical Education and absorbed them in the general cadre of Lecturers' collegiate branch of the Higher Education Department with immediate effect instead of the due date. It was also noted in the same Notification that the appellant and others shall be placed at the bottom of existing Seniority List of Lecturers' general cadre.
4. That the Department did not frame/notify the Seniority List as per the mandate of Section-8(5) of the Khyber Pakhtunkhwa Civil Servants Act, 1973 and it was almost with the delay of five years that the impugned Seniority List dated 07.08.2015 (Annex:-D) was issued whereby the appellant was placed junior to Respondents No.3 to 685

in violation of the law as well as the Judgment of this Hon'ble Tribunal cited above:

5. That being aggrieved of the impugned Seniority List and the impugned Notification *ibid*, the appellant challenged the same through departmental Representation (*Annex:-E*) on 01.09.2015 but the same was not disposed of within the statutory period of 90 days, hence, this appeal *inter-alia* on the following grounds:-

Grounds:

- A. That Respondents have not treated appellant in accordance with law, rules and policy on subject and acted in violation of Article 4 of the Constitution of Islamic Republic of Pakistan, 1973 and unlawfully issued the impugned Seniority List/Notification, which are unjust, unfair and hence not sustainable in the eye of law.
- B. That the Government of Punjab in the year 1991 (*Annex:-F*), the Federal Government in 1998 (*Annex:-G*), AJK Government in 1992 (*Annex:-H*), Government of Sindh in 1991 (*Annex:-I*) and even the Government of Balochistan a far backward Province also in the year 2005 (*Annex:-J*) encadred/absorbed all the DPEs in the general Lecturers' cadres but unfortunately encadrement of the appellant and others were unduly delayed and it was in this view of the matter that the Hon'ble Tribunal issued directions for the needful within two months including the merger of seniority of the appellant and others with general cadre Lecturers but instead of two months it took the Department to take more than three years in issuing the impugned Notification for absorption and took yet another almost eight years in issuing the impugned Seniority List due to which the seniority of the appellant and others and their consequent chances of promotions were adversely affected which has resulted in serious miscarriage of justice.

- C. That the delay in issuing the impugned Notification/Seniority List occurred due to the omission/lethargic attitude of the Department in deviation of the directions of the Hon'ble Tribunal which attained finality after the order of the Hon'ble Supreme Court of Pakistan, therefore, the appellant and his other colleagues cannot be made to suffer due to lapse on the part of the Department, therefore, the appellant and others are entitled for seniority/absorption with effect from the timeline granted by this Hon'ble Tribunal in its Judgment referred hereinabove.
- D. That Respondents in Category-A (Respondents No.3 to 372) are those who were directly recruited on the recommendations of the Khyber Pakhtunkhwa Public Service Commission during the period from 18.09.2007 to 10.03.2012. Similarly Respondents in Category-B (Respondents No.373 to 657) were regularized on 24.09.2009 pursuant to the Khyber Pakhtunkhwa Regularization of Civil Servants Act-2009 while Respondents in Category-C (Respondents No.658 to 685) were also appointed on the recommendations of the Public Service Commission in the year 2010, 2011 and 2012. Thus in either of the case, Respondents No.3 to 685 are established juniors to the appellant and his other colleagues, therefore, the impugned Seniority List is violative of Section-8 of the Khyber Pakhtunkhwa Civil Servants Act-1973 read with Rule-17 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989.
- E. That the absorption Notification was issued on 18.08.2010, the mandate of Section-8(5) of the Khyber Pakhtunkhwa Civil Servants Act-1973 is to notify the Seniority List every year preferably in the month of January but in the case in hand, the first Seniority List was issued on 07.08.2015 after long five years, and the seniority assigned to the appellant and his other colleagues thus was reckoned with effect from 07.08.2015 rendering them juniors even to those who joined the Department after 18.08.2010 which is even violative of the

Notification dated 18/08/2010 itself declaring the seniority of the appellant and others at the bottom on the said date and thus the impugned Seniority List is not sustainable under any canons of law, justice and good conscience.

- F. That even under Rule-17(1)(a) read with Rule-17(2) of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules-1989, seniority is to be determined with effect from the date of regular appointment to the post in the cadre but in the case in hand the seniority of the appellant and his other colleagues has been determined with effect from the date of issuance of the seniority list resulting into patent injustice in violation of the law.
- G. That appellant would like to offer some other grounds during the course of arguments.

It is, therefore, humbly prayed that the instant appeal may graciously be accepted as prayed for above.

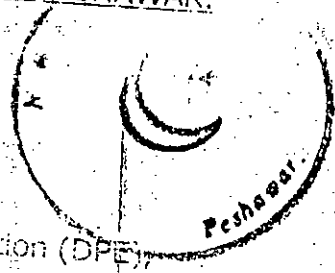

JUDGMENT

MUHAMMAD UMAR AFRIDI, MEMBER- This appeal has been filed by Mr. Farooq Hussain Director Physical Education(DPE) Government College, Peshawar under section-4 of the NWFP Service Tribunals Act, 1974 against the respondent Government's Order No.SO(TRG:)HE/17-1/2003/KC-5/PART-II, Dated 10.5.2005.

2. Brief facts of the case are that on the recommendations of the Public Service Commission, NWFP, the appellant was selected and appointed as Director Physical Education(DPE) in B-16. Since then he had been serving continuously at various stations of postings and had been performing his duties diligently to the satisfaction of his seniors. The appellant on the basis of M.Sc (Physical Education) degree, obtained from the University of Peshawar and his selection and appointment as a Member of the College Teaching Staff, claimed that he was entitled to get all the benefits of service allowed to other members of the teaching staff of the Colleges/Higher Secondary Schools in the NWFP. In view of the appellant, the respondent Government had discriminatory attitude towards his cadre.

3. The appellant alongwith several other members of the cadre/service filed Writ Petition.No. 379/2000 in the Peshawar High Court, Peshawar, which was heard and disposed of vide its judgment dated 06.6.2001. In the said judgment it was observed that:-

"the provincial government should appoint a committee to examine the entire case of the petitioners and, if possible, to give them an adequate relief by making suitable changes in the service structure of the petitioners."

4. The respondent department was reluctant to consider the DPES' case, the appellant alongwith others therefore, approached the

august Supreme Court of Pakistan through C.P. No. 364-P/2001, which was heard by the learned Bench in the Supreme Court on 22.10.2003. The order of the august Supreme Court of Pakistan was as under:-

"It is pointed out by Mr. Muhammad Jamil, Secretary Education that matter is under active consideration and a committee has been constituted to examine the controversy in depth including financial and administrative aspects of the matter.

Matter adjourned. To be fixed after eight weeks."

5. The august Supreme Court of Pakistan again heard and disposed of the case vide its order dated 07.5.2004 under:-

"Learned Advocate General, NWFP states that the summary for suitable changes in the service structure of the petitioners has been moved to the Chief Minister and its finalization would take some time.

In view of the above statement, learned counsel for the petitioners does not press this petition for the time being which is accordingly disposed of."

6. As per his undertaking, the Secretary Higher Education NWFP (Respondent No.2) prepared a summary for approval of the Provincial Government viz: the Chief Minister NWFP but it was altered at the instance of the Finance Department thereby depriving the appellant of whatever benefit of service had been initially proposed by the Higher Education Department. Consequent upon the approval of the summary, the Government of NWFP vide order bearing No. SO (TRG:) HE/17-1/2003/KC-5/PART-II, dated 10.5.2005, accorded administrative approval to the placement of the mentioned posts of Director Physical Education BPS-16 and of the BPS-17 posts in BPS-18. The personal scales BPS-17 availed by the Directors Physical Education were

protected. It was further stated that the share of male and female DPEs would be worked out on the basis of their sanctioned strength. The appellant alongwith the respondents filed departmental appeal to the competent authority which was not responded to. Then they filed the present appeal on 28.2.2006.

7. The appeal was admitted to full hearing on 21.4.2006 and notices were issued to the respondents for filing their written replies. They filed their written replies and contested the appeal. The appellant also filed his rejoinder in rebuttal.

8. Arguments heard and record perused.

9. The learned counsel for the appellant argued that the DPEs were selected and appointed on the recommendations of the Public Service Commission and/or other selection board or authority as prescribed by the Provincial Government. The DPEs had the basic qualification of M.Sc/M.A Physical Education and they came into service through the same channel of selection which was adopted for the recruitment/appointment of Lecturers in other subjects being taught in the Higher Secondary Schools/colleges. It was further argued that the DPEs were not only the trainers of Physical Education in the Higher Secondary Schools/Colleges but were also Lecturers of the subject, i.e. Physical Education which had been introduced as an elective subject in the intermediate and degree levels.

10. The learned counsel for the appellant stated that Federal Government had granted the status of Lecturer to all the Physical Education Instructors/Directors and they had entered the service as such in BPS-17. They had been equated for all purposes with the Lecturers in other subjects. Similar was the case of the Punjab Province. The counsel for the appellant pointed out that the

Committee constituted by the Provincial Government for the purpose of examining the issue was directed as under:-

(i) The committee was required to submit recommendations in respect of the issue for re-designation of the post of DPE as Lecturer in Physical Education and to merge them in the cadre of Lecturer, by amending the relevant rules. The implications involved in the proposed amendments would be worked out for perusal and orders of the competent authority.

(ii) The committee was authorized to co-opt the president Sarhad All Colleges Teachers Association and President DPEs Association NWFP as and when required in order to facilitate their work. The committee was required to submit its report to the Provincial Government within one month.

11. The learned counsel for the appellant also stated that the Committee constituted a sub-committee comprising the representatives/Deputy Secretaries of the Higher Education Department, Establishment Department, Finance Department, and the Inspector Physical Education, Directorate of Higher Education NWFP, Peshawar. It was further stated by the learned counsel for the appellant that it was after the deliberation of the committee and the sub-committee that the final recommendations were made in the shape of the summary to the Worthy Authority/Chief Minister, who approved the same. But the Secretary Finance had subsequently inserted a note in para-10 of the summary which was evidently after the approval of the proposal by the authority and the impugned notification was issued wrongly in line with the observations of the Secretary Finance which was irrelevant and was illegally inserted

under the approved proposal. The counsel for the appellant requested that the petitioner and respondents No. 4 to 31 may be allowed the benefits of the proposal made by the committee duly constituted and the proposal sanctioned by the worthy authority minus (-) the secretary Finance Note Para-10. He also requested for exclusion of Para-10 of the summary for aforesaid reasons. Regarding the status of the government decision, it was stated by the learned counsel for the appellant that a decision whether administrative or policy, had to be in line with the fundamental rights granted under constitution of 1973 of Islamic Republic of Pakistan, and not in violation of those rights. The learned counsel for the appellant stated that in the instant case, all other Lecturers had the qualification of M.A/M.Sc. in their respective subjects. In the same manner the DPEs had the qualification of M.A/M.Sc and they also taught the subject both to the Intermediate as well as the Graduate Classes. Therefore, they were entitled to the same benefit of service allowed to the Lecturers/Teachers in other subjects. Regarding the discrimination and the policy against the fundamental principles noted above, the Supreme Court of Pakistan had held in "1993-SCMR- 1287 that in the event of any discrepancy or violation of a fundamental right, such a decision of the government could be set aside by the Service Tribunals in an appropriate case. The learned counsel for the appellant added that the status of Lecturer of a college with all the benefits of service due had also been granted to the DPEs/Lecturers in Physical Education in the Province of Baluchistan, Punjab and AJ&K in addition to the Federal Government of Pakistan. It would be equitable and just that the government of NWFP should allow identical service benefits to the DPEs/Lecturers in Physical Education possessing the minimum qualification of M.A/M.Sc. He requested for acceptance of the appeal.

12. The learned counsel for private respondents No. 4 to 31 relied on the arguments advanced by the learned counsel for the appellant.

13. The learned AGP, on the other hand, argued that the appellant had been appointed as Director Physical Education (DPE) in BPS-16 with qualification less than that of Master Degree in the subject to supervise sports activities in the colleges, whereas appointments on the post of Lecturer (Teaching Cadre) in the college sector were made in Basic Pay Scale-17 with qualification of Master Degree. The learned A.G.P further argued that since the Hon'ble Peshawar High Court, Peshawar had not accepted the petition so the appellant alongwith the respondents approached the august Supreme Court of Pakistan against the judgment of Peshawar High Court and the apex court also did not set aside the judgment but maintained it. Even then the Chief Minister constituted a high level committee, comprising Secretary Higher Education, Secretary Establishment Department, Secretary Finance Department Director Higher Education NWFP, President College Teachers Association and President of DPEs (whenever required) so as to examine the proposed service structure. As far as service structures given to the DPEs in Punjab, Baluchistan provinces, State of AJ&K and Federal Government were concerned, every federating unit/state of AJ&K had to consider such things within its financial limits and resources. In spite of the facts that our province had limited financial resources even then it followed Government of Sindh to frame service structure for DPEs of the province. The Provincial Government of NWFP framed the present service structure for DPEs viewing all its aspects and the resources. No discriminatory treatment had taken place with the appellant. Hence his plea in this regard was incorrect. Giving service structure to a cadre was a policy decision and policy making power of the Government fell outside the jurisdiction of this Tribunal. It was also argued by the AGP that there was no change

by any authority in the approved summary. He requested for dismissal of the appeal.

14. The Tribunal heard both the parties and perused the available record. From perusal of the record, it transpires that there is no denial of the fact that the DPEs teach Physical Education as a subject to the intermediate and degree classes in the Higher Secondary Schools/Colleges. The respondent department is also not in a position to state that they have framed a better service structure for the DPEs than the ones framed by the Governments of Punjab, Baluchistan, AJ&K and the Federal Government. It is certain that majority of the DPEs possessing M.A/M.Sc. in the country are enjoying most favourable service structure whereas the DPEs equally qualified in our province do not enjoy the same status and terms & conditions of service. The respondent department has followed the Government of Sindh where less favourable service structure has been approved. Most of the DPEs under the administrative control of the respondent department are M.A/M.Sc. in the Physical Education and hence are as good as qualified as the Lecturers of other subjects in the Higher Secondary Schools/Colleges. The appellant and private respondents No. 4 to 31 have been selected/appointed by the same authority which selected/appointed Lecturers of the other subjects. Therefore, the aforementioned appellant and private respondents deserve to be treated at par with the Lecturers of other subjects in the Higher Secondary Schools/Colleges.

15. In view of the aforementioned discussion, the Tribunal remands the case back to the respondent department with the direction to consider the framing of service structure for the DPEs holding M.A/M.Sc. Degrees, on the analogy/pattern of either of the Governments of Punjab, Baluchistan, AJ&K and Federal Government within two months of the receipt of this judgment. The Tribunal

further directs that the inter-se seniority of the appellant and the privates respondents with the Lecturers of other subjects should also be fixed on the analogy/pattern of the same government whose service structure is followed/adopted.

16. This single judgment will also dispose of the service appeal No. 894/2005, titled as " Roghan Shah Versus Director, Higher Education, NWFP, Peshawar etc." in the terms that the impugned seniority of the parties be settled on the analogy of the seniority settled in similar cases in other Governments i.e. Punjab, Baluchistan, AJ&K and Federal Government within a period of two months of the receipt of this judgment.

17. No order as to costs. File be consigned to the record.

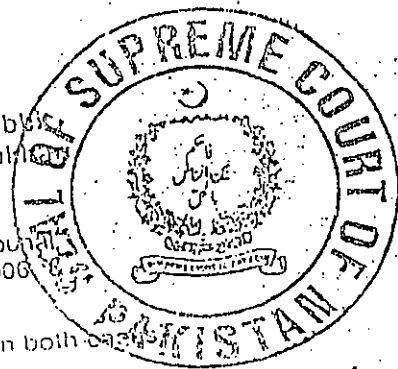


