RESPECTFULLY SUBMITTED:

The written reply on behalf of above mentioned respondents is as under:

PRELIMINARY OBJECTIONS:

1. That the appeal in hand is non maintainable in its present form and under the present circumstances of the instant case.
2. That the appellant has concealed material facts from this Honourable Tribunal and has thus not come to the court with clean hands,
3. That the appellant has estopped by his own conduct to file the instant appeal.

4. That the impugned notification dated 18/08/2010, wherefrom the appellant feels himself aggrieved has never challenged by him before at any forum within due time thus at this belated stage the same cannot be challenged. The appeal in hand is badly time barred.
5. That the impugned seniority list has been issued well in accordance with the law, Rule and Regulations and cannot be interfered with.
6. That the seniority is always reckoned from the date of appointment / promotion in service/ cadre. Since the replying respondents were appointed as lecturers much prior from the date of absorption/ up gradation/ promotion of the appellant in BPS-17 and their absorption in the cadre of lecturers.
7. That the notification dated 18/08/2010, has rightly stipulated the conditions of placing the appellant at the bottom of seniority list, since the notification was not challenged at any forum therefore it has attained finality.
8. That this honorable tribunal has got no jurisdiction to entertain and adjudicate upon the matter.
9. That the departmental appeal as well as the instant appeal of appellant is badly time barred.
10. That after issuance of Notification dated 18/08/2010 the appellant alongwith other DPEs were benefited and were absorbed in the Lecturer Cadre with condition of placing them at the bottom of seniority list. The condition was never challenged by them meaning thereby they agreed with the same, thus they are estopped by their

conduct to raise any objection to the said notification at this belated stage.

**ON FACTS:**

1. Contents need no reply, however the replying respondents were appointed much prior to the induction / absorption of appellant in the cadre of lecturer.
2. Contents being related to court record hence need no comments; however the impugned seniority list and the notification were issued well in accordance with directions issued in the judgment.
3. Contents incorrect and misleading to the extent of delaying the matter soon after the decision of the august supreme court of Pakistan dated 30/03/2009. The matter was considered and notification dated 18/08/2010 was issued , however any delay on the part of official respondents / government cannot affect the rights of the private respondents who were appointed in the cadre of lecturers much prior to the induction / obserption of appellant in the said cadre, besides this, the condition of placing the appellant in the bottom of the seniority list also well in accordance with the pattern of the Federal Government and other Provincial Governments. The Honourable Services Tribunal of the has also directed for framing of service structure for DPEs on the analogy/pattern of Federal Govt: or any other Provincial Govt.
4. Contents incorrect and misleading the impugned seniority list has been issued well in accordance with section.8 Civil Servant Rules 1973 and the rules made there under. The appellant has rightly been placed junior to the private respondents/replying rasp. Moreover

placing them at the bottom of the seniority list was also the condition mentioned in the notification dated 18/8/2010. Which was never challenged before. Hence on this score alone the instant appeal is not maintainable and is devoid of any substance or merit.

5. Contents incorrect and misleading. The departmental appeal is subject to proof. Moreover the departmental appeal attached with the instant appeal is also ambiguous as it does not disclose any prayer, besides this the Notification dated 18.8.2010 has also not been challenged neither in the departmental appeal attached nor at any stage before the instant appeal.

**ON GROUNDS:**

- A. Contents incorrect and misleading. The appellants have been treated in accordance with the law, rules and policy without there being any violation of their rights. The seniority list is well reasoned and justifiable, hence cannot be interfered with.
- B. Contents incorrect. Every provincial government has its own rules regulations and is empowered to frame rules/provide service structure for its own employees keeping in view its own resources. The honorable Tribunal in its judgment very clearly directed to consider case of the appellants on the pattern of the other provinces/federal government.
- C. Contents incorrect and misleading .The impugned notification was issued after the disposal of appeal by the august supreme court of Pakistan. Moreover, delay, if any, happened for any reason cannot be made ground to affect the vested rights of the replying

respondents who were appointed much prior to the appellants in the cadre of the lecturers.

**D. Contents incorrect.** Admittedly all the replying respondents had been appointed as Lecturer much prior to the induction / re-designation / absorption of the appellant in the cadre of lecturers. Hence the impugned seniority list is well in accordance with the Law, Rules and Regulations.

**E. Contents incorrect and misleading.** The seniority list is issued well in accordance with the sec.8 of the civil servants act 1973 and the appellants has rightly been placed at the bottom of the seniority list as per the absorption Notification dated 18.8.2010.

**F. Contents incorrect and misleading .**the notification is well in accordance with the law, rules and regulations and cannot be interfered with.

**G. The replying respondents also seek permission to rely on additional grounds at the time of arguments.**





**ON FACTS:**





2. That this Hon'ble Tribunal has passed an order on 01.09.2016 (*Annex:-A*) issued an injunctive order directing that Lecturers appointed after Notification dated 18.08.2010 through the process of initial recruitment as well as promotion should not be considered for promotion in preference to the appellant and similarly placed employees;
3. That after the order appellant and others submitted a joint application on 22.11.2016 to Respondent No.1 for obeying the lawful order of the Hon'ble Tribunal but inspite of the same, Respondents not only took up the cases of all those employees appointed after 18.08.2010 but also processed the same and recommended them by the PSB and issued Notification dated 23.05.2017 (*Annex:-B*).
4. That the conduct of Respondents No.1&2 clearly and squarely falls within the ambit of contempt of the lawful order passed by the

Hon'ble Tribunal, therefore, they are liable to be proceeded against for their contumacious and for punishment according to law.

It is, therefore, humbly prayed that on acceptance of this application, appropriate proceedings for the contempt of the order of the Hon'ble Tribunal may graciously be initiated against Respondents No.1 & 2 and they be punished accordingly and be also directed to withdraw the unlawful recommendations and Notification dated 23.05.2017, be denotified in the interest of justice.

Learned counsel for the appellant has submitted that on the strength of judgment of this Tribunal dated 30.4.2007 in Service appeal No. 148/2006 service structure of DPEs was ordered in line with other provinces whereagainst appeal of the respondent department was disposed of by the August Supreme Court of Pakistan vide judgment dated 30.3.2009. That on the strength of the judgment of this Tribunal, the appellant was entitled to induction in the seniority list referred to above in accordance with rules in vogue but the matter was unreasonably delayed, and, finally, the seniority list was issued on 07.8.2015 thus placing the appellant and similarly placed employees at the bottom of the seniority list in violation of the spirit of the judgment of this Tribunal. Learned counsel for the appellant seeks restraint order to debar the official respondents from promotion of the private respondents to BPS-18 in violation of the judgment of this Tribunal.

Learned Senior Government Pleader and learned counsel for private respondents seeks adjournment.

Since the learned counsel for private respondents are seeking adjournment as such the appeal is adjourned for written statement/ comments by the respondents to 13.10.2016. Meanwhile it is directed that

Lecturer appointed after notification dated 18.08.2010 through the process of initial recruitment as well as promotion shall not be considered for promotion in preference to appellant and similarly placed employees.
