- f. That repeated transfers were highly condemned by the apex Court. The impugned transfer order is not in the interest of public service but in the interest of the said Naib Tehsildar, R.No.3.
- g. That the impugned order is based on favoritism and malafide.

It is, therefore, most humbly prayed that on acceptance of the appeal, the impugned office order dated 16.07.2013 of respondent No. 1 be setaside and order dated 17.04.2013 be restored with all service benefits.


