RESPECTED SHEWETH:

Joint para-wise comments on behalf of Respondent No. 1-6 is narrated as below.

PRELIMINARY OBJECTIONS:

- 1. That the appellant has no locus standi to file the instant appeal.
- 2. In order to prevent the corrupt practices/corruption the posting/transfers are being done in the best public interest as deemed appropriate at any time.
- 3. That the appellant has no cause of action and no locus standi to file the instant appeal.
- 4. That the appellant does not come to the tribunal with clean hands and has suppressed all relevant facts.
- 5. That the appeal has been mis-oriented, mis-constructed and mistakenly drawn in its present frame and context & is liable for rejection.
- 6. That the appeal is weak having no force, fabricated and factitious based on ill will modified and having no footing in the eyes of Laws.

PARA WISE REPLY TO THE APPEAL:

- 1. The applicant is serving as Naib Tehsildar in DIKhan Division however his superannuation retirement is on 20.01.2025.
- 2. Incorrect.
- 3. The re-shuffling of Tehsildar/Naib Tehsildar was made vide order No. 4400/Estt; dated 17.08.2023 not only to the extent of appellant but the Tehsildars whose services were placed by the Board of Revenue and kept under waiting for posting has been posted on the vacant seats, resultantly the appellant was kept under waiting for posting. But later on vide this office order No. 4856/Estt; dated 01.09.2023 was posted as Naib Tehsildar Paharpur by reverting the
- incumbent who was working on OPS basis.
- 4. As discussed above.
- 5. The matter pertains to Director Lands Record Khyber Pakhtunkhwa.
- The internal transfer at District level is made on the basis of Revenue experience and for the best public interest. The appellant being a experienced hand was posted vide office order No. 5300-19/Estt; dated 28.09.2023 as NT Consolidation to complete the Consolidation work at the earliest.
- 7. This is the prerogative of the Competent authority either to accept or filed any service appeal hence para is misconstrued.
- 8. No comments.

GROUNDS:

- 1. Incorrect: as discussed under para 7 the respondent No. 04 being a competent authority of the appellant has prerogative to dispose of service appeal hence the contention of appellant have no locus standi.
- 2. Incorrect: The Civil servant as provided under Civil Service Act 1973 can be posted by the competent authority for performance of his official duty. The appellant was rightly transferred/posted.
- 3. Incorrect: no comments as a policy matter.
- 4. Incorrect: The appellant superannuation retirement according to his date of birth is 20.01.2025 hence the contention of appellant is incorrect.
- 5. The matter pertains to Director Land Records Khyber Pakhtunkhwa.
- 6. Incorrect.
- 7. Incorrect, the posting/transfer was made in the best public interest.
- 8. Being a court matter no comments.
- 9. The posting/transfer and observance of tenure policy is followed, however under special circumstances when Tehsildars/Naib Tehsildars are recruited through Public Service Commission and their services were placed at the disposal of Commissioner DIKhan Division for further posting has been posted against the post of Tehsildar/Naib Tehsildar, resultantly all the incumbents who were working on OPS basis against various positions were reverted back to their original position, hence the matter of policy violation and content of the applicant are baseless.

Therefore, it is requested that the appeal of the appellant may please be dismissed with cost throughout.
