

PRAYER IN APPEAL:

On acceptance of the instant appeal, date of birth of appellant in
service book may kindly be corrected according to medical certificate
as well as CNIC record.

Any other remedy which deems proper, efficacious and just may

of the instant petition and is entitled to all the privilege under the existing law.

- 2) That the appellant was initially appointed as constable on 02/01/1984 plus usual allowances against the vacant post in the office of respondent No.3 (copy of appointment order is annexure A while copy of service book is annexure B)
- 3) That the appellant was born in 1966 and on the basis of his said date of birth got government employment, as such the correct date of birth of the appellant is truly and correctly shown and incorporated in appellant's CNIC. (Copy of CNIC is annexure C and Medical Certificate and relevant documents are annexure D).
- 4) That after appointment the respondents inadvertently/wrongly and incorrectly incorporated in service roll as 02/01/1964 of first page while in the long roll is 1965 of his service book instead of 1966 in service book of the appellant, as such the same is based on none and the same should be corrected and recorded as per appellant's NADRA as well as record of Medical Certificate.
- 5) That there is a one post of MTO vacated in the whole District Shangla and as per rules and regulation the petitioner is going to be promoted on the said post, therefore, the respondents intentionally made a collusion with the one constable namely Rozi Mand to be promoted on the said post, therefore, the respondents made cutting and overwriting in the service of petitioner for the purpose to deprive the petitioner for his legal rights.

- 6) That the said illegal and wrong act on part of the respondents would obviously prejudice the appellant in his service career as well as the appellant will suffer difficulties, inconvenience and irreparable loss, however, approached to the worthy respondent No.3 by filing application and requested therein, that he wanted to meet him to the purpose of correction of his date of birth, but the worthy official did not give any time for meeting despite several applications. (copies of applications/ appeals are annexure E)
- 7) That the appellant as above-mentioned facts and circumstances, has left with no option except to file the instant appeal before this Hon'ble Court on the following amongst other grounds.
- 8) That cause of action arose when the appellant made photocopies of his service book.
- 9) That the petitioner got knowledge when the respondents called him by informing that the petitioner will be retired on 01/01/2024.

GROUNDS

- i. That the acts, commissions and omissions of respondents (hereinafter impugned) are patently illegal, un-lawful, of no legal effect, hence, liable to be corrected by directing them to entertain the said applications for correction of date of birth.
- ii. That the respondents inadvertently/wrongly and incorrectly incorporated two dates of birth of appellant as 02/01/1964 and 1965 in the service book of appellant,

instead of 1966 and subsequently refusal of meeting for its correction is illegal, unlawful and against the norms of justice.

- iii. That according to the rules and policy and in the light of judgment of Honorable Apex Court the Respondents are legally and morally bound to correct the date of birth of the appellant as 1966.
- iv. That the appellant was not treated as per law and the precedent laid down by the August Supreme Court of Pakistan from time to time.
- v. That the impugned inaction of the respondents' authorities by not correcting the date of birth of appellant is not only against law and facts but also contrary to the well-established principles of justice, equity and good conscience.
- vi. That the appellant performing his duties honestly, zealously of his efficiency with all most satisfaction of his superior, and there is no single complaint against him in any manners, two different dates of birth in service book are against the law and facts, inoperative qua his rights and as such, is liable to be corrected.
- vii. That failure of the respondents to correct the same after being approached in this behalf, gave rise to necessary cause of action to institute the instant appeal.

viii. Those further grounds, with leave of this Honorable Court, would be raised at the time of arguments before this Honorable Court.

PRAYER

It is therefore, most humbly prayed that on acceptance of the instant appeal, date of birth of appellant in service book be corrected according to CNIC & Medical Certificate.

Any other remedy which deems proper, efficacious and just may kindly be granted in favor of appellant under the inherent powers of this tribunal
