



**PRAYER:-**

ON ACCEPTING OF THIS APPEAL IMPUGNED ORDER NO. DP/F&A08/10063-20 DATED 08/08/2023 KINDLY BE SET ASIDE AND THE RESPONDENTS MAY GRACIOUSLY BE DIRECTED TO RESTORE THE REGULAR SERVICE OF THE APPELLANT AS AN ASSISTANT WITH ALL BACK BENEFITS IN THE INTEREST OF JUSTICE.

*Respectfully Sheweth,*

1. That the appellant was appointed as a Junior Clerk in C&W department on 12/03/1995 as and continued on his post and performed his duties honestly and devotedly.
2. That thereafter appellant was adjusted in BPS-7 in K.P.K Law, parliamentary affair and human rights department vide order No. SLT(LD-15(1):96, dated 21.07.2003.

3. That during the year 2016 the respondents promoted the appellant's junior from the post of junior clerk BPS-9 to post of senior clerk BPS-14 and appellant was not given the promotion only on the basis of a baseless inquiry and after concluding of inquires, appellant was granted promotion with immediate effect instead of from the date when his colleagues were promoted.
  
4. That the appellant filed appeal No. 924/18 Before This Honourable Tribunal regarding granting of promotion w.e.f. 8-1-16 which was accepted by this Hon'ble Tribunal vide judgment dated 17.02.2021 and on acceptance of appeal respondent granted promotion to appellant w.e.f. 8-01-16. **(Copy of judgment and order are annexed as Annexure "A" & "B")**
  
5. That subsequently the respondent after approval of DPC having of prescribed qualification eligibility and fitness granted the promotion to appellate against existing vacant post of

assistant on regular bases vide order No.952-75 dated 11-02-2019. *Copy of order Annexed as Annexure 'C'*

6. That the appellant after promotion against the post of Assistant B.P.S 16 continuously performed his duty against the said post to the satisfaction of his superior officer and no any complaint against the appellant.

7. That the respondent issued final seniority list of assistant B.P.S 16 in years 2021-22 in which the name of appellant mentioned at serial No.20 & 22 as a regular employee. **(Copy of seniority list is annexed as Annexure "D" & "E")**

8. That respondents No.1 & 2 issue impugned order on ~~03~~ 08-08-2023 and final seniority list of Assistant in years 2023 under which regular service of the appellant converted to acting charge bases, which is illegal against the law discriminatory thus not sustainable under the law. **(Copy of impugned order dated**

08.08.2023 and final seniority list years 2023  
are annexed as Annexure "F" & "G")

9. That the appellant has filed a departmental appeal against impugned order dated 08.08.2023 and the final seniority list year 2023 but no response has been given by the respondents, hence this appeal inter-alia on the following grounds amongst others. (Copy of Departmental appeal is annexed as Annexure "G")

**GROUND:-**

- a. That after the appellant was regularly promoted in B.P.S 16 he performed his duty according to the satisfaction of his superior officer, therefore promotion order has been implemented and the appellant has acquired vested rights based on the order, now the respondent have no power under the law to change / convert the regular service of the appellant's to acting charge base thus the

impugned order is void illegal contrary to law, rules and natural justice, hence not sustainable.

b. That the impugned order dated 03.08.2023 and final seniority list year 2023 issued by the respondent on the bases of malafide and in violation of Article 4 and 25 of the Constitution, hence not sustainable.

c. That the persons who was promoted alongwith the appellant in the post of assistant B.P.S 16 on 11.02.2019 and his qualification is matric the respondent not only kept its regular service, but also proposal for promotion in B.P.S 17 was also given. And the regular service of the appellate converted into acting charge bases thus the action of respondents based on discrimination.


d. That the instant Service appeal is well within time.



e. That the other points shall be urged at the time of arguments.


**PRAYER**





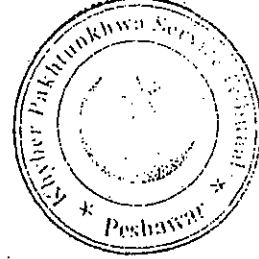

Affairs & Human Rights Department on 21.07.2013. Those Junior Clerks who were junior to the appellant were promoted from BPS-11 to BPS-14 during the year 2016 but appellant was not promoted on the pretext that an inquiry was pending against him whereas the said inquiry was decided in his favor. Respondents No.3 to 7 who were junior to appellant were promoted as Senior Clerk in the year 2016 whereas appellant was promoted on 03.01.2018 but with immediate effect. He then filed a departmental appeal but the same was not responded to, hence, the instant service appeal.

2. Learned counsel for appellant argued that the promotion order of the appellant issued with immediate effect is discriminatory and that justice demands that the appellant may be treated in accordance with law from the date when his juniors were promoted.

3. Conversely, learned A.A.G submitted that a meeting of Departmental Promotion Committee was convened on 29.01.2016 for the purpose of promotion of Junior Clerks to the posts of Senior Clerks and that the name of appellant was also included in the working paper however, he was deferred due to pending inquiry against him and after exoneration from the inquiry, appellant was promoted and that question of superseding the appellant by the junior colleagues does not arise and lastly, he submitted that no discrimination to the appellant was committed rather he was promoted in accordance with law and rules. He, therefore, requested for dismissal of the instant appeal.

4. Record reveals that meeting of departmental selection committee was convened for the purpose of promotion of Junior Clerks ( BPS-11) to the post of Senior Clerk (BPS-14) and the name of the appellant was also

included in the working paper, the committee however deferred his case due to a pending inquiry against him. The appellant after exoneration from the charges, was promoted to the post of Senior Clerk(BPS-14), but with immediate effect and his name was also placed in his due place in the seniority list, whereas the appellant is seeking relief to the effect that his promotion shall be made effective from the date, when his juniors were promoted, as he was deferred and not superseded. The learned attorney when confronted with the proposition conceded to the fact that he was deferred for an inquiry pending against him and after his exoneration, respondents were required to effect his promotion from the date i.e. 08-01-2016 when his other colleagues were promoted.
