

**Prayer:**

It is, therefore, earnestly prayed to allow this service appeal with directions to the official respondents to place the appellant at serial No.47 instead of 66 in the final seniority list and also promote him w.e.f. 21.06.2023 from Arabic Teacher BPS-15 to Senior Arabic Teacher BPS-16 with all consequential back benefits.

Any other relief which this Hon'ble Tribunal deems appropriate in the circumstances of this service appeal and to whom the appellant found entitled may kindly also be granted.

***Respectfully Sheweth;***

Brief facts giving rise to the instant appeal are as under:-

- 1) That the appellant submitted objection petition dated 10.07.2023 to the District Education Officer (male) Bannu against the

tentative seniority list of Arabic Teachers but the same has not been decided. It is pertinent to mention that the tentative seniority list was not properly circulated to invite the objections of the aggrieved and the same was obtained by the appellant on 08.07.2023 and thereafter filed the objections.

(Copy of objection viz-a-viz tentative seniority list is Annex: "A" while the tentative seniority list is Annex: "B").

- 2) That the appellant was appointed as constable vide order dated 09.06.2007 in police department.

(Copy of order dated 09.06.2007 is Annex: "C").

- 2) That vide order dated 22.05.2014 the appellant was appointed as Arabic Teacher in BPS-15 on contract basis in teacher cadre.

(Copy of order 22.05.2014 is Annex: "D").

- 3) That the appellant assumed charge on 22.05.2014 as Arabic Teacher BPS-15 at Govt. Middle School Adnan Sardi Khel Bannu.

(Copy of charge report is Annex "E").

- 4) That Headmaster GMS, Adnan Sardi Khel submitted the case of appellant to the office of District Education Officer (Male) Bannu for regularization and claiming regular GP fund instead of CP fund.

(Copy of letter dated 03.06.2014 is Annex: "F").

- 5) That vide order dated 09.09.2014 the appellant was regularized on AT Post (BPS-15) and pay protection was also granted on account of previous service as constable who applied through

proper channel vide S.P. Investigation order Endst: No.1219 dated 27.05.2014.

(Copy of order dated 09.09.2014 is Annex" "G").

- 6) That vide order dated 31.05.2019 passed by District Education Officer (Male) Bannu wherein sanction was accorded for pay protection in respect of the appellant and also given him the benefit of previous regular service rendered in police department as Constable w.e.f 09.06.2007 under FR 22-B hence entitle to all service benefits as a regular employee, which includes the issue of seniority as well.

(Copy of order dated 31.05.2009 is Annexure "H").

- 7) That tentative seniority list was published without properly circulated the same to invite objections from Arabic Teachers (BPS-15) in which Irfan Ullah (serial No.47) M.Ismail Khan (serial No.48), Abdul Wahab (serial No.49), M.Younas Khan (serial NO.50), Tariq Ali Shah (serial No.51), M.Murtaza Khan (serial No.52), Hazrat Ullah (serial No.53), Syed Rehmat Ullah (serial No.54), Matiullah (serial No.55), Tariq Khan (serial No.56), M.Aslam Khan (serial No.57), Abdul Hafiz (serial No.58), Barkat Ullah Khan Qureshi (serial No.59), Obaid Ullah Shah (serial No.60), Abid Ullah Khan (serial No.61), Ulfat Qadir (serial No.62), Inam Ullah Khan (serial No.63), Hamid Ullah Khan (serial No.64) and Abdul Subhan (serial No.65) were shown senior than the appellant who has been placed at (serial No.66) wrongly and illegally.

- 8) That since the respondents failed to pass any order on the objections filed by the appellant viz-a-viz tentative seniority list as referred to in para-2 above, and the final seniority list was



circulated without communicating the same to the appellant, and further promoted private respondents No.4 to 22 from BPS-15 Arabic Teacher (AT) to BPS-16 Senior Arabic Teacher (SAT) vide impugned order dated 21.06.2023 against which he preferred departmental appeal dated 24.07.2023, but the same has not been responded even after lapse of statutory period of 90 days. Hence, the instant appeal, which is well within time.

(Copy of departmental appeal, final seniority list and order dated 21.06.2023 are Annex: "I, J" & "K" respectively.

- 9) That the appellant feeling aggrieved and dissatisfied with the inaction of the department in the matter of seniority of the appellant viz-a-viz seniority private respondents No.4 to 18, hence constrained to approach this Hon'ble Services Tribunal, for redressal of his grievance, on the following amongst other grounds:

Grounds of appeal:

- A) That it is pertinent to mention that the services of the appellant as Arabic Teacher were regularized with effect from 09.06.2007 by giving the benefit of previous regular service while the services of the above named respondents No.4 to 22 appearing at serial No.47 to serial No.65 were regularized on 21.03.2018 much later than the undersigned.

(Copy of regularization order dated 21.03.2018 of private respondents No.4 to 22 is Annex: "L")

- B) That the appellant is entitled to the pay protection and regularization under FR 22-B hence entitled all service benefits including seniority w.e.f. his initial date of appointment as constable in police department i.e. w.e.f. 09.06.2007.

- C) That inaction of the department speaks volume of malafide in the seniority matter viz-a-viz private respondents No.4 to 18.
- D) That the appellant keeping in view the previous regular service need to be placed above than the private respondents No.4 to 22 in the final seniority list, which needs correction in the light order dated 09.09.2014 passed by DEO (M) Bannu.
- E) That additional grounds will be raised at the time of arguments with the kind permission of this Hon'ble Tribunal.



# TERMS AND CONDITIONS

42

1. Their services shall be governed by the Khyber Pakhtunkhwa Civil Servants Act, 1973, the Khyber Pakhtunkhwa (Appointment, Deputation, Posting & Transfer of Teachers, Lecturers, Instructors & Doctors) Regulatory Act, 2011, and such rules and regulations as may be issued from time to time by the government.
2. Their services shall be considered regular and they shall be eligible for pension/deduction of GP fund in terms of the Khyber Pakhtunkhwa Civil Servants Act, 1973 as amended in 2013.
3. Their services are liable to termination on one month prior notice from either side. In case of resignation without notice, their one month pay/allowances shall be forfeited to the Government treasure.
4. They shall possess the same qualification and experience required for a regular post.
5. They shall have not resigned from their services or terminated from services on account of misconduct, inefficiency or any other ground before commencement of this ACT. The DDO concerned should ensure this condition before the drawal of their pay as regular servants.
6. Their regularization shall not affect the promotion quota of existing holders of posts in respective service cadres.
7. They shall rank junior to all other employees belonging to the same cadre who are in service on regular basis on the commencement of this Act and shall also rank junior to such other persons if any, who, in pursuance of the recommendation of the Khyber Pakhtunkhwa Public Service Commission made before the commencement of this ACT are to be appointed to the cadre, irrespective of their actual date of appointment.
8. Their seniority shall be determined on the basis of their continuous service in cadre, provided that if the date of continuous service in the case of two or more employees is the same, the employees older in age shall rank senior to the younger one.
9. Errors and omissions will be acceptable within the specified period.
