

**PRAYER:**

**ON ACCEPTANCE OF INSTANT APPEAL, THE  
IMPUGNED ORDERS OF RESPONDENT DATED  
10/12/2021 AND 16/01/2019 MAY KINDLY BE SET ASIDE  
AND DIRECTED TO PROMOTE THE APPELLANT SUB  
INSPECTOR TO INSPECTOR, EXCISE, TAXATION &/**

NARCOTICS CONTROL (INSPECTOR) FROM  
21/12/2017 WITH BACK BENEFITS.

**RESPECTFULLY SHEWETH;**

*The appellant submits as under;*

1. That Appellant serves the respondents department as Sub Inspector since 2012
2. That the Appellant is senior most in the seniority list and has become eligible for promotion from 2017.
3. That the Appellant submits departmental appeal before the respondents which was not responded with in the stipulated period hence the instant service appeal. *(Copy of Departmental Appeal is Annex "A")*.
4. That the Respondents / Government make rules for promotion on the basis of Departmental Examination vide notification No. 1136-46/Tax/KIX-C-140, dated 03/08/1950, which the Appellant passed two papers in the examination for promotion Sub Inspector to Inspector.
5. That service record of the Appellant is outstanding through his career and as per the Civil Servant Acts. (Seniority) Rules 1993 Appellant is senior most amongst Sub Inspector since 2012.
6. That Respondents / Government in pursuance of the Provisions contained in Rules 3(2) of the North West Frontier

Province Civil Servant (Appointment, Promotion and Transfer) Rules 1989 lay down a method for recruitment qualification and other conditions vide Notification No. SO9(Estt)E&T/1-41/2009, dated: 30/03/2010.

7. That the Appellant is serving as Sub Inspector since 2012 and has passed two papers in the examination for promotion, other the colleagues of the Appellant has been promoted from Sub Inspector to Inspector due to waiving of the condition of passing the said examination. *(Copy of the orders are Annex "B")*.
8. That since the Appellant was eligible and entitled to promote as Inspector according to the above mentioned rules and the same right has already been granted to the other Sub Inspectors in the Department.
9. That the Appellant has moved departmental appeal before the Competent Authority in his department but not responded yet and the Appellant is most senior in the Seniority List. *(Copy of Seniority List is Annex "C")*
10. That the Respondent No. 2 & 3 on the basis of malafide intention and contrary to the promotion rules of Sub Inspector to Inspector, which act of respondents is illegal and is against the law and amounts of refusal of application of Appellant for promotion.

11. That it is pertinent to mentioned here that even Section Officer Respondent No. 2 & 3 not clarify of the above mentioned fact and did not respond.
  12. That feeling aggrieved of the same, Appellant approaches this August Tribunal on the following grounds amongst the others.

**GROUND:**

- A. That act omission and inaction of the Respondents by ignoring the final Seniority List for promotion is against the law, rules, norms of natural justice and material on record, therefore, is not tenable in the eyes of law.
- B. That the examination rules of 1950 has set the eligibility of the Sub Inspector to Inspectors and the Secretary has discretion power to give relaxation for condition of passing examination, which was already entertained for other colleagues of the Appellant.
- C. That the Appellant has been discriminated for the promotion from Sub Inspector to Inspector, which is against the Article 25, of the constitution, 1973!
- D. That the Appellant has been kept deprived from his legal right of promotion from Sub Inspector to Inspector, which is against the law and facts and judgment of the Superior Courts.
- E. That the length of the serving of the Appellant is 35 – 36 Years in the Department and now the Appellant is going to be retired after 6 – 7 months.

I. That the Appellant seeks permission of this Hon'ble Tribunal to raise / argue additional points of law and facts at the time of arguments.

**PRAYER:**


*It is, therefore, most humbly prayed that on acceptance of instant appeal, the impugned orders of respondent dated 10/12/2021 and 16/01/2019 may kindly be set aside and directed to promote the appellant Sub Inspector To Inspector, Excise, Taxation &/ Narcotics Control (Inspector) from 21/12/2017 with back benefits.*

*Any other remedy, which this Hon'ble Court may deems fit in the circumstances may also be granted.*

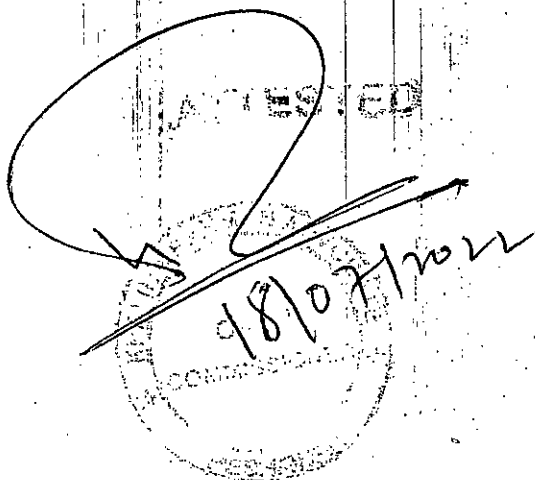




