



**Appeal u/s 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974 against the impugned office order bearing No. 5863 dated 16/10/2023 whereby departmental appeal/application of the appellant has been regretted (Copy annexed hereto marked A).**

**Prayer in Appeal:**

On acceptance of this appeal, the impugned office order bearing No. 5863 dated 16/10/2023 may kindly be set aside and the appellant's previous services may kindly be counted in his service and the pay of the appellant may kindly be refixed accordingly pay with all back benefits/financial benefits.

**Respectfully Sheweth:**

1. That the appellant joined the health department in the capacity of Computer Operator BPS-14 on 26/06/2012.
2. That the services of the appellant have been regularized through KP Employees of Health Department (Regularization of Services) Act 2017 (KP Act No. VII of 2017) on 30/06/2017 by the Provincial Assembly.
3. That vide notification bearing NO. SOG/Health/2-65/2017 dated 30/06/2017 the salary of the appellant has been fixed w.e.f 01/07/2017 and the previous services have not been counted with accumulation financial benefits accruing thereunder.
4. That the appellant, being aggrieved, filed departmental appeal/application for redressal of his grievance through diary No. 34147 dated 16/10/2023.
5. That it is pertinent to mention here that through Act No. 1 of 2018 passed by the KP Assembly the services

of SST Elementary and Secondary Education have been regulated from the date of initial appointment.

6. That vide impugned office order dated 16/10/2023, the departmental appeal/application of the appellant has been regretted.
7. That the appellant, feeling aggrieved, and having no other adequate remedy, invokes the appellate jurisdiction of this Hon'ble Tribunal, on the following grounds, inter alia:

### **G R O U N D S:**

- A. That the Government of KP through Act No. 1 of 2018 has regularized the services of SST in Elementary and Secondary education from the date of their initial appointment, but respondents/departmental despite clear cut direction of the Government, is not complying with the directions and thus the action of respondents/department is unlawful and violation of all the norms of justice.
- B. That it is also settled law, that notification, whereby monetary benefits is allowed to a civil servant the same is a right of the employee and can not be withdrawn but respondents/department is not fulfilling their duties by not including previous services of the appellant from the date of his initial appointment.

- C. That the constitution of the Islamic Republic of Pakistan, 1973 makes it clear that deviation from law has not to be countenanced; this is an assurance to the people of Pakistan that people in authority shall treat them in accordance with law and each one is bound by the stipulations of the constitution.
- D. That Article-4 of the constitution commands that all the citizens without any discrimination shall be dealt with in accordance with law, so enforcement of the law leaves no room for creating any distinction between the citizens.
- E. That it is the constitutional duty of each and every authority in Pakistan to exercise its power fairly, justly and transparently, which has not been done in the case of appellant and the appellant has not been treated in accordance with law, rules and regulations
- F. That the inclosure of previous services of the appellant is his rights and he is entitled for the same
- G. That any other ground, with leave of the Honorable Tribunal, will be raised at the time of hearing of the appeal and after recording of evidence, if any.

It is, therefore, most humbly prayed that on acceptance of this appeal, the previous services from the date of initial appointment of the appellant may

kindly be counted/included in the pay and services of the appellant with all back benefits.

Any other relief, which the appellant has not specifically asked for and the Honourable Tribunal deem appropriate, may also be granted in favour of the appellant.



**Terms and Conditions:**

1. The employees shall have held their posts validly till the commencement of this Act.
2. They shall possess the same qualification and experience as required for a regular post. Their pay shall be released subject to verification of academic documents/testimonials from the concern Board/University by the DEO concern.
3. Their services are regularized with effect from their initial appointment for the purpose of fixation of pay.
4. Their services shall be governed by the Khyber Pakhtunkhwa Civil Servant Act, 1973, the Khyber Pakhtunkhwa (Appointment, Deputation, Posting and Transfer of Teachers, Lecturer, Instructor and Doctors) Regularity Act, 2011 and such rules and regulations as may be issued from time to time by the Government.
5. They have not resigned from their services or terminated from their services on account of misconduct, in efficiency or any other ground, before the commencement of Act.
6. Their regularization shall not affect the promotion quota of existing holders of posts in respective service cadre.
7. They shall rank junior to all other employees belonging to the same Cadre, who are in service on regular basis on the commencement of this Act, and shall also junior to such other persons, if any, who, in pursuance of the recommendation of the Commission made before the commencement of this Act, are to be appointed to the Cadre, irrespective of their actual date of appointment.
8. The seniority inter-se of those employees, whose services are regularized under this Act within the Cadre, shall be determined on the basis of their continuous service in Cadre.

No. PA/Khyber Pakhtunkhwa/Bills/2017/10279.—The Khyber Pakhtunkhwa Employees of Health Department (Regularization of Services) Bill, 2017 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 2<sup>nd</sup> March, 2017 and assented to by the Governor of the Khyber Pakhtunkhwa on 9<sup>th</sup> March, 2017 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

**THE KHYBER PAKHTUNKHWA EMPLOYEES OF HEALTH DEPARTMENT  
(REGULARIZATION OF SERVICES) ACT, 2017**

**(KHYBER PAKHTUNKHWA ACT NO. VII OF 2017)**

*(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa, (Extraordinary), dated the 13<sup>th</sup> March, 2017).*

**AN  
ACT**

*to provide for the regularization of the services of employees appointed on adhoc or contract basis against civil posts and project posts in the Khyber Pakhtunkhwa.*

**PREAMBLE:- WHEREAS** it is expedient to provide for regularization of services of doctors, Drug Inspectors and other employees appointed on contract or adhoc basis in Health Department, Government of Khyber Pakhtunkhwa;

It is hereby enacted as follows:-

**1. Short title and commencement.**---(1) This Act may be called the Khyber Pakhtunkhwa employees of Health Department (Regularization of Services) Act, 2017.

(2) It shall come into force at once.

**2. Definitions.**--- (1) In this Act, unless the context otherwise requires,-

- (a) "Government" means the Government of Khyber Pakhtunkhwa;
- (b) "Commission" means the Khyber Pakhtunkhwa Public Service Commission;
- (c) "Department" means the Health Department of Government of Khyber Pakhtunkhwa;
- (d) "Departmental Selection Committee" means a Departmental Selection Committee constituted for making selection for initial appointment to posts in BPS-16 and below in the Department.
- (e) "Project" means:-
  - (i) Health Sector Reforms Unit (HSRU), Health Department;
  - (ii) Strengthening of Planning Cell, Health Department;
  - (iii) District Health Information System, Health Department;
  - (iv) Independent Monitoring Unit, Health Department, and;
  - (v) Strengthening of Rehabilitation of Service of Physically Disabled at Health Department, Khyber Pakhtunkhwa.
- (f) "employees" mean those duly qualified persons:-
  - (i) who were appointed as District Specialist, Medical Officers, Dental Surgeons and Drug Inspectors on adhoc or contract basis by the Government in the years 2015, 2016 and 2017 but otherwise than in accordance with the prescribed method of recruitment;
  - (ii) who were appointed in Saidu Medical College, Swat and Gajju Khan Medical College, Swabi on adhoc or contract basis by the Government in the years 2015, 2016 and 2017 but otherwise than in accordance with the prescribed method of recruitment;

(iii) who were appointed on adhoc or contract basis by the Government in Khalifa Gul Nawaz Teaching Hospital Bannu in the year. 2011 in the following cadres but otherwise than in accordance with the prescribed method of recruitment:-

- (a) Paramedics cadre;
- (b) Nursing cadre;
- (c) Computer operator;
- (d) Photographer;
- (e) Sub-Engineer, and;

(iv) who were appointed in the projects referred to in sub section (1) on adhoc or contract basis in accordance with project policy.

(g) "law or rules" means the law or rules for the time being in force governing the selection and appointment of civil servants;

(h) "posts" means a posts occupied by the employee and is required to be filled on the recommendation of Commission or Departmental Selection Committee.

(2) The expressions, "Adhoc appointment or Contract appointment" shall have the same meaning as respectively assigned to them in the Khyber Pakhtunkhwa Civil Servants Act, 1973 (Khyber Pakhtunkhwa Act No. XVIII of 1973).

**3. Regularization of services of employees.---** (1) Notwithstanding anything contained in any other law or rules, the employees appointed on contract or adhoc basis and holding the post till the commencement of this Act shall be deemed to have been validly appointed on regular basis from the day of the commencement of this Act.

Provided that;

(i) Where this Act affects the service promotion quota of any service cadre, such employee(s) shall be deemed to have been regularized against the post in the lower grade of such cadre prescribed under the rules for initial recruitment.

(ii) they have not resigned from their services or terminated from service on account of misconduct, inefficiency or any other ground before the commencement of this Act; and

(iii) the services of such employees shall be deemed to have been regularized only on the publication of their names in the Official Gazette.

**4. Determination of seniority,---** (1) The employees whose services are regularized under this Act or in the process of attaining services at the commencement of this Act shall rank junior

to all civil servants belonging to the same service or cadre, as the case may be, who are in service on regular basis on the commencement of this Act, and shall also rank junior to such other persons, if any, who, in pursuance of the recommendation of the Commission/ Departmental Selection Committee made before the commencement of this Act, are to be appointed to the respective service or cadre, irrespective of the actual date of appointment.

(2) The seniority inters of the employees, whose services are regularized under this Act within the same service or cadre, shall be determined on the basis of their continuous affiliation in such service or cadre;




Provided that if the date of continuous affiliation in the case of two or more employees is the same, the employee older in age shall rank senior to the younger one.

5. **Removal of difficulties.**--- If any difficulty arises in giving effect to any of the provision of this Act, the Department may give such direction as it may consider necessary for the removal of such difficulty.

6. **Overriding effect.**--- Notwithstanding anything to the contrary contained in any other law or rules, the provisions of this Act shall have an overriding effect and the provisions of any such law or rules to the extent of inconsistency to this Act shall cease to have effect.
