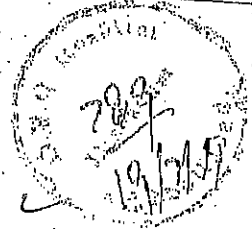

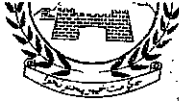

SUBJECT: ONE TIME UPGRADATION/PROMOTION OF RADIOLOGY & MCH.

I am directed to refer to the subject noted above and to state that the following observation may be clarified which is as under:-

- i. Seniority list of BPS-12 submitted by you indicates that the incumbents were up-graded/promoted to BPS-12 from BPS-09 on 20/01/2010, that the date after approval of paramedics service structure i.e. 10/05/2006. As the incumbents already promoted to BPS-12 as one time exercise as provided in para-5 of the notification dated 10/05/2006 and 14/05/2008.
- ii. As per para-8 (i) read with para-14 of the summary for Chief Minister, Khyber Pakhtunkhwa, the Health Department will prepare stage-wise/category-wise seniority list at the provincial level on the basis of para-4 of the notification dated 09/05/2006, reproduced as under;
"The Cabinet Decision regarding revised service structure for paramedics was arrived in its meeting held on 25/08/2006 while the District cadets have been established on 15/01/2002. Therefore any promotion/placement in senior grades of these paramedics can now only be carried out after District wise seniority lists are framed which negates the very purpose where paramedics with long years in service were supposed to be benefited. The following intervention is therefore required:-
 - (i) Back dating of Cabinet Decision of 25/08/2006 to before 15/01/2002.
 - (ii) Consideration of promotion cases of paramedics on seniority lists prior to 15/01/2002.
 - (iii) Giving these promotions effect from date before 15/01/2002 but without any arrears/increments.
- iii. The seniority list required for the one time exercise as per para-14(ii) of the approved summary, prior to 15/01/2002, while DGHS submitted seniority list of 2013 for one time up-gradation/promotion of left over two sub cadets of paramedics, which also appear defective and against the spirit of section-8 of Khyber Pakhtunkhwa Civil Servants Act 1973 and against the decision made by the competent authority in 2006 and 2009.

- iv. As other 14-paramedics sub cadets upgraded/promoted in August, 2012 with immediate effect without any arrears, Director General Health Services deviated from approved summary 13/01/2009 i.e. instead of providing seniority list prior to 15/01/2002; the incumbents were upgraded/promoted on seniority list of 2012. Which directly affect the incumbents who retired or died in service prior to 2012 and after the approval of new service structure i.e. 10/05/2006.
- v. Before filling all remaining posts of paramedics in BPS-17 from amongst BPS-12 and BPS-14 employees, we may first ensure that all BPS-16 employees of all sub cadets serving as such prior to 10/05/2006 have been granted at least one time Upgradation/promotion as per the decision taken repeatedly.



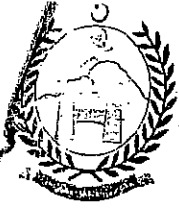

- 1) In the service rules of paramedics, the mandatory requirements for appointment of X-Ray Technicians and radiographers [REDACTED] before the restructuring of paramedics in 2006, while their scales were 9 & 6 respectively. (Copy of service rules are attached as (Annex- A)). This was unjust and discriminatory.
- 2) The Finance Department Government of NWFP vide Scheme of Basic Pay and Fringe Benefits of Provincial Civil Servants, 1983 through Circular No. FD (SR-I) 1-67/82 Dated 24th Aug 1983 had revised the scale of different Cadres of civil servants including Paramedics of Health Department in which X-Ray Technicians and Radiographers were not included, which was an anomaly with the radiographers. (Circular attached as (Annex: AII)).
- 3) The same anomaly of scales of Radiographers and X-Ray Technicians was existing in the Federal Government Health system as well. The Ministry of Health, Special Education and Social welfare (Health Division) Government of Pakistan in its letter dated 6th March 1988 (copy attached as (Annex: B)) removed the anomaly in scales of X-Ray Technicians and Radiographers and granted BS-9 to both the cadres. The letter was communicated to Accountant General Peshawar besides others. The said rectification was required to be implemented by the Health Department Khyber Pakhtunkhwa [REDACTED] implemented. However the Administrator of Khyber Teaching Hospital (the then Hayat Shaheed Teaching Hospital) Peshawar, vide letter No.




22745/HSTH/E dated 15-11-94 requested Secretary Health, Govt. of NWFP(KPK) Peshawar to amalgamate the posts of X-Ray Technicians and Radiographers in the same scale (BS-09) on the analogy of Federal Government letter. (Copy attached As (Annex- C).

- 4) The Health Department took up the matter with Finance Department vide No SO (H)III/7-317/94 dated 15.1.1995. In response Finance Department KP raised some observations/queries in its letter addressed to SO III Health Department Dated 15-02-1995 (Copy attached as (Annex-D). Record of further progress in the case is not available with us.
- 5) After restructuring of Paramedics in 2006, Radiographers and X-Ray Technicians were given the same scale (BS-9), however Radiographers were placed at the bottom in the seniority list of CT Radiology even those radiographers who were appointed much earlier than the X-ray Technicians.
- 6) Feel aggrieved, some of the Radiographers filed a Writ Petition in Peshawar High Court for redressal of their grievances. The Honorable Peshawar High Court directed the Health Department to reckon the seniority from dates of their initial appointment. Consequently Health Department, vide letter No. SOH (Lit-I) 12-1139/2012 Dated 18 Jan 2012, directed the Director General Health Services KP to implement the court judgment in future when preparing working papers for seniority lists for up gradation.(Copy attached as (Annex-F).
- 7) In para ii, sub para ii of Health Department Letter No. SOH-III/8-60/2013(Radiology & MCH) dated 3rd May 2013, addressed to DG Health KP, envisaged consideration of promotion cases of paramedics on seniority list prior to 15-01-2002, but Radiographers have been unlawfully and illegally deprived of the same.(Copy attached as Annex-H).
- 8) The seniority of civil servants, as per rules, shall be reckoned from dates of initial appointment.(Copy of Rules attached as Annex- I)
- 9) The Government may rectify its uncertain wrong done to civil servants and there is no limitation or bar upon government as per ruling of Govt of NWFP (KPK) Law Department (Copy attached as Annex -J).
- 10) Forgoing view and in the best interest of justice, the Notification of 1988 is required to be implemented upon Radiographers and we may kindly be placed in BPS-09 from our respective date of initial appointments.)
Grievances of the appellants are submitted for kind consideration.

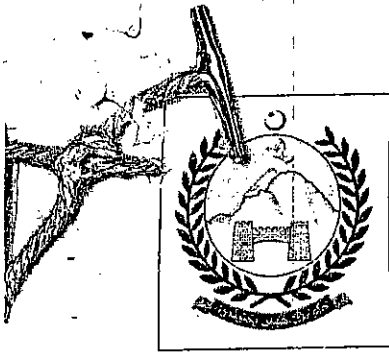





**THE ¹KHYBER PAKHTUNKHWA CIVIL SERVANTS
(APPOINTMENT, PROMOTION & TRANSFER) RULES, 1989**

PART-I

GENERAL

1. **Short title and commencement:** - (1) These rules may be called the ²{Khyber Pakhtunkhwa] Civil Servants (Appointment, Promotion and Transfer) Rules, 1989.

(2) They shall come into force at once.

2. **Definitions:-**(1) In these rules, unless the context otherwise requires:-

(a) "Appointing Authority" in relation to a post, means the persons authorized under rule 4 to make appointment to that post;

(b) "Basic Pay Scale" means the Basic Pay Scale for the time being sanctioned by Government, in which a post or a group of posts is placed;

(c) "Commission" means the ³[Khyber Pakhtunkhwa] Public Service Commission;

⁴(d) "Departmental Promotion Committee" means a committee constituted for making selection for promotion or transfer to such posts under a Department, or offices of Government, which do not fall within the purview of the Provincial Selection Board;

⁵(dd) "Departmental Selection Board" means a Board constituted for the purpose of making selection for initial recruitment /appointment to posts under a Department or office of Government in Basic Pay Scale 17 not falling within the purview of the Commission:

Provided that more than one such committees may be constituted for civil servants holding different scales of pay".

(e) "Departmental Selection Committee" means a committee constituted for the purpose of making selection for initial appointment to posts under a department, or office of Government [in Basic Pay Scale 17 and below not falling within the purview of the Commission];

(f) "Post" means a post sanctioned in connection with the affairs of the Province, but not allocated to all Pakistan Unified Grades ; and

With humbly request it is stated that we are the Radiographer of Health Department and would like to present the following few points for your kind consideration please:-

C.S.O to C.S.
Govt. of Khyber Pakh

- i) That we were appointed as Radiographer in BS-6 in 1986.
- ii) On 1.3.1988, Ministry of Health Govt. of Pakistan Islamabad vide Circular No. F.4-78/85-HF-II had granted BS-9 to X-Ray Tech. & Radiographers in Federal Government (copy enclosed).
- iii) However, this Provincial Government did not implement the said facility in this Provincial Government, but Health Department appointed following X-Ray Tech. in BS-9, on the analogy of Federal Govt. policy by ignoring the fact that Finance Department, Khyber Pakhtunkhwa has not yet notified the said policy:-

- i. Mr. Afzal Ur Rehman
- ii. Gul Sher Khalil
- iii. Mr. Ramiz Khan
- iv. Islam ud Din
- v. Mr. Jamil Khan and 8 others whose names are mentioned in Seniority list.

- iv) On 25.8.2006, this Provincial Govt. has introduced/approve 8-stage service structure for Paramedics of Khyber Pakhtunkhwa and reduced 57-different categories of Paramedics into 14-cadres and also given us Junior Clinical Technicians (Radiology) (JCT) nomenclature and granted BS-9 (copy enclosed).
- v) On 7.10.2009, Health Department issued a seniority list of JCT (Radiology) BS-9 and mentioned the names of above mentioned officials (who were appointed after us in 1988 under Federal Govt. policy which was not adopted by this Provincial Govt.) at the top of our seniority list (first page enclosed which clearly describes that appointee of 1988 are senior to appointee of 1986)
- vi) Consequently, JCT (Radiology) made a representation in Health Department that names of 1986 appointee may be mentioned over the names of X-Ray Tech. appointed in 1988.
- vii) When Health Department did not entertain the request, then, JCT (Radiology) challenged the same before PHC through W.P No. 2525/2010 and PHC had decided the case in favour of our cadre.

viii) Consequently, Health Department vide letter No.SOH(Lit.I)/12-1139/2012 dated 18.1.2012 had categorically communicated the decision of Honourable, PHC to DG Health Services for necessary compliance (copy enclosed) but DG Health Services did not make any decision till date and made the matter rolling stone.

ix) Instead of correcting our s/list, Health Department made promotion of above mentioned X-Ray Tech. on the basis of this disputed s/list:-

- i. Promoted them from BS-9 to BS-12 w.e.f. 20.4.2010
- ii. Promoted them from BS-12 to BS-17 w.e.f. 19.8.2013
- iii. Promoted them from BS-17 to BS-18 w.e.f. 28.9.2021

x) We have submitted several applications/representation to Health Department for correcting S/List and mentioning our names over the names of those X-Ray Tech. who were appointed after us in 1988, but in vain.

xi) on 28.12.2021, in response of our appeal, office of DG health Services claimed that Health Department made injustices with Radiographers on different times (copy of Health Department attached for ready reference).

2. Now the X-Ray Tech. appointed in 1988 (on the basis of illegal Fed. Govt. Circular) reached to BS-17/18 (their names are mentioned in Para-1 Sr. iii) and we are in BS-16 despite the fact that we were appointed in 1986, therefore, it is requested that Health Department may kindly be directed to take following actions and submit report:-

a- Correct our list and give us seniority position over X-Ray Tech. whose names are mentioned in Para-1 Sr. iii)

AND

b- Also grant us promotion to the following grades from the dates as mentioned below:-

- i. Promotion to BS-12 w.e.f. 20.4.2010 (the date when above mentioned X-Ray Tech.) were granted BS-12
- ii. Promotion to BS-17 w.e.f. 19.8.2013 (the date when above mentioned X-Ray Tech.) were granted BS-17
- iii. Promotion to BS-18 w.e.f. 28.9.2021 (the date when above mentioned X-Ray Tech.) were granted BS-18

















These cases were argued at considerable length, however, it has been admitted by learned counsel for the petitioners at the bar that petitioners are civil servants but their stance was that since they seek enforcement of notification dated 01.03.1988, therefore, this court has the jurisdiction to entertain these writ petitions but such stance was seriously opposed by learned Assistant Advocate General.

3. We have gone through the prayer made by the petitioners before this court. The same revolves around of their promotion from BPS-06 to BPS-09 as per the notification dated 01.03.1988, therefore we understand that it is a controversy which pertains to the terms and conditions of service of the petitioners and thus as per the

mandate of Constitution the same could only be adjudged by the Khyber Pakhtunkhwa Service Tribunal.



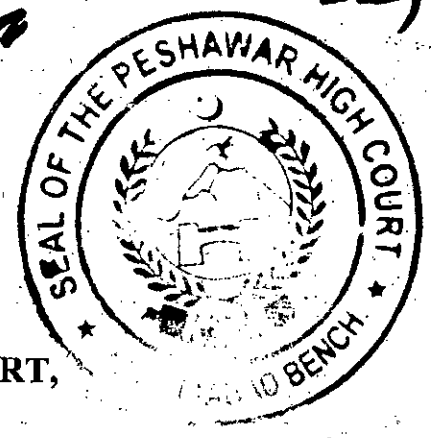
The ex-States of Dir, Swat and Chitral were made Districts of the Province of the N.W.F.P. somewhere in the year, 1971. With this action there emerged a question of the absorption of the employees of various categories serving in the former States and the fixation of their seniority with their counterparts already serving in the Province. After a thorough probe into the matter, the Services and General Administration Department issued Integration Order. The question of deciding the case of the treasury staff serving in the former States came up for consideration in the Finance Department where a final order issued on 23.10.1971. The Commissioner, Malakand Division, Saidusharif prepared a seniority list (pages 11.12 of the AD file) regarding employees serving in the treasury Establishment wherein one Mr. Abdul Waheed was shown at S.No. 8 while Mr. Sher Mohd at S.No. 12. Feeling aggrieved by the aforesaid list Sher Mohammad preferred a petition to the Commissioner for giving him due place in the seniority list. His petition came to be dismissed by the Commissioner vide order copy at pages 13-14 of the AD file. Mr. Sher Mohammad has filed a representation before the Secretary Finance Department vide pages 2-4 of the AD file. A perusal of the order of the Commissioner (pages 13-14) dated 10.7.1980 shows that he has dismissed the petition of Mr. Sher Mohammad both on merits as well as on the point of limitation. In his opinion when the tentative seniority list was prepared in the year, 1978, the same was circulated for inviting objections from the concerned officials. Many officials filed objections but Mr. Sher Mohammad failed to do so and as such his petition was time barred. On merits the Commissioner has formed opinion that the service rendered by Sher Mohammad prior to merger of the States into the Province cannot be taken into consideration for determining inter-se-seniority of the employees. As regards the first question it may be stated that the observations made in para 20 directly speak on the subject. It is also pointed therein that "to correct the wrong, if done to a civil servant, there should be no limitation or bar for Government". In the comments of the Commissioner, Malakand Division at pages 32 - 33 of the AD file too, there is nothing to show that the tentative seniority list was actually circulated amongst all the officials concerned or that there is any clear cut proof regarding that with the authorities. As such the plea of limitation should not be allowed to stand in the way of
