#### Respectfully Sheweth;

- 1. That appellant was initially appointed / recruited as Probationer Assistant Sub-Inspector on 26-03-2011.
- 2. That on 13-08-2014, services of appellant was regularized along with others but with immediate effect instead of from the date of initial appointment i.e. 26-03-2011 and was deprived for about 03 years from the benefits of rendered services. (Copy as annex "A")
- 3. That appellant etc. filed W.P. No. 3720-P/18, "Qazi Muhammad Arif etc vs Govt. of KP & Others" to direct respondents to implement the decision of the Committee Board regarding fixation of seniority from the date of initial appointment which was allowed on 24-04-2019 by the hon'ble bench of the Peshawar High Court, Peshawar directing respondents to implement the recommendations of the Committee already admitted by the them in the comments in letter and spirit. (Copies as annex "B" & "C")
- 4. That in the pursuance of the judgment dated 24-04-2019 of the hon'ble Peshawar High Court, Peshawar, R. No. 01 revised List "E" of the appellant etc. from the date of initial recruitment as ASIs vide Notification dated 05-06-2020. The name of appellant was figured at S. No. 13. (Copy as annex "D)
- 5. That on 01-07-2020 subsequent Notification of colleagues of appellant etc was issued by R. No. 01 and services of colleagues were regularized from the date of their initial recruitment. (Copy as annex "E")
- 6. That on 61-07-2020, appellant etc submitted representation before R. No. 02 to finalize / issue seniority list with effect from the date of initial recruitment with other colleagues as promotion to the upper rank was took on place but in vain. (Copy as annex "F")
- 7. That on 37-08-2020, appellant filed Writ Petition No. 3831-P/20 "Masood Khan, etc, vs CCPO & another" for direction to respondents to issue joint seniority list with others and to bring his name on list "F" with all back benefits. (Copy as annex "G")

8. That on 12-10-2020, R. No. 01 circulated Seniority List of Officiating Sub Inspectors and Assistant Sub Inspectors with List "E" wherein name of appellant was figured at S. No. 66 and his name was brought on List "E" from the date of appointment instead of with immediate effect as per court decision. (Copy as annex "H")

- That on 26-02-2021, R. No. 01 issued Notification wherein on the recommendation of Departmental Selection Committee, appellant was promoted to the rank of Officiating Sub-Inspector with effect from 16-04-2014 and his name was placed at S. No. 39. (Copy as annex "I")
- 10. That in light of the Writ Petitions regarding promotion, confirmation and antidation, DPC was constituted who examined the cases and held therein that it was principally agreed to grant favour to incumbents of their SHO period served during acting charge basis period and those PASIs of the batches who had completed their mandatory period, prior to amendment shall be confirmed on old criteria while those who could not completed periods prior of SHO, etc shall be confirmed as SI after completion of mandatory period (SHO etc). However on completion of the said period left over's PASIs shall be confirmed and he be assigned seniority with their batch. (Copy as annex "J")
- 11. That in pursuance of the decision of the said DPC, R. No. 01 issued Notification on 16-03-2021 wherein appellant was confirmed in the rank of SI with effect from 21-01-2021, when he completed mandatory period provided in PR 13.02 and Standing Orders issued from time to time. (Copy as annex "K")
- 12. That appellant was never deputed by the department for completion of mandatory periods of SHO etc so he was not dealt with as per Notification dated 16-03-2021 of R. No. 01 with his colleagues. He was deprived from confirmation as SI from the date of promotion to the rank of Officiating SI, i.e. 16-04-2014, so on 30-03-2021, he submitted representation before R. No. 02 to treat him at par with his colleagues and to confirm him from the date of

promotion to the rank of Officiating SI, i.e. 16-04-2014 but in vain. (Copy as annex "L")

Hence this appeal, Inter Alia, on the following grounds:

#### GROUNDS

- a. That appellant is serving the department with devotion and no complaint, whatsoever, was made against him in this respect.
- b. That appellant was deprived from confirmation as Sub Inspector for the sole reason that he has not gone through the mandatory periods of SHO, etc. which objection is incorrect and illegal for the reason that it was the duty of the respondents to depute him for the purpose and when the respondents did not do so, then who be made responsible for the same.
- c. That it was held time and again not only by this hon'ble Tribunal but also by the apex court that when the department failed to honor its objection, there no shall be hold responsible for the same and was give the relief sought for.
- d. That in the circumstances, appellant is entitled to be confirmed as SI from the date of promotion to the rank of Officiating Sub Inspector i.e. 16-04-2014.
- e. That Notification dated 16-03-2021 is liable to be modified with effect from 16-04-2014 instead of with immediate effect i.e 21-01-2021.
- f. That in the circumstances, the impugned Notification to extent of not confirming appellant as Sub Inspector since 16-04-2014 is based on discrimination and malafide.

It is, therefore, most humbly prayed that on acceptance of the appeal, order dated 16-03-2021 of R. No. 01 be modified / reviewed and appellant be confirmed as Sub Inspector from the date of promotion to the rank of Officiating Sub Inspector i.e.16-04-2014 with all service benefits instead of 21-01-2021 with such other relief as may be deemed proper.

- E. That it is the basic principle that every appointment whether initial / direct recruitment or promotion is made against a sanctioned post hence when there is no sanctioned post, there shall be no appointment, detailed discussion whereof is as under:-
  - "Officiating promotion as per rules/Esta code is staff-gap arrangements. Such promotions are made against non sanctioned posts / no availability of permanent vacancy for which salary is drawn by someone else. For clear understanding, the relevant excerpt (Annex B) from Esta code is re-produced as under.

"For example, a Head Clerk etc. are being retired / on long leave or suspension shall be filled on officiating basis, till he/ they is /are regularly promoted. That as per reported judgment of Services tribunal 2002 PLC (CS) 14.03; there is no rule lying down that conformation would be a date different from date of appointment hence confirmation other than appointment shall be illegal in light of provision 12.2(3) Police Rules 1934. That the petitioners have been assigned dud seniority in the seniority list from date of confirmation i.e 26.03.2011, therefore any other officers, promoting from HC and were required to be confirmed from the date of completion of promotion period, gets no bonafide right to be made senior and selected for upper course rather detailing to the course before us.
- J. That the Officers as per rule of law, highlighted in the seniority list E, are juniors to us but have been placed seniors in the seniority lilts, strictly in contravention to the rules / law on the seniority
- K. That the Hon'ble Inspector General of police vide order No 452/E-II dated 23.01.2017 has considered the prayer of probationer kohat division and revised seniority of probationer ASIs of kohat region in list E in accordance with the prescribed rules i.e 12.2(3), 12.8 and 13.18 of police rules 1934 (copy attached as anenx F) thus attracting the principle / rule of consistency, directed by the Hon'ble Supreme Court

It is therefore prayed that On acceptance of this writ petition appropriate may please may be issued by directing the respondents to implement the decision of the committee Board regarding fixation of seniority, where as semiority list "E". be revised petitioners direct appointee through public service commission be brought and placed at their due place of seniority, and also to ensure the circulation of the seniority list, prepared in accordance with law rules lay down for the purpose, the reluctance on the part of the respondents by not implementing the decision of the committee board is illegal unlawful, without lawful authority, violative upon the rights of the petitioners. Or any other relief which is not specifically asked may also be allowed.





#### Respectfully Sheweth:

1. That on 20-02-2010, 13-03-2010 and 26-03-2011 petitioners—were initially appointed / recruited as Probationer Assistant Sub-Inspectors.

- 2. That on 13-08-2014, after serving successfully and devotedly services of all petitioners were regularized with immediate effect and not from the date of initial recruitment. (Copy as annex "A")
- 3. That petitioners filed W.P. No. 3720-P/18, "Qazi Muhammad Arif vs Govt. of KP & Others" which was allowed on 24-04-2019 by the hon'ble court. (Copies as annex "B" & "C")
- 4. That the said judgment was remitted to respondents for compliance on 27-06-2019, but respondents were not implementing the same of the hon'ble court in letter and spirit, so COC No. 52-P/2020 was filed for the purpose which came up for hearing and then the representative of the respondents placed on board Notification dated 05-06-2020 by regularizing their services from the date of initial recruitment instead of the date of with immediate effect, i.e. 13-08-2014. (Copies as annex "D", "E" & "F")
- 5. That on 05-06-2020, R. No. 01 revised order dated 13-08-2014 of the petitioners with effect from 20-02-10, 13-03-2010 & 26-03-2011, i.e. from the date of their initial recruitment but till date, no Final Seniority List with other colleagues was circulated by the department. (Copy as annex "G")
- 6. That on the other hand, respondents are promoting incumbents from the previous Seniority List who have by now become most junior than petitioners but petitioners are ignoring from promotion to the next higher grade / post for the reason that integrated seniority list of the former incumbents viz-a-viz petitioners was neither finalized nor circulated till date amongst them.
- 7. That for the aforesaid purpose, petitioners submitted representations before respondents on 12-06-2020 and 01-07-2020 to issue integrated seniority list of the former incumbents along with petitioners but of no avail till date, while on the other, hand respondents are promoting incumbents from the former seniority list, despite the fact that petitioners are quite seniors than the former incumbents. (Copies as annex "H")

Hence this Writ Petition, inter alia, on the following grounds:

#### GROUNDS.

- a. That respondents are not treating petitioners at par with other colleagues as they are much seniors than others.
- b. That as and when services of incumbents were confirmed / regularized after completing of probationer period, they were confirmed from the date of their initial recruitment and not with immediate effect.
- c. That it was incumbent upon the respondents to confirm after successfully completing probationary period from the date of initial recruitment and not with immediate effect. In the case in hand, services of petitioners were confirmed with immediate effect instead of their initial date of recruitment, thus they were put to lose not only from further promotion but also other benefits of services.
- d. That unless and until revised integrated seniority list is not issued by the respondents of the colleagues viz-a-viz petitioners, they would suffer further promotion as well as other benefits of service and would remain juniors till then.
- e. That juniors to petitioners, being most seniors, are battling since the year, 2018 for their vested right but respondents are intentionally not redressing their grievances for no legal reason. such act of the respondents is based on malafide and discrimination.

# DEPARTMENTAL SELECTION COMMITTEE FOR PASIS BATCH 2010-11

Departmental Selection Committee has been constituted in the backdrop of Writ Petition No. (Sic) in CM No.2171/P filed by Abdul Sattar & others for their revised seniority and information in the rank of Sub Inspector after their names were brought on List E from the date confirmation in light of the judgment in Writ Petition No.3720-P/2018. DSC had several directing on different dates and petitioners were also called in every meeting to hear their point of view. DSC comprised of the following officers:

- I. SSP CO Ordination (Chairman)
- 2. SP HQrs
- 3. SP Security
- 4. SP Cantt Traffic
- 5. DSP legal
- 6. Office Sudpt

Petitioners were aggrieved of the following:-

- A. Their confirmation date in the rank of ASI shall be revised as DPC for both he batches was held late enough and if the same had been called on the due date i.e, after 03 years of completion of probation, they would have availed promotions chances and got eligibility in time for mandatory periods/ courses.
- B. They should have been promoted as Offg: SI in April 2014 when first DPC after the completion of their probation was held and petitioners be made senior to the promotees.
- C. They be confirmed on old criteria of SI confirmation wich was applicable prior to 30.06.2018.
- D. Their nomination as per Form 13.15 Police Rules shall be snet to Central Police Office recommending their names to be included in List F from revised date.

Committee had threadbare discussion over the specific issue and relevant laws/ rules were perused. Committee after mutual consultation agreed on the following recommendations.

- As for as the grievance A of the petitioners regarding revision of their confirmation in the rank of ASI is concerned it appears to be based on valid reason. PR 12.08 states that directly recruited ASIs should be on probation for 03 years but in the present case of petitioners, the probation period exceeded by 03 years. The DPC date is required to be revised and they may be confirmed on completion of 03 years probation PASIs of batch 2011 were appointed on same date i.e. 26.03.2011 but PASIs of batch 2010 were appointed on different dates, therefore their confirmation may be made from their dates of enrollment after completion of three years probation period.
- 2. As for as point B is concerned, after their confirmation in the rank of ASI is revised and comparing that date with that of the DPC for promotion of Offg SI held in April (sic)

Who were promoted through DPC held on 16.4.2014. Committee is of the opinion that petitioner's revised promotion shall be made from 16.4.2014 instead of 03.03.2017 & 12.02.2019.

3. After their revised promotion as Ofg SI next question before committee was the confirmation of the petitioners in the rank of SI. As there are certain courses and mandatory periods prior to confirmation in the rank of SI as provide in PR

13.10 and some standing orders. PR 13.10 has been amended and a one year mandatory course has been introduced in 30.6.2018. Petitioners have been promoted on Acting Charge Basis on 24.07.2015 much prior to their regular promotion in the year 2017 and 2019. It was principally agreed to grant the favor to petitioners of their SHO period served during Acting charge basis period. Among these PASIs of 2010 and 2011 batches who had completed their mandatory period prior to the amendment in 30.06.2018 shall be confirmed on old criteria while those who could not complete mandatory periods prior to amendment in PR 13.10, they shall be confirmed as SI after they complete the mandatory period as provided in amended PR 13.10. However on completion of period and after confirmation these leftover PASIs shall be assigned seniority with their batch.

4. Amended PR 13.10(2) makes it mandatory for every SI to go through Upper College course before being confirmed in the rank. Petitioners were deputed for upper college course in year 2019 because their seniority was not properly adjusted. Now as their seniority is being revised and as per revised seniority they would have completed the subject course much earlier to the amendment, therefore committee is of the view that one time waiver may be granted to the batches of 2010-11 by not considering the date of completion of Upper College Course at the time of confirmation. This decision is being suggested specifically in the present circumstances and it may not be made precedent in future.

#### Respectfully sir,

- 1. That appellant etc were initially appointed / recruited Probationer Assistant Sub-Inspectors in the year 2010/2011.
- 2. That services of all appellant etc were regularized on 13-08-2014 but with immediate effect and not from the date of initial recruitment.
- 3. That appellant etc filed Writ Petition No. 3720-P/18, "Qazi Muhammad Arif vs Govt. of KP & Others" which was allowed on 24-04-2019.
- 4. That on 05-06-2020 and 01-07-2020, CCPO Peshawar revised their recruitment from the date of initial appointment.
- 5. That on 26-02-2021, Notification in pursuance of the pending Writ Petitions was issued through DPC wherein the incumbents mentioned therein were confirmed in the rank of ASI's and promoted to the rank of Officiating Sub-Inspectors of the batches 2010 and 2011 was revised. In his Notification 52 personnel's were mentioned.



That on 16-03-2021 the worthy CCPO issued subsequent Notification wherein the incumbents mentioned therein were confirmed in the rank of Sub-Inspectors with effect from the date of completion of mandatory period provided in Police Rules 13.10 (2).

Here it out be not out of place to mention that I at S. No. 31 was confirmed with immediate effect i.e. 21-01-2021 with immediate effect after completion of the mandatory period and not with their batch mates according to the DPC Minutes.

- 7. That here it is pertinent to mention that I was never deputed / posted for completion of Police Rules 13.10 (2) at the right time, so I was confirmed with immediate effect.
- 8. That in the Minutes of the Meeting of the DPC, it was decided that the leftover incumbents shall be assigned seniority with their batch.
- 9. That it was incumbent upon the authority to confirm me in the rank of Sub-Inspector from the date of promotion to the rank of officiating SI and not with immediate effect.
- 10. That not only the hon'ble Service Tribunal and the apex Supreme Court of Pakistan held in plethora of judgments that no one can be deprived from benefits of confirmation / promotion to the next rank when the same is not on their part.
- 11. That appellant was discriminated for no legal reason but due to the lapses of the department / authority. Such act is based on ulterior motive.

It is, therefore, most humbly requested that Notification dated 16-03-2021 be kindly reviewed / modified and appellant be confirmed in the rank of Sub Inspector with their batch mates and obliged.

#### PRELIMINARY OBJECTIONS:-

- 1. That the appeal is badly barred by law & limitation.
- 2. That the appeal is bad for mis-joinder and non-joinder of necessary and proper parties.
- 3. That the appellant has not come to Hon'able Tribunal with clean hands.
- 4. That the appellant has no cause of action and locus standi.
- 5. That the appellant is estopped by his own conduct to file the instant appeal.
- 6. That the appellant has concealed the material facts from Honorable Tribunal.
- 7. That the appeal is not maintainable being devoid of any merit.

#### **REPLY ON FACTS:-**

- 1. Para pertains to record, hence needs no comments.
- 2. Incorrect. In fact as per Rules 19.25(1) (2) of the Police Rules 1934 which provides that (1) "Inspector, Sub Inspector, Assistant Sub inspector, who are directly appointed, shall be deputed to the Police Training school to undergo the course of training laid down for such officers in the Police Training School Manual and are liable to be discharged if they fail to pass the prescribed examinations or are badly reported on. (2) On successfully completing the course at the school, upper subordinate will be posted to districts for practical training. The following programme of instruction shall be followed. Course A- prosecuting inspector's work. Course B Police Lines. Course C-office of the Superintendent. Course D- training at a Police Station". The appellant after qualifying probationer course was confirmed in the rank of ASI and brining his name on promotion List "E".(copy of rules is annexure as A)
- 3. Para pertains to court hence needs no comments. However, in pursuance of the order of the High Court seniority of the appellant along with their colleagues was fixed and they were confirmed in the rank of ASI from the date their initial appointment.
- 4. Para pertains to record, hence needs no comments. In addition to that after court order case of the appellant along with his collogues was process in finally there were brought on their due place.

- 5. Para pertains to record, hence needs no comments. In fact, the case of the appellant along with his collogues was put before the DPC where the case was discussed and after due consideration they were regularized from the date of their initial recruitment.
- 6. Incorrect. Application of the appellant was under process, but the appellant without waiting the finalization of his application, filed writ petition before Peshawar High Court regarding the same matter which effected on the process of his application.
- 7. Para not related to answering respondents record.
- 8. Para pertains to record, hence needs no comments. In fact, seniority was rightly issued and appellant along with his colleagues was revised and their names were brought to list E from the date of initial appointment.
- 9. Para pertains to record, hence needs no comments. However, after revised their names are list E they were promoted to the rank of officiating sub inspector from the date of 16.04.2014.
- 10. Incorrect. Colleagues of the appellant were confirmed in the Rank of SI after completion of their mandatory period. Confirmation in the rank of S.I requires completion of laid down criteria and those S.Is who fulfill the said qualification are confirmed first in the rank of S.I. Real facts of the para are that those SIs who have completed their mandatory period toward confirmation in the rank of SI prior to the year 30.06.2018 have been confirmed on old criteria while those who have not fulfilled the requisite laid down criteria have not been considered for the same, hence para is not maintainable. In order to ensure transparency and fairness in seniority/promotion of Police Officials, different Standing Orders have been issued from time to time to meet the criteria for promotion to the next higher rank.
- 11. Correct to the extent that the appellant himself accepted the reality that he was confirmed in the rank of SI after completion his mandatory period.
- 12. Incorrect and misleading. Actually services of Police required extra vigilance and experience to serve the general public and generally only those officers are selected for posting as SHO, who have gained sufficient experience in Police duty, and whose working/ duties are found satisfactory and it can be relied that he will come upon the expectations of public at large and Police Seniors officers as well. Therefore under Rule 13-10 (2) of Police Rules 1934 amended 2017, which provides that "no sub inspector shall be confirmed in a substantive vacancy unless he has been tested for at least a year as an officiating S.I in independent Incharge of PS, a notified post, or as Incharge investigation of a PS or CTD". (copy of rule is annexed as "B")

That appeal of the appellant being devoid of merits may be dismissed on the following grounds.

#### **REPLY ON GROUNDS:**

a. Para pertains to record, hence needs no comments.

- b. Incorrect. Appellant has never been deprived of his due right nor treated with discrimination. Actually only those Sub Inspectors are confirmed in the ranks who fulfill the laid down criteria and confirmation of no SIs considered without completion of requisite criteria.
- c. Incorrect. Appellant has been treated strictly in accordance with law and no legal right has ever been violated. Actually confirmation in the rank of Sub Inspector is subject to fulfillment of Rule 13.10 (2) and Standing Orders issued by the Officer from time to time.
- d. Incorrect. In fact confirmation in the rank of S.I requires completion of laid down criteria and those S.Is who fulfill the said qualification on priority are confirmed first in the rank of S.I. Similarly appellant was also confirmed in the rank of S.I on qualifying the said pre-requisite criteria without committing any irregularity in his case of confirmation.
- e. Incorrect. Appellant has to qualify the requisite laid down criteria for confirmation in the rank of SI. His request for confirmation as SI is devoid of merit. Infact under rule 13.10(2) of Police Rules, he is not entitled for confirmation as SI.
- f. Incorrect. Appellant has never been deprived of his due right nor treated with discrimination. Replying respondents are duty bound to follow law/rules and no right of the appellant has been violated.

#### PRAYERS:-

It is therefore most humbly prayed that in light of above facts and submissions the appeal of the appellant being devoid of merits, legal footing may be kindly be dismissed with costs please.

#### **PRELIMINARY OBJECTION**

All the 07 Preliminary Objections are illegal and incorrect. No reason in support of the same is ever given as to why the appeal is barred by law and limitation, bad for non and misjoinder of necessary parties, unclean hands, without cause of action and locus standi, estoppel, concealment of facts and not maintainable.

#### ON FACTS

- 1. Needs no comments.
- 2. Not correct. The para of the appeal is correct regarding regularization of service from the date of initial appointment i.e. 26-03-2011 instead of with immediate effect because services of other similarly placed employees were regularized from the date of initial recruitment. Rest of the version of the respondents is not correct.
- 3. In response to para No. 03 of the comments, it is submitted that similarly placed employees services were regularized from the date of initial appointment but when such matter of other coemployees like appellant by not regularizing their services from the date of initial appointment, knocked the doors of the hon'ble court and thereafter on the direction of the hon'ble court, regularized their services from the date of initial appointment, so not only services of appellant were regularized from the date of initial appointment with seniority too but of others too.

- 4. Admitted correct by the respondents by revising the former order and regularized services of appellant as ASIs from the date of initial appointment vide order dated 05-06-2020.
- 5. As above.
- 6. Not correct. The para of the appeal is correct regarding submission of representation before the authority for issuing of seniority list from the date of initial recruitment like colleagues.
- 7. Not replied by respondents regarding Writ Petition for issuing joint seniority list with colleagues and to bring names on List "F" with all back benefits.
- 8. Admitted correct by the respondents regarding circulation of seniority list and bringing their names on list "E" from the date of initial appointment.
- 9. As above.
- 10. Not correct. The para of the appeal is correct where relief sought was given by the respondents to appellant.
- 11. Admitted correct by the respondents by confirming services of appellant as SI with effect from 21-01-2021, neither with his colleagues nor per Police Rules 13:18 from the date of officiating promotion to the rank of SI.
- 12. Not correct. It was mandatory upon the respondents to depute appellant for completion of mandatory period of one year as SHO, etc. He was not dealt with as per Notification dated 16-03-2021 with his colleagues nor per the Minutes of the DPC to confirm promotion of appellant with his colleagues nor per Police Rules from the date of officiating SI i.e. 16-04-2014.

Similar question of law and facts came up for hearing before the hon'ble Tribunal wherein it was held in judgment dated 21-02-2018 and 15-03-2019 that to depute a person for mandatory period as well as training was the responsibility / duty of the respondents. By not doing so, incumbent cannot be punishment for the lapses of others. (Copies Attached)

4. On the other hand learned DDA argued that the appellant did not implead those officers/officials who would be declared junior to him through anticipated judgments. That the departmental authority rightly ordered the confirmation of the appellant from 27.08.2015 because he was to undergo certain pre conditions like testing for one year and passing certain courses. He next contended that the present appeal was time barred. He further argued that the appellant was repatriated in the year, 2010 from Motorway Police and thereafter he was posted as SHO and he would be confirmed thereafter.

## CONCLUSION.

The appeal is not time barred as in the first round this Tribunal remitted the appeal to departmental appellate authority. There was no need to implead other officials as this is a case of confirmation and not sensority simplicitor. This Tribunal in the above mentioned judgments have already decided this issue by holding that the confirmation of officiating policitating policitations from the date of officiating promotion. This Tribunal also are at a few already of Munic. #### **ARGUMENTS**

2. Learned counsel for the appellant argued that on the recommendations of Khyber Pakhtunkhwa Public Service Commission, he was appointed as ASI in the Police Department on 29.01.1991. He was confirmed as ASI w.e.f 29.04.1991 in 1994 and got promoted as Sub-Inspector on 01.10.1997 on officiating basis. In order to complete the process of confirmation against the available slots a meeting of Departmental Promotion Committee was held on 29.08.2002. A panel of eight officers including the appellant was placed before the committee for consideration/decision. Name of the officers appearing at sr. no. 1 to 6 of the list

EXAMINER Kinder Pakitukhwa Service Tribunai were ignored due to various deficiencies recorded in the minutes. Mr. Bashir's case was cleared by the committee. Case of the appellant alongwith others was deferred for want of PERs for the year 2000 and 2001. However, in parawise comments submitted by the respondents, it was clarified that case of the appellant was deferred being posted at UN Peace Mission. However, in 2002 Mr. Gul Naseeb and Mr. Muhammad Shafiq (respondents no. 4 and 5) were confirmed without getting approval of the Departmental Promotion Committee. In 2003 another meeting of the Departmental Promotion Committee was convened in which name of the appellant was reflected at sr. no.5 but again ignored. Feeling aggrieved, he preferred a departmental representation on 22,01.2011 which was rejected on 15.03.2011, hence, the instant service appeal. No valid justification was given while ignoring the appellant for confirmation against the said post.

Even officers juniors to him were confirmed which is a worst case of discrimination. Reliance was placed on case law reported as 1996 PLC 528 and judgment of this Tribunal dated 21.02.2018 passed in service appeal no. 736/2016.

3. On the other hand learned Deputy District Attorney argued that as the appellant had proceeded abroad to perform duty at U.N Peace Mission and due to non-availability his case for confirmation of S.I was not considered during the meeting by the DPC held meeting on 29.08.2002. Subsequently, another meeting of DPC was held on 10.12.2013 to fill the vacant vacancies but as the appellant was junior so his case was again not taken up. All codal formalities were observed and the appellant was treated fairly and without any discrimination.

## CONCLUSION

- Perusal of record revealed that the appellant was confirmed as ASI w.e.f. 29.04.1391 in 1994 and promoted as S.1 on officiating basis on 01.10.1997. It is not dispeted that being eligible for confirmation as S.I his name was included in te panel of officers considered by the Departmental Promotion Committee in its meeting held on 29,08,2002. However, it was not considered for want of PERs for the year 2002 and 2001, but in the statement/para-wise comments it was stuted that time he was posted at U.N Peace Mission. Similar remarks were also recorded rgainst Gul Nasech. It is attunge enough that in 2002 Gal Nisseeb and Muhammad Shafique were confirmed without getting approval of the DPC. In addition to above they did not fulfill the criteria laid down for the confirmation. Respondents had not quoted rules which imposed bar on confirmation during the course of posting abroad. It is perfinent to point out that he was sent to the UN Pence Mission by the Govt: of Pakistan. This issue has already been addressed in the below mentioned judgment of this Tribunal, We are unable to comprehend that those who joined service in 1995 and were juniors to the appellant were confirmed but he was ignored,
  - 5. Moreover, on the strength of judgment of this Tribunal dated 21.02.2018 passed in service appeal no. 736/2016, it was held that confirmation of officiating police officials shall be considered from the date of officiating promotion. It is further fortified by Rule-13.18 of Police Rules, wherein it is laid down that all police officers promoted in rank shall be un probation for two years, provided that the appointing authority may, by a special order in each case, permit periods of the appointing service to count towards a period of probation. **JUDGMENT** 

Mr. ATIO UR REHMAN WAZIR MEMBER (E):- Brief facts of the case are that the appellant was promoted as officiating Sub Inspector(SI) on 01-01-2010 but was not confirmed as SI after satisfactory service for two years, whereas his other colleagues including his juniors were confirmed in the rank of SI vide order dated 10-09-2012. Finally, the appellant was confirmed as sub inspector vide order dated 13-07-2015 but with immediate effect, against which the appellant filed departmental appeal, which was not responded to, hence the instant service appeal with prayers that the appellant may be confirmed as sub inspector w.e.f

10-09-2012, the date when his other colleagues/juniors were confirmed with due seniority in list F with all back benefits.

- 02. Written reply/comments were submitted by respondents.
- Arguments heard and record perused.
- 04. Learned counsel for the appellant has contended that the appellant was not confirmed as SI along with his colleagues due to the reason that during the tenure as officiating sub inspector, he did not serve in independent charge of a police station, a notified police post or as in-charge investigation of a police station or in counter terrorism department. Learned counsel for the appellant further contended that such postings were beyond control of the appellant; that according to Police Rules 13:18, it was the legal right of the appellant to be confirmed as SI after lapse of two years, but in case of appellant, the said rules have not been observed; That finally the appellant was confirmed vide order dated 13-07-2015 but with immediate effect instead of 10-09-2012 and was included to list F, whereas his other colleagues and juniors were confirmed on 10-09-2012 and were accorded seniority accordingly, the appellant too, as such is entitled to ante-dated confirmation as SI w.e.f 10-09-2012, but he was not treated accordingly. Learned counsel for the appellant further contended that similar nature cases have already been accepted by this Tribunal and the appellant is also entitled to same relief under the principles of equity and consistency. Reliance was placed on CP No. 538-P of 2003, Service Appeal No. 1602/2010, Service Appeal No. 1450/2013, Service Appeal No. 1227/2013, Service Appeal No. 1021/2015 and Service Appeal No. 271/2018. Learned counsel for the appellant added that the appellant has not been treated in accordance with law and rule and was deprived of his legal rights in arbitrary and illegal manner. On the question of limitation, learned counsel for the appellant added that in matter of promotion, seniority, pay and other emoluments, limitation



would not foreclose his right accrued to him. Reliance was placed on 2002 PLC (CS) 1388, 2009 PLC (CS) 178 and 1999 SCMR 880. Learned counsel for the appellant prayed that on acceptance of this appeal, the appellant may be confirmed as SI w.e.f 10-09-2012, the date when his colleague/juniors were confirmed with due seniority in list F and with all back benefits.

- Deputy District Attorney appeared on behalf of official respondents have contended that confirmation in the rank of SI is subject to fulfillment of rule 13:10(2) and standing order issued by the provincial police officer from time to time; that the appellant was required to qualify the requisite criteria for confirmation in the rank of SI. Learned Deputy District Attorney further contended that the appellant was confirmed as SI, when he fulfilled the mandatory requirements and orders are issued with immediate effect and not with retrospective effect as per law and rule. Learned Deputy District Attorney added that other colleagues/ juniors of the appellant were promoted after fulfilling the requisite criteria. Learned Deputy District Attorney further added that posting/transfer on independent position are made after examining professional skills and ability of sultable officers; that the appellant was treated in accordance with law and his appeal being devoid of merit may be dismissed.
  - 06. We have heard learned counsel for the parties and have perused the record. Record reveals that the only reason for non-confirmation of the appellant as SI was that the appellant had not fulfilled the criteria envisaged in 13:10(2) of Police Rules, 1934, which is reproduced as under:

"No Sub-Inspector shall be confirmed in substantial vacancy unless he has been tested for a year of an officiating Sub-Inspector in independent charge of a Police Station, a notified police post, or as in-charge investigation of a police station or in counter terrorism department."

To this effect the worthy Apex Court as well as this Tribunal, in numerous in judgments have held that condition of postings as envisaged in the rule ibid, as

impediment in the way of confirmation as SI was not attributable to the appellant because postings were beyond control of the appellant, which powers rests with the competent authority and subordinate officials cannot be punished for such administrative lapses on part of the relevant authority, hence depriving him from being confirmed in the rank of SI along with his batch-mates would tantamount to his deprivation from further progression, which was not justified. It was also noted that respondents totally ignore Rule-13:18 of Police Rules, 1934, wherein it is laid down that all police officers promoted in rank shall be on probation for two years, provided that the appointing authority may, by a special order in each case, permit periods of officiating service to count towards a period of probation. On the conclusion of probation period a report shall be rendered to the authority empowered to confirm the promotion who shall either confirm the officer or revert him.

27. In view of the foregoing discussion, we are of the considered opinion that case of the appellant is similar in nature with the cases already decided by this Tribunal as well as by the apex court, as referred to by counsel of the appellant. For the reasons, we are inclined to accept the present appeal with directions to the respondents to confirm the appellant as SI from the date when his other colleagues were confirmed, as well as place him in due place in the seniority list. The appellant is also held entitled to all consequential benefits, if any. Parties are left to bear their own costs. File be consigned to record room.


#### **JUDGMENT**

IJAZ ANWAR, J.---Through the instant writ petition under Article 199 of the Constitution of 'Islamic Republic of Pakistan, 1973, Capt: Zahur Ahmad Khan Khalil (the petitioner) claim promotion to BPS-22 after his retirement and prayed for the following relief:-

"That on acceptance of this writ petition in the light of above facts and grounds and after

calling for all relevant record of the petitioner a direction may be issued to the respondents for grant of proforma promotion (BPS-22) with effect from the date the juniors to the petitioner are promoted). Any order if is issued in violation of it and not in the knowledge of the petitioner be declared illegal and against the law".

- 2. The precise facts as narrated in this writ petition are that the petitioner joined the District Management Group now (PAS) in 9th Common Training Programme in November, 1982. It is alleged that he was inducted against the Armed Forces quota where he was posted as Captain. It is claimed that the petitioner remained on various administrative positions like Assistant Commissioner, Deputy Commissioner, Commissioner, Secretary of various Departments, On Staff with Chief Minister and Governor of Khyber Pakhtunkhwa and with unblemished service career. He was promoted to BPS-18, BPS-19, BPS-20 and lastly as BPS-21. It is alleged that in the year, 2012, the High Powered Selection Board deferred his case for promotion in its meeting held on 12.02.2012. Again his name was placed before the High Powered Selection Board for promotion to BPS-22 in its meeting held on 27.12.2013, but his name was deferred. It is further alleged that twice again his name was placed before the High Powered Selection Board for consideration but for no justifiable reasons, he was deferred and in the meantime, he reached the age of superannuation with effect from 14.01.2015, hence this petition.
- 3. The respondents were put to notice, they submitted their parawise comments, raising factual and legal objections. It is alleged that the petitioner was considered for promotion quadrupled, however, he was not promoted specifically giving the reasons for his deferment. It is further alleged that High Powered Selection Board (HPSB) has exercised its powers responsibly, fairly, justly and for the advancement of the purpose of section 24-A of General Clauses Act. Further, the post of BS-22 is not only required to be considered as per seniority the officer is evaluated on the basis of record and collective wisdom of the Board, on merit. There is no mala fide intention on the part of HPSB to deprive any one from promotion. Instead, the officers are evaluated on the basis of available record as mentioned in Para-4 of the report so that competent officers could be promoted to undertake the highest level of responsibilities. No one is extended any favour. Only eligible, honest, qualified and competent officers are promoted. It is a matter of record that the petitioner is younger to the promoted officer and it has no relevance with the promotions.
- 4. The learned counsel for the petitioner argued that after the judgment of the Honourable Supreme Court in famous case of Tariq Aziz-ud-Din (2010 SCMR 1301), the respondents have formulated the Civil Servant (Promotion to the post of Secretary, BPS-22 and equivalent) Rules, 2010, the discretion of the Government in the matter of promotion was structured and confined to the rules, so framed. He referred to Rule 3, which prescribes the eligibility of the officer holding in BPS-21. Similarly, referred to Rule 4 and according to which, the petitioner was perfectly eligible and fit to have been allowed promotion to BPS-22. He argued that where the respondents themselves are not posting the petitioner against any alleged challenging assignment, how he can be denied promotion on such pretext. He argued that the petitioner though retired from service but due to inaction of the respondents, he is deprived of his promotion in BPS-22. He placed reliance on 2017 SCMR 969 Federation of Pakistan through Secretary, Establishment Division and others v. Dr. Muhammad Arif and others.
- 5. The learned D.A.G. argued that the petitioner was duly considered for promotion; however, for the reasons correctly mentioned in the minutes, he was deferred. He argued that no officer can claim promotion as of right. He also referred to section 22 subsection of the Civil Servant Act, 1973, that since the matter relates to the fitness of the Civil Servant, therefore, this Court has got no jurisdiction to interfere in the matter.
  - 6. Arguments heard and record perused.
- 7. The substantive law for promotion of civil servants is given in section 9 of Civil Servant Act. 1973, which provides as follows:-
  - "9. Promotion.---(1) A civil servant possessing such minimum qualification as may be prescribed shall be eligible for promotion to a higher post for the time being reserved under the rules of departmental promotion in the service or cadre to which he belongs:



Provided that the posts of
(a)
(b)

- (2) A post referred to in subsection (1) may either be a selection post or a non-selection post to which promotions shall be made as may be prescribed.
- (a) In the case of a selection post, on the basis of selection on merit; and
- (b) In the case of a non-selection post, on the basis of seniority-cum-fitness.
- (3) Promotion to posts in basic pay scales 20 and 21 and equivalent shall be made on the recommendations of a Selection Board which shall be headed by the Chairman, Federal Public Service Commission."

The above provisions are supplemented by Rules 7, 8 and 8-A of The Civil Savants (Appointment, Promotion and Transfer) Rules, 1973. For the ease of reference the said rules are reproduced hereunder:

- "7. Promotion and Transfers to posts in [basic pay scales 2 to 18 and equivalent, [except the posts specified in sub-clause (i) of Clause (b)] and equivalent] shall be made on the recommendation of the appropriate Departmental Promotion Committee and promotions and transfers to posts, [specified in sub-clause (i) of clause (b) and posts], in [basic pay scales 19 to [21] and equivalent] shall be made on the recommendations of the Central Selection Board.
- 8. Only such persons as possess the qualifications and meet the conditions laid down for the purpose of promotion or transfer to a post shall be considered by the Departmental Promotion Committee or the Central Selection Board as the case may be; (underlines supplied for emphases)
- 8-A. No promotion on regular basis shall be made to a posts in Basic Pay Scales 17 to 22 and equivalent unless the officer concerned has completed such minimum length of service, attended such training and passed such departmental examination, as may be prescribed from time to time."
- 8. The august Supreme Court of Pakistan, while dealing the cases of promotion of the posts carrying BPS-21 and BPS-22, had in <u>Tariq Aziz-ud-Din</u> case (2010 SCMR 1301), deprecated the non-existence of any rules for promotion to BPS-22 and besides others, directions observed for the formulation of Rules for promotion from BPS-21 to BPS-22 to avoid unjustness and arbitrariness in making promotion. The Federal Government vide SRO notified on 16th August, 2010, framed Civil Servants (Promotion to the post of Secretary, BS-22 and Equivalent) Rules, 2010. Rules 3 and 4 provide the eligibility criteria for promotion to BS-22. Rules 3 and 4 are reproduced for convenience:-
  - "3. Manner of Promotion.---(1) The Posts in BS-22 in the Federal Government shall be filled in by promotion from amongst the officers specified in sub-rule (2) with the approval of the appointing authority on the recommendations of the Board.
  - (2) The officers holding post in Basic Scale 21 on regular basis in an All Pakistan Service or, as the case may be, a civil service of the Federation or a post in connection with the affairs of the Federation and possessing the length of service and fulfilling other conditions specified in rule 4, shall be eligible for promotion to a post in Basic Scale 22 in the respective service, group or cadre to which the officer for the time being belongs:

Provided that the pot of Secretary in BS-22 in the Secretariat Group may be filled in by promotion in the public interest from amongst officers of regularly constituted Occupational Groups and Services possessing the length of service and fulfilling other conditions specified in rule 4, holding, on regular basis, posts in Basic Scale 21.

(3) Nothing in this rule shall prevent a post in Basic Scale 22 or equivalent already reserved

for initial appointment in accordance with the method of appointment laid down under subrule (2) of rule 3 of Civil Servants (Appointment, Promotion and Transfer) Rules, 1973, in filling such post in accordance with such method.

- 4. Length of service and other conditions for promotion.—An officer shall possess the length of service and fulfill the following conditions for promotion to a post in Basic Scale 22 including the post in BS-22 as Secretary in the Groups and Services in the Federal Government;
- (i) Twenty-five service in Basic Scale 17 and above, excluding the period of suspension not counted as duty and extraordinary leave, and has completed at least two years in a post in Basic Scale 21;
- (ii) at least three "very good" reports during the last six years;
- (iii) No penalty under Government Servants (Efficiency and Discipline) Rules, 1973 or under the Removal from Service (Special Powers) Ordinance, 2000 (since repealed) has been imposed upon him during his tenure in BS-21; and
- (iv) possesses sufficient variety of experience. (underlines supplied).
- 9. On the promulgation of these rules, the discretion of the Government has been structured and curtailed and now promotion to BPS-22 are governed under the provisions of these rules. The petitioner has illustrious service career and was promoted to BPS-21 in the year 2010. It transpires from the comments submitted by respondents that the petitioner was initially considered for promotion by the High Powered Selection Board in its meeting held on 22nd to 26th December, 2012, 27th November, 2013, 22nd September, 2014 and lastly on 6th January, 2015, however, repeatedly in these meetings, the petitioner was deferred mainly for the reason beyond his control, as on 22nd September, 2014, "the board felt that his performance has to be assessed on a more challenging post for merit in promotion to BPS-22, the Board directed the Establishment Division to post the officer on a challenging assignment in Islamabad and called for special report of the officer at least for three months.
- 10. The synopsis of the posting order of the petitioner attached with the writ petition depict that the petitioner remained on major administrative posts of Secretaries in different departments of the Provincial Government ever since 1992. In the Federal Government, he remained Chairman Pakistan Tobacco Board, Govt. of Pakistan, Ministry of Commerce, Islamabad from 9th January, 2012 to 9th October, 2012, Member (Finance) Pakistan Agriculture Research Council, Islamabad, BS-21 from 27th May, 2013 to 8th July, 2013, Director General Wafaqi Mohtasib (Ombudsman)'s Secretariat, Regional Office, Peshawar, from 13th August, 2013 to 11th November, 2013, Member/Additional Secretary, Incharge Wafaqi Mohtasib (Ombudsman)'s Secretariat, Regional Office, Peshawar, from 12th November, 2013 till his retirement. It is pertinent to mention here that posting on any assignment is within the domain of the Federal Government if the Federal Government is not posting the petitioner on such alleged challenging assignment, how he can be blamed. It shows that pick and choose policy has been adopted by the Government in posting of officers of their choice, therefore, the objection regarding non-posting on challenging assignment cannot be attributed to the petitioner.
- 11. There is another important aspect of the case. On each occasion, when the petitioner was considered for promotion by the High Powered Selection Board, the petitioner was deferred and not superseded. The Federal Government has formulated policy guidelines for the conduct of Departmental Promotion Committees (D.P.Cs) and Central Selection Boards (C.S.Bs).
- 12. By way of general selection, the policy provided that the DPC/CSB shall consider the case of eligible civil servants in the order of seniority and either:
  - (a) Recommend a civil servant for promotion to the next higher post; or
  - (b) Recommend a civil servant for supersession; or
  - (c) <u>Defer consideration of a civil servant's promotion</u> provided that this step will be taken <u>only</u>

if

- (i) The CR dossier is incomplete or any other <u>document/information required by the DPC/CSB</u> for determining a civil servants suitability for promotion is not available; or
- (ii) <u>Disciplinary or departmental proceeding are pending</u> against the civil servant whose promotion case comes up for consideration before the DPC/CSB; or
- (iii) The civil servant on deputation abroad to a foreign government, private organization or international agency; or
- (iv) The civil servant does not possess the requisite length of service; or
- (v) The civil servant has not undergone the prescribed training or passed the departmental examination for reasons beyond his control; or
- (vi) The civil servant's inter se seniority is sub judice.

The policy further required that the civil servant whose promotion has been deferred will be considered as soon as the reason on the basis of which deferment took place ceases to exist.

- 13. Thus, the deferment by itself refers to certain shortcomings, which, in due course of time when fulfilled, the officer is re-considered for promotion and is allowed promotion with effect from the date when he was deferred. To the misfortune of the officer he stood retired from service w.e.f. i4.01.2015 and thus, remained deprived of the promotion to BS-22. The august Supreme Court of Pakistan, in the case of Orya Maabool Abbasi v. Federation of Pakistan through Secretary Establishment and others (2014 SCMR 817), held that "Although promotion was not a right but a civil servant fully qualified for promotion, has a right to claim that his case may be considered for promotion strictly following the eligibility criteria laid down by the authority, and that "though the officer not meeting eligibility criteria for promotion, could be deferred but the deferment could not be arbitrary and not supported by the service record. In this case, the apex Court further held that "Board failed to take into consideration the PER Reports for the reasons not tenable under the law and their such findings were clear violation and departure from the promotion policy because once the officer have fulfilled the criteria, their cases have to be considered to assess the fitness and suitability to share higher responsibility mostly based on subjective criteria instead of denying promotion to them for the subjective consideration".
- 14. It merit mention that the High Powered Selection Board remained stuck up with some report in the National Management Course (NMC), held from 3rd March, 2008 to 24th March, 2008. Though thereafter, the petitioner was promoted to BPS-21 in the year 2010, and those were considered and ignored, it seems that the High Powered Selection Board has not conducted itself in the manner required under the law. We are thus, fortified in our view by the judgments of the apex Court in Tariq Aziz-ud-Din (2010 SCMR 1301), Muhammad Rahim Khan v. The Chief Secretary, N.-W.F.P. and 4 others (1999 SCMR 1605), Orya Maqbool Abbasi v. Federation of Pakistan through Secretary Establishment and others (2014 SCMR 817), 2017 SCMR 969 Federation of Pakistan through Secretary, Establishment Division and others v. Dr. Muhammad Arif and others.
- 15. The petitioner though has retired from his service, but since his non-promotion has certainly effected his privileges and pension, therefore, in view of Fundamental Rules-17, he can be considered for promotion, even after retirement. Proviso to F.R. 17 is reproduced herein below:-
  - "[Provided that the [appointing authority may, if satisfied that a civil servant who was entitled to be promoted from a particular date was, for no fault of his own, wrongfully prevented from rendering service to the Federation in the higher post, direct that such civil servant shall be paid the arrears of pay and allowances of such higher post through pro forma promotion or upgradation arising from the ante-dated fixation of his seniority.]
- 16. For the reasons stated above, this petition is allowed and the respondents are directed to place the case of petitioner again before the High Powered Selection Board for consideration for promotion to BPS-22, if cleared be allowed promotion to BPS-22 from the date he was lastly deferred. The
