


Respected Sir.

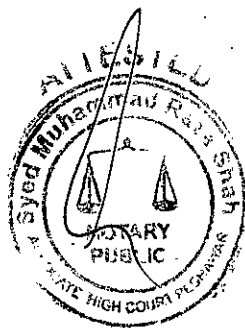
