### IMPLEMENTATION REPORT ON BEHALF OF RESPONDENTS NO. 2 & 3.

#### Respectfully Sheweth,

i. Incorrect, hence denied. In fact the petitioner / decree holder was initially appointed as Assistant Oral Master (BPS-09) on contract basis by the Erstwhile District Coordination Officer, D.I.Khan whose services were later on regularized. As far as the contention regarding upgradation of the various posts of teachers in BPS-16 & BPS-17, the respondent department has never upgradated such posts. However, the Finance Department, Government of Khyber Pakhtunkhwa has allowed (new) scale of pay effect vide Circular letter dated 24.07.1986 in term of awarding BPS-16 & BPS-17 as under (Annex-A):

а	Trained Graduate Teacher B.A/B.Sc, B.Ed with the adequate Knowledge in the Education of deaf to be certified by the Social Welfare Directorate.	B-17	
b	Un-trained Graduate and post-graduate Teachers (B.A/B.Sc.M.A/M.Sc) with adequate knowledge in the education of deaf to be certified by the Social Welfare Directorate.	B-16	These teachers must acquire B.Ed within a period of three years.

As evident from the above prescribed qualification for (new) scale of pay effect, the petitioner / decree holder was required to submit proper application alongwith academic / adequate knowledge certificate in relevant expertise (sign language) but during the

service period in the respondent department the petitioner could not become eligible accordingly. Since adequate knowledge certificate which is mandatory for the benefit prayed for and in the case of petitioner, the same could not be certified because he is no more a special education teacher. It is further to add here that the spirit of the (new) pay scale effect is an award to the Special Education Teachers in lieu of imparting formal education to the Special Children in inclusive method.

ii. Correct. However, due to filing of CPLA in the August Supreme Court (Annex-B) and none certification of the adequate knowledge in the relevant field, request of the petitioner could not be materialized.

In view of the above clarifications/explanations, it is therefore, humbly prayed that the instant Execution Petition may graciously be dismissed having no weight and being based on malafide intentions.




