**PARA WISE COMMENTS ON BEHALF OF RESPONDENT NO.01 TO 03.**

Respectfully sheweth:-

**PRELIMINARY OBJECTIONS**

- a. That the appellant has no cause of action or locus standi to file the instant appeal, as such the same liable to be dismissed.
- b. That the appeal is not maintainable in its present form.
- c. That the appellant has come to the tribunal with malafide intention.
- d. That the appellant has been estopped by his own conduct to file the appeal.
- e. That the appeal is barred by law and limitation.

**ON FACTS:-**

1. In-Correct. Hence denied. The appellant was performing his duty as Forest Guard at Unkar Forest Check Post (Annexure A), but his performance was not to the entire satisfaction of his superiors. The staff of Forest Check posts have been repeatedly directed/instructed regarding controlling of illegal movement of forest produce through proper checking of each and every vehicle crossing Forest Check Posts, but the appellant failed to do so. On 31/05/2022 a Hino Oil Tanker bearing hand written registration No. C-2602 loaded with 43 scants of Deodar timber having volume of 172 cft apprehended by staff of Lower Dir Forest Division at Shamardin. The said vehicle crossed Unkar Forest Check Post with active connivance of appellant Forest Guard. (Annexure B)
2. In Correct. Hence denied. The appellant was charge sheeted on the grounds that he has not performed his duty with devotion and honesty. As per Sub Divisional Forest Officer, Dir Forest Sub Division letter No. 71/Dir, Dated 02/06/2022 (Annexure C) reported that the said vehicle crossed the Unkar Forest Check Post

at 6:02 AM as evident from CCTV Camera video. Being Forest Guard it was his prime responsibility to ensure to close the barrier of the check post, obstructs and check vehicle to avoid illicit movement of Forest produce. The appellant was on duty at that night, but he did not bother to stop the oil tanker loaded with illicit timber and left the check post open to timber smugglers. The appellant has been proceeded under Government of Khyber Pakhtunkhwa Efficiency and Disciplinary Rules, 2011.

3. Correct. The appellant was proceeded as per Government of Khyber Pakhtunkhwa, Efficiency & Disciplinary Rules, 2011 under Rule 10 and in response to the charge sheet/statements of allegations, the appellant submitted his written reply to the inquiry officer appointed for the purpose thereof under the ibid rules.
4. In-Correct. Hence denied. The inquiry officer appointed for the purpose under the ibid rules has followed the procedure laid down under Rule 11 of the Government of Khyber Pakhtunkhwa Efficiency and Disciplinary Rules, 2011. The appellant has been provided proper chance of defense under the ibid rules and inquiry officer examining the written reply of the appellant and questions and answers recorded on personal hearing fixed on 22/02/2023 (Annexure D) in the office of the Divisional Forest Officer, Working Plan Unit-IV Kanjo Swat. The inquiry officer submitted his inquiry report to the competent authority under the Rule 11 of the ibid Rules, wherein the charges leveled against the appellant in charge sheet have been proved. Further the appellant has been provided proper chance of defense under the rules but he failed to prove himself innocent. **(Annexure E)**. Respondent No. 03, after receiving the inquiry report, being competent authority have satisfied that the inquiry has been conducted accordance with the provisions of the ibid rules Rule 14 (4) (a) informed the appellant about the charges proved and penalty or penalties imposed upon him. Provided reasonable opportunity of showing cause against the penalty or penalties imposed upon him vide letter No. 6687/Estt, dated 29/05/2023 (Annexure F) along with inquiry report and called for personal hearing on 04/07/2023 vide letter No.7172-74/Estt, dated 21/06/2023 (Annexure G). After fulfilled all the codal formalities under the ibid rules, office order No. 07, dated 14/07/2023 has been issued by the respondent No. 03. (Annexure H)
5. In-Correct. Hence denied. The appellant being aggrieved of the said order filed departmental appeal to respondent No. 02, being appellate authority, under Rule 17 of the Government of Khyber Pakhtunkhwa Efficiency and Disciplinary Rules, 2011. The appellate authority respondent No.02 called the competent authority respondent No.03 for record of the case and comments on the points raised in the appeal of the appellant vide letter No. 857/E, dated 21/08/2023. (Annexure I) The respondent No. 03 submitted the comments vide letter No. 886/Estt, Dated 29/08/2023. (Annexure J) Subsequently the appellant has been called for

personal hearing on 28/09/2023 vide letter No. 1561-65/E, Dated 21/09/2023 (Annexure K) and after hearing the appellant by appellate authority, the penalty ordered vide office order No. 07, Dated 14/07/2023 has been converted to reduction to initial stage of pay for period of three years vide respondent No. 02 office order No. 11, dated 11/11/2023. (Annexure L)

- 6. Correct. To the extent of record.
- 7. Pertains to record.

**GROUNDS:**

- A. In-Correct. Hence denied. The punishment awarded to the appellant by the appellate authority is in accordance to law, facts, norms of natural justice and materials on record,
- B. In-Correct. Hence denied. Proper enquiry has been conducted by the inquiry officer against the appellant under Government of Khyber Pakhtunkhwa Efficiency & Disciplinary Rules, 2011 and the punishment has been awarded after fulfillment of all the codal formalities on the subject as mentioned above.
- C. In-Correct. Hence denied. The respondent No. 03 Divisional Forest Officer, Upper Dir Forest Division has been informed by the respondent No,02 Conservator of Forests, Malakand West Forest Circle vide letter No.6149-51/G&L, dated 02/06/2022, (Annexure M) about the apprehension of the vehicle loaded with illicit timber by staff of Lower Dir Forest Division and directed to take disciplinary action against the staff posted at check post. As the vehicle apprehended has actually been originated from Upper Dir crossed the Unkar Forest Check post with active connivance of the appellant posted at Unkar Forest Check post. The difference between registration No. of vehicle booked in damage report and charge sheet is actually typing mistake.
- D. In-Correct. Hence denied. Proper enquiry has been conducted by the inquiry officer as provided under Rule 11 of Government of Khyber Pakhtunkhwa Efficiency & Disciplinary Rules, 2011 and proper chance of defense has been provided to the accused.
- E. In-Correct. Hence denied. The appellant has been associated in whole process of the inquiry and every possible chance of defense has been provided to the appellant under the rules. As proper chance of written defense has been provided by the enquiry officer to the appellant, personal hearing has been provided by the enquiry officer to the appellant, personal hearing has been conducted by the inquiry officer before submitting the inquiry report. Furthermore before imposing any penalty, proper show cause notice has been issued to appellant vide letter No. 6687/Estt, dated 29/05/2023, informing about the imposition of penalty along with enquiry report and personal hearing has been conducted on 04/07/2023 in the office of the Divisional Forest Officer, Upper Dir Forest Division, being competent authority

respondent No. 03. Furthermore personal hearing has also been held in the office of the Conservator of Forests, Malakand West Forest Circle, being appellate authority on 28/09/2023.

F. In-Correct. Hence denied. The appellant has been associated in the inquiry process and Proper chance of defense has been provided to the appellant under the rules as three times chance of personal hearing/defense has been provided.

G. In-Correct. Hence denied. The appellant was posted at Unkar Forest Check Post and as per his written statement/reply submitted to the inquiry officer; he made confession that at night of incidence he was present at check post. Furthermore as per report submitted by Sub Divisional Forest Officer, Dir Forest Sub Division vide his letter No.71, dated 02/06/2022, the appellant was present on duty at the night of incident.


H. That the respondents also seek permission to raised further points at the time of arguments.

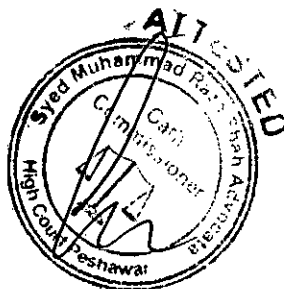





1. BRIEF HISTORY.

The Divisional Forest Officer, Lower Dir Forest Division apprehended a vehicle Hino Oil tanker registration No. C-2605 loaded with illicit timber of Deodar = 172 cft. Subsequently chalked damage report No. 527/6, dated 02/06/2022. The matter was investigated and it comes to the surface that the said vehicle loaded in Kalkot Dir Kohistan, crossed the sheringal Forest Checkpost in Dir Kohistan Forest Division and Unkar, Sahibabad, Warri and Akhgram Forest Checkpost of Upper Dir Forest Division without any hesitation. Which was further authenticated through video clip provided by DFO Dir Kohistan that the vehicle crossed Sheringal Forest Checkpost.

Divisional Forest Officer, Upper Dir Forest Division called explanation of the Sub Divisional Forest Officer/Range Forest Officer vide letter No.6337-39/G, dated 02/06/2022, as per directives of Conservator of Forests, Malakand West Circle letter No. 6149-51/G&L, dated 02/06/2022. On receipts of the reply of SDFO/RFO, Divisional Forest Officer, Upper Dir Forest Division charge sheeted staff including Mr. Siddiq-ur-Rehman, Mr. Mushtaq Ahmad Forest Guard and Muhammad Farooq Barrierman of Unkar Forest Checkpost, Mr. Saif-ul-Islam Forest Guard Sahibabad Forest Check post, Mr. Aziz Ullah, Forest Guard and Mr. Niaz Muhammad Barrierman of Warri Forest Check post and Mr. Muhammad Rafiq Forest Guard of Akhgram Forest Check post on account of inefficiency, misconduct under Rule, 3 of Government of Khyber Pakhtunkhwa Efficiency & Disciplinary Rules, 2011 and ordered a proper enquiry vide office order No. 46, dated 02/02/2022. Entrusted fact finding enquiry to Mr. Murad Ali Shah, DFO Patrol Squad Forest Division, Malakand West Forest Division. But due to the posting of Mr. Murad Ali Shah as Divisional Forest Officer, Upper Dir Forest Division the enquiry was entrusted to the undersigned the then SDFO Litigation Dir Upper vide DFO Upper Dir office order No.92, dated 22/06/2022 to investigate the matter in connection with charges/allegations leveled against the checkpost staff in the charge sheets and statement of allegations under section 5(1) of the Government of Khyber Pakhtunkhwa, Efficiency & Disciplinary Rules, 2011.

3. BRIEF DESCRIPTION OF THE CASE.

Whereas, Divisional Forest Officer, Upper Dir Forest Division regular issues instructions regarding control of illegal movement of forest produces through proper checking of each and every vehicle crossing forest check post, but staff of forest check post failed to do so. Due to their inefficiency and not following the instructions of the higher ups an Oil tanker bearing registration No. C-2605 loaded with illicit timber crossed the checkposts in the jurisdictions of Upper Dir Forest Division and later on apprehended by the staff of Lower Dir Forest Division.

As per report of the SDFO Dir the said vehicle crossed the Unkar Forest Chekpost morning at 6:2 Am leading by a car (Rav-4) without any hesitation and the barrier of check post was open. The SDFO Dir further reported that Mr. Siddiq-ur-Rehman Forest Guard and Farooq Barrierman was on duty at that night and recommended to take strict disciplinary action against them under the rules, as they have failed to perform their duty. Besides that Mr. Mushtaq Ahmad Forest Guard is posted at Unkar Forest Check post.


The staff of Sahibabad Forest checkpost also failed to stop the vehicle loaded with illicit timber and RFO Darrora submitted that Mr. Saif-ul-Islam Forest Guard was on duty at that night. While SDFO Warri reported that there was a fault in the CCTV camera installed on Warri Forest Checkpost and did not determined the exact time on which vehicle crossed the Warri checkpost and reported that Mr. Aziz Ullah Forest Guard and Mr. Niaz Muhammad Barrierman were on duty at the night in Warri Forest Checkpost and Mr. Muhammad Rafiq Forest Guard at Akhgram Forest Checkpost. They all failed to stop and properly check the vehicle.

4. PROCEEDINGS.

After receiving the charge sheet/statement of allegations the accused official was directed to submit their written replies to the charge sheet/statement of allegations before the enquiry officer, the then Sub divisional Forest Officer, Litigation now SDFO Working Plan Unit-IV Swat for further proceeding in the matter.

The accused officials submit their written replies to the undersigned and after receipt of the reply of the accused, date for personal hearing has been fixed on 20/02/2023 in the office of Divisional Forest Officer, Working Plan Unit-IV and directed the accused official to appear before the undersigned on scheduled date, time and venue. Furthermore Divisional Forest Officer, Upper Dir Forest Division has been requested to nominate Departmental representative to attend the proceeding on due date.

Personal hearing of the accused has been conducted and cross questions have been asked from the accused in front of the departmental representative nominated by DFO Upper Dir. Written statement of the accused has been recorded during the personal hearing.

5. FINDINGS.

As Forest Check Post is established under Section 58 of Forest Ordinance, 2002 to regulate the legal timber transported under transport pass issued by Divisional Forest Officer concerned. And discourage illegal movement of forest produce and take strict legal action under Forest Ordinance, 2002. Being Forest Guard posted at forest check post, it is their prime responsibility to check each and every vehicle crossing check posts and make proper entry into relevant register maintained for the purpose.

As it is ascertained from the video of CCTV camera installed at Unkar Forest checkpost that the barrier of the checkpost was opened and the said vehicle crossed the checkpost without any barrier and the checkpost staffs were not visible in the video.


Mr. Siddiq-ur-Rehman Forest Guard in his written statement and during personal hearing stated that he was present at that night, performed duty from 11:00 PM to 3:00 AM and after that due to intense fatigue handover the duty to Mr. Farooq Barrierman and the vehicle loaded with illicit timber crossed the checkpost during his duty time.

Mr. Farooq Barrierman stated in his written statement that he performed duty from 2:00 AM to 5:00 AM and the said vehicle crossed the vehicle during duty time of Mr. Siddiq-ur-Rehman. While it has been ascertained from the video that during crossing the checkpost he was present on duty and sitting in the cabin of checkpost, giving non verbal gesture to the pilot Rav-4 vehicle and after few minutes the said vehicle crossed the check post without stopping on the checkpost. The statement of Farooq mentioning that he has not given any chance of complaint during his 33 years of service were denied by the departmental representative and informed that he is already under enquiry in the same nature case and also recently a show cause notice has been issued to him.

Mr. Mushatq Ahamd Forest Guard were on routine leave and not present on duty, which was further confirmed from the attendance register of the checkpost and stated that he is not involved in any kind of irregularity.

Mr. Saif-ul-Islam Forest Guard was posted at Sahibabad Forest check post and was present on that night on duty. From perusal of his written statement and during personal hearing he confirmed his presence on checkpost at that night but does not observed the passing of the said vehicle. He sated stated that he was alone performing duty on Sahibabad Forest check post and so many time requested RFO Darrora for posting of another Forest Guard and barrierman to avoid any unpleasant accident. Further stated that may be the vehicle crossed on the alternative road or during have taking breakfast. Beside that he stated that he has also

performed additional duty of nurseries and forest beat, due to which it is impossible for him to perform duty 24 hours 7 days a week on checkpost.


Mr. Aziz Ullah Forest Guard, Incharge Warri forest check post were also charge sheeted on account of failure to perform his duty efficiently. Mr. Aziz Ullah Forest Guard in his written statement and during personal hearing informed that he was not present at Warri Forest Checkpost because in addition to checkpost duty he has also perform duty of Badalai forest beat and was in Badalai beat for transportation of apprehended timber in Damage report No. 1068/22 dated 27/05/2022. The CCTV camera installed on Warri Forest Checkpost were not functional on that night and being incharge it was his responsibility to made all arrangements for working of the CCTV camera. He stated that the CCTV camera were recording video in presence of electricity and when electricity was not available the CCTV camera does not worked as there is no solar facility available in the Warri Forest Checkpost due to which the video has not been recorded at that morning. He also complaint about the burden of additional duty of plantations and beats.

Mr. Niaz Barrierman were also charge sheeted and perusal of his written statement and personal hearing he stated that he was on check post at that night and perform duty from 8:00 PM to 4:00 AM and after that handover the duty to Levy Sepahi Mr. Liaqat Ali and left the checkpost to pray Fajar prayer and after that he was slept and when waked it was 7:00 Am morning and does not observed the said vehicle.


At Akhgram Forest check Mr. Muhammad Rafiq Forest Guard were charge sheeted on account of failure to apprehend the said vehicle and does not perform his duty efficiently. He also denied the charges and stated that he was present on duty at that night, performed his duty honestly and does not observe the vehicle.


**6. CONCLUSION.**

Keeping in view the written statements of the accused officials, personal hearing and available record it comes to the surface that the staff of Forests check post does not perform their duty efficiently and due to their laxity and casual attitude the Hino Oil tanker having registration No.C-2605 loaded with illicit timber of deodar crosses the checkpost without any hesitation or stopping on the forest checkpost. A contradiction was observed in the statement of Mr. Siddiq-ur-Rehman FG and Mr. Farooq Barrierman and instead to take responsibility blaming one another. Mr. Mushtaq Ahmad Forest Guard was on routine leave at that night and does not seems to be responsible, while other staff of checkpost are equally responsible for not performing their duty as per their job description. The competent authority may proceed further against the accused officials in the light of Efficiency & Disciplinary Rules, 2011as deemed appropriate.





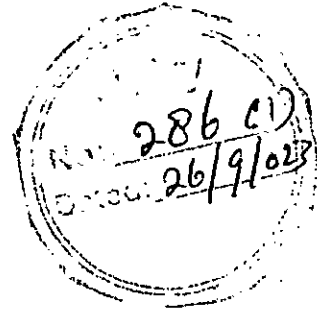

5. Whereas, the accused Official was awarded major penalty of "REMOVAL FROM SERVICE" vide DFO Upper Dir Office Order No. 07 dated 14/07/2023.
6. Whereas, the appellant being aggrieved with the penalty awarded by DFO Upper Dir, filed the departmental appeal to the undersigned (appellate Authority) requesting to set aside the penalty.
7. Whereas, Para wise comments were asked form DFO Upper Dir vide this office letter No.257/E, dated 21/08/2023. The DFO Upper Dir furnished the requisite comments vide his office memo No.886/Estt., dated 29/08/2023. On receipt of the comments, the appellant was provided opportunity of being heard / Personal hearing on 28.09.2023 in the office of Conservator of Forests Malakand West Forest Circle vide memo No.1561-65/E dated 21/09/2023.
8. Whereas, on perusal of record, comments of the D.F.O Upper Dir and personal hearing of the appellant the facts surfaced that the illegal timber was transported in Hino Oil Tanker bearing Registration No.C-2605 and has crossed Unkar Forest Check Post with active connivance of appellant. Hence the charges leveled against him are proved with certainty.

ORDER:-

I Mr. Shaukat Fiaz Conservator of Forests Malakand West Forest Circle Timergara in the capacity of appellate authority hereby convert the penalty of "REMOVAL FROM SERVICE" to reduction to initial stage of his pay Scale for a period of Three (3) years and the intervening period from 14/07/2023 to 10/10/2023 is treated as leave without pay.
