



- 3) That after going through the requisite procedure, appellant was appointed as Blood Bank Technician B-9 on the recommendation of Departmental Selection Committee DSC vide order dated 25.06.2013 by Respondent No.1 and assumed the charge of the said assignment on 26.06.2013. (Annex: "D and E").
- 4) That without any reason and justification, order of appointment of appellant was made cancelled by Respondent No.1 vide order dated 26.07.2013 on the directions Respondent No.2 to appoint his nominee, Respondent No.4. (Copies Annex: "F").
- 5) That on 29.07.2013, appellant submitted representation before respondent No.2 for reinstatement in his service but the same met dead response till date. (Annex: "G").

Hence this appeal, inter alia, on the following grounds:


### **GROUND**

- A. That appellant was appointed as such after following the prescribed legal procedure for appointment by the department.
- B. That advertisement was floated and on the recommendations of Departmental Selection Committee, order of appointment of appellant was issued.
- C. That the said appointment order was acted upon, implemented and got finality, and cannot be dispensed with at single stroke of pen.
- D. That neither appellant was served with any notice nor any enquiry, being mandatory, was ever conducted, so the impugned order is of no legal effect.

- E. That vested rights of appellant were infringed for ulterior motive to appoint Respondent No.4, the nominee of the Senator of area on the said post.
- F. That the impugned order is based on malafide and misuse of power by the authorities, so is of no legal effect.


