Appeal under Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974, against the promotion order dated 26.06.2015 never communicate to the appellant, the appellant came to know in August 2015, hence the served departmental appeal dated 25.08.2015 however it was not considered nor replied with the statutory period of 90 days.

Prayer in appeal:

On acceptance of this appeal, the appellant may please be considered as deferred for promotion when the promotion order dated 26.6.2015 was issued and be allowed promotion w.e.f 26.06.2015 by allowing him all arrears and consequential seniority.

EComposer (Energy (Soulynum et food):

1. That the appellant was initially appointed in a project namely Dar ul Kifala for Male Beggars, Peshawar on 19.08.2006. (Copy of the appointment letter dated 19.08.2006 is attached as Annexure A)

2. That during the course of his service regular posts were sanctioned for Dar ul Kifala for Male Beggars, Peshawar, and it was brought on regular side, accordingly vide office order dated Q8.06.2007, the services of the appellant were regularized w.e.f 1.07.2007. (Copy of the office order dated @8.06.2007 is attached as Annexure B)

- 3. That the respondent No. 4 to 6 were also project employees and their services also stood regularized under the orders of the Govt on the regularization of their project, albeit were much junior to the appellant.
- 4. That in accordance with recruitment rules 33% quota has been reserved for promotion to the post of Junior Clerk from amongst class IV employees having passed matriculation certificate. (Copy of the Rules are attached as Annexure C)
- 5. That recently the appellant came to know that the respondents have made promotion to the post of Junior Clerk BPS-11 vide office order dated 26.06.2015, the appellant however when came to know about the order got its copy, in August 2015 and found that many juniors were promoted to the post of Junior clerk BS-11 ignoring and not promoting the appellant. (Copy of the promotion order is attached as Annexure D)
- 6. That the appellant submitted his departmental appeal dated 25.07.2015 however no action was taken thereon despite the lapse of 90 days. (Copy of the departmental appeal dated 25.08.2015 is attached as Annexure E)
- 7. That not allowing and ignoring the appellant for promotion is illegal, unlawful authority, against the rules and law inter alia on the following grounds: -

<u>GROUNDS OF APPEAL:</u>

- a. That the appellant has not been treated in accordance with law and his rights secured and guaranteed under the law have been recklessly violated.
- b. That the acts and omission of the respondents in excluding the name of the appellant and not considering him for regular promotion is illegal, in violation of law, without lawful authority and against the rights of the appellant.

- c. That the appellant is perfectly qualified and cligible to be considered for promotion, however the respondents acted illegally by allowing promotion to the Juniors seriously affecting the rights of promotion of the appellant.
- d. That quite malafide the respondents have made promotions from other districts ignoring the overall seniority of the directorate, the post of junior Clerk being provincial cadre post no promotion/ appointment can be made from the seniority maintained at district level, the promotions so made are thus not in accordance with law.
- e. That promotion 33 % quota is to be filled on the overall strength of the Social Welfare Directorate, then how the impugned promotions were made in violation of law and seniority position in the Directorate.
- f. That the appellant has not treated been in accordance with law and he remained throughout deprived of his regular promotion due to in action/ slackness of the respondents thus the respondents are bound to follow the law and to act in accordance with law.
- g. That the appellant seeks the permission of this Honourable. Tribunal to rely on additional grounds at the hearing of this appeal.

It is, therefore, humbly prayed that On acceptance of this appeal the appellant may please be considered as deferred for promotion when the promotion order dated 26.6.2015 was issued and be allowed promotion w.e.f 26.06.2015 by allowing him all arrears and consequential seniority.
