ii. Furthermore, as per practice in vogue the said residential accommodations are allotted by various authorities including principal RPDC as is evident from letter No. 665, dated 02/07/2022, No. 668, dated 05/08/2022, No. 2254-59, dated 13/04/2017, No. 4213-18, dated 07/03/2019, No. 2586-93, dated 19/03/2022 under these which all allotments including that of appellant has been confirmed. - iii. The principal RPDC Jamrud in his letter No. 694 dated 08/10/2022 addressed to the Director Professional Development, Khyber Pakhtunkhwa has clearly mentioned that he has allotted all the quarters on merit and has shared the same with DPD (Letter dated 08/10/2022 is annexed as Annexure "M").
- iv. As evident from Annex, the residential accommodations of Four (04) Bedrooms have been allotted to BPS-14 teachers and even to a Junior Clerk of Civil Secretariat, Peshawar.
- 9. The reply is incorrect and misleading. There is no such order of the court for vacation of accommodation as asserted. The fact may be confirmed from the judgment as per Annexure "E" of the appeal, a copy of which has also been submitted by the respondent with the reply.

GROUNDS:

The respondent have not replied para A to G of the grounds as per its contents and only detailed about the deduction of House Rent etc. The deduction at prescribed rates are to be made which is an exercise of respondents and having no objection by the appellant.

In view of the above, it is, therefore, most humbly prayed that an appeal of the appellant may very graciously be accepted and relief granted as prayed for.
