Appellant with counsel present. Preliminary arguments heard and record perused.

According to the stance of the appellant his actual date of birth is 1.12.1960 which is reflected in the documents of the appellant as well as record relating to his service affairs except service book. The respondents, as per stance of the appellant, are bent upon retiring the appellant on the basis of erroneous date of birth mentioned in his service book as 01.06.1956 despite the fact that the actual date of birth of the appellant is 1.12.1960.

Since respondents have not taken any steps for retirement of appellant on the basis of alleged erroneous date of birth i.e. 01.06.1956 as such no order, original or final, exists against the appellant and impugned before the Tribunal. Therefore the appeal not found maintainable at this stage.

In view of the afore-stated position learned counsel for the appellant requested for withdrawal of appeal.

Dismissed as withdrawn with the observations that the respondents shall consider the grievances of the appellant at their level prior to retiring the appellant from service. File be consigned to record room.





Appeal Under Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974 for correction and entering the correct date of birth of the appellant in the Service Book which is 01.12.1960 while in Service Book it has inadvertently and mistakenly entered as 01.06.1956 which is wrong, against the facts and ineffective upon the rights of the appellant.

**Prayer:**

On acceptance of this appeal the respondent may graciously be directed to permanently enter the correct date of birth of the appellant in their record i.e. Service Book as 01.12.1960 instead of 01.06.1956.

**Respectfully Sheweth,**

Brief facts of the instant appeal are as under:

- 1) That the appellant on 15.12.1980 was appointed as Class-IV in the Services and General Administration Department whereby his date of birth was mentioned in the Service Book as 01.06.1956.
- 2) That in the year 1984 the appellant passed his Matric exam and his date of birth in the Matric Certificate was very rightly mentioned as 01.12.1960. (Copy of DMC is attached)
- 3) That upon the application of the appellant the entry of qualification was made in the service book and the appellant promotion was made on the basis of seniority list.
- 4) That keeping in view the seniority list the appellant promotions were made time to time and on 02.11.2015 he was promoted as Superintendent in BPS-17.
- 5) That a month before the appellant came to know that upon the basis of entry of wrong date of birth in the service book i.e. 01.06.1956 the respondents are going to issue a notification of giving pension to the appellant, the appellant made applications to the respondents to correct his date of birth in the service book which is 01.12.1960 instead of 01.06.1956, but

the appellant was informed verbally to approach to the honourable tribunal for his redressal.

- 6) That not correcting the date of birth in the service book is against the rights of appellant, hence the instant appeal inter alia o the following amongst other grounds.

### **GROUND**

- a) That entry in the service book of the date of birth of the appellant i.e. 01.06.1956 is totally wrong, made inadvertently while the correct date of birth of the appellant is 01.12.1960 which is very much evident form the matric certificate issued in the year 1984.
- b) That in the National Identity Card as well as in the service card the appellant date of birth is very rightly mentioned as 01.12.1960.
- c) That in the monthly pay slips issued by the Accountant General, KPK, the correct date of birth of the appellant has been mentioned which is 01.12.1960.
- d) That it is astonishing that seniority list which is maintained by the department from the very start and through which the promotions has been awarded to the appellant, their his date of birth has very rightly mentioned as 01.12.1960, *while it is furthered to mention that according to the Seniority list the date of retirement of appellant become 30-11-2020.*
- e) That according to the Service Rules (GFR Sec 116) the date of birth must be confirmed from Matric

certificate, Municipal Birth Certificate and, hence all the documentary evidence fully suggests that actual date of birth of the appellant is 01.12.1960 which is required to be correct in the service book.

- f) That appellant moved his grievance to the Administration / respondents but no needful has been done till date while verbally the appellant has been instructed to move to the honourable court / tribunal for the redressal of his grievances.
- g) That all the documentary evidence as well as official record itself and seniority list crystal cleared proved that actual date of birth of the appellant is 01.12.1960 and not 01.12.1956.
- h) That it is the fundamental and legal right of the appellant that correction in the service book in regard of date of birth is require to be made / corrected according to the documentary evidence and if it is not done the appellant will not only suffer an irreparable loss but also his fundamental rights will be infringed.
- i) That the appellant on attaining the age of superannuation will going to be retired in 2020 while upon the wrong and incorrect entry of date of birth the department / respondents are going to issue a pension notification which is against the law and ineffective upon the rights of the appellant.

It is, therefore, most humbly prayed that on the acceptance of this appeal the respondents may graciously be directed / instructed to enter the correct date of birth of the appellant in his Service Book as 01.12.1960 instead of 01.06.1956.
