#### **PRELIMINARY OBJECTIONS:-**

Khyber Pakhtukhwa Service Tribunal

- 1. That the appeal is badly barred by law & limitation.
- 2. That the appeal is bad for mis-joinder and non-joinder of necessary and proper parties.
- 3. That the appellant has no cause of action and locus stand to file the instant appeal.
- 4. That the appellant has not come to this Honorable Tribunal with clean hands.
- 5. That the appellant is estopped due to his own conduct to file the instant Service Appeal.
- 6. That the appellant is trying to conceal the material facts from this Honorable Tribunal.

#### **FACTS:-**

- 1. Para No. 01 pertain to the appellant record needs no comments.
- 2. Incorrect. Perusal of record reveals that the appellant was found an irresponsible and efficient Police Officer as he remained absent from his lawful duty for a long period of 365 days in different occasions for which he was awarded several punishments including one time dismissal from service, in this regard there are 09 bad entry with no good entry in his credit. (Copy of bad entries attached herewith as annexure "A").
- 3. Incorrect. The appellant remained absent from lawful duty with effect from 27.10.2022 till to the date of his removal from service i.e 21.01.2023 for a long period of 02 months and 15 days without any leave or prior permission of the competent authority. The plea of flood taken by the appellant in the Para is a propounded story and he was supposed to have taken this plea before the Enquiry Officer or before the competent authority during the course of enquiry. (Copy of absence report attached herewith as annexure "B").
- Incorrect. The appellant was willfully absented from his lawful duty without any leave or prior permission of the competent authority and also failed to submit any application.
- 5. Incorrect. The appellant continuously remained absent from duty and deliberately failed to report his arrival or to submit reply of Show Cause Notice, earlier issued to him vide No. 252/FRP dated 03.11.2022. Moreover, the appellant was dealt with proper enquiry under the law/rules and during the course of enquiry the appellant was summoned time and again by the Enquiry Officer through written Parwana to submit his reply of Charge Sheet and to join the enquiry proceedings issued vide No. 492, dated 29.11.2020, but he did not

turn up, meaning thereby that he was not more interested in the service of Police Department. (Copy of Urdu Parwana attached herewith as annexure "C"). Hence, he was issued Final Show Cause Notice but he again failed to submit reply in his defense. Besides, a sufficient opportunity of defense has also been provided to him as he was called in orderly room time and again by the competent authority, but he did not turn up.

- Incorrect. As discussed in the preceding Para above on the allegations of willful absence the appellant was proceeded against proper departmental and after fulfillment of all codal formalities he was awarded major punishment of removal from service as per law/rules.
- 7. For disposal of departmental appeal the appellant was called and heard in person by the appellate authority in orderly room held on 28.04.2023, but he failed to present any justification regarding to his innocence thus his departmental appeal was rejected / announced in the presence of appellant.
- 8. Incorrect. Departmental appeal submitted by the appellant was thoroughly examined and rejected on sound grounds and a copy of such order had already been conveyed to the appellant on his home address vide this office order Endst; No. 4155-56/SI Legal, dated 02.05.2023.
- 9. Incorrect. The appellant has not come to this Honorable Tribunal with clean hands and he was no cause of action hence, this appeal being devoid of merits may kindly be dismissed on the following grounds.

#### **GROUNDS:-**

- a. Incorrect. Both the orders issued by the respondents No. 02 & 03 are legally justified and accordance to law/rules.
- b. Incorrect. As the appellant was proceeded against departmentally under Police Rules 1975 amended in 2014, which is applicable law to the case of appellant. Thus the respondent did not commit any violation of law/rules in the case of appellant.
- c. Incorrect. The allegations are false and baseless. In fact, the Charge Sheet alongwith Summary of Allegations were issued and served upon the appellant by the Enquiry Officer and his signature was obtained as a token of receipt. (copy of receipt attached herewith as annexure "D"). However, the appellant failed to submit his reply or to appear before the Enquiry Officer, despite the facts he was summoned time and again. (Copy of Charge Sheet is attached herewith as annexure "E").
- d. Incorrect. Proper departmental enquiry was conducted against the appellant and was awarded major punishment of removal from service, which is legally justified and in accordance with law/rules. (Copy of enquiry report is attached herewith as annexure "F").
- e. Incorrect. Upon the findings of Enquiry Officer the appellant was issued Final Show Cause Notice, but he failed to submit his reply. A sufficient opportunity of defense in the shape of personal hearing has also been offered to the appellant, but he deliberately failed to avail this opportunity. (Copy of Final Show Cause Notice is attached herewith as annexure "G").
- f. Incorrect. As the appellant remained absent from lawful duty for a long period of 02 months and 15 days without any leave or prior permission of his seniors. The plea of flood detriment and critical situation contented by the appellant is a propounded story by which he trying to cover his prolong absence.
- g. Incorrect. The allegations are false and baseless and just to mislead this Honorable Tribunal. In fact, on the allegations of willful absence the appellant was earlier issued as Show Cause Notice, but he failed to submit his reply or to

join his duty. Thereafter, proper departmental enquiry was initiated against him as he was issued Charge Sheet alongwith Summary of Allegations vide No. 2096-97/FRP dated 25.11.2022 and Enquiry Officer was nominated. After completion of enquiry, the Enquiry Officer submitted his findings, wherein the appellant was found guilty of the charges leveled against him and recommended for major punishment. Upon the findings of Enquiry Officer, he was issued Final Show Cause Notice and served upon him through special messenger and his signature was obtained on the photocopy of the said notice, but he did not bother to submit his reply. Besides, a sufficient opportunity of defense has also been provided to him as he was called in orderly room time and again by the competent authority, but he did not turn up. Thus the removal order issued by the respondent No. 03 vide OB No. 46/FRP, dated 12.01.2023 is legally justified and in accordance to law/rules.

Incorrect. As earlier the appellant was dismissed from service on account of h. willful absence for which he later on reinstated in service by taking lenient view, but he did not mend his way and again repeated the same practice. Therefore, any leniency would further embolden the appellant, and impinge upon adversely on the conduct of Police Force.

The respondents may also be permitted to raise additional grounds at the time i. of arguments.

## **PRAYERS:-**

Keeping in view the above facts and circumstances, it is most humbly prayed that the instant service appeal being devoid of merits may kindly be dismissed with costs please.

According to daily diary report No.55 dated 14.09.2020 of Police Static Cantt: DIKhan, he remained absent from law full duties with effect from 14.09.20% without any leave or permission from the competent authority. He reported back he arrival on 13.10.2020 vide daily diary report No.44 dated 13.10.2020 of Police Station Can DIKhan, total absence period comes (29) days.

On the basis of above, show cause notice was served upon him of 17.09.2013. He was required to submit the reply of Show Cause Notice within stipulate period but he failed to do so. He was charge sheeted. SI Kifayat Ullah of FRP DIKha Range was nominated as Enquiry Officer to unearth the actual facts. After completion all codal formalities. The Enquiry Officer submitted his finding report along with oth relevant papers. The defaulter Constable was found guilty of the charges leveled agair him and Enquiry Officer recommended to treat his absence period as without pay and al for suitable punishment. From the perusal of his service record it revealed that the defaulter was enlisted as Constable on 17.09.2013, he remained absent form lawful dutifor 91 days, awarded minor punishment of confinement to quarter guard for 01 day an extra drill for 05 days previously.

Keeping in view the facts stated above, <u>I MR. NISAR KHAN</u>, Superintendent of Police FRP D.I.Khan Range, D.I.Khan, in exercise of powers vested in me under Khyber Pakhtunkhwa Police Disciplinary Rules-1975 amended-2014 is hereby awarded minor punishment of **Fine Rs.1000/-** and his absence period i.e 14.09.2020 to 13.10.2020 total (29) days is also treated as leave without pay.
