


- 2- That the abovementioned appeal is instituted against the appellate order dated 24-08-2015 whereby the Departmental appeal of the appellant for the grant of promotion to the post of PHC Technician (M.P) BPS-14.
- 3- That the grievance of the appellant has been redressed by the respondents, therefore the appellant is no more entrusted to pursue the instant case.

- 1- That appellant having the requisite qualification for the post of Sanitary Inspector (BPS-6) was appointed in the respondent Department as Sanitary Inspector (BPS-06) on the recommendations of proper Departmental Selection Committee vide order dated 25-07-1979. That in response to the appointment order dated 25-07-1979 the appellant submitted his arrival report and started performing his duty quite efficiently and up to the entire satisfaction of his superiors. Copy of the service book is attached as annexure **A.**
- 2- That during the course of service the appellant was promoted to the post of Tehsil sanitary Inspector (BPS-9) vide order dated 1.12.1993 and later on was promoted to the post of District Sanitary Inspector (BPS-10). Copy of the service book is already attached as annexure**A.**
- 3- That vide Government of NWFP now Khyber Pakhtunkhwa Health Department Notification dated 25-08-2006 the competent authority approve 08 stages paramedics Service structure of Khyber Pakhtunkhwa. That the post of the appellant was re-designated in BPS-12 from BPS-10 with nomenclature of technician. Copy of Notification is attached as annex **B.**
- 4- That according to the seniority list of Sanitary Inspectors of the respondent Department the appellant was shown at serial No.3 of the said seniority list circulated on 30.6.2000 but astonishingly after up gradation to BPS-12 the name of the appellant was not enlisted in the seniority list of PHC Technician (MP) (BPS-12) circulated on 23.4.2012. Feeling aggravated the appellant filed application for inclusion of his name in the said seniority list. Copy of the seniority lists are attached as annexure **C and D.**
- 5- That later on the appellant was informed through letter dated 14.11.2012 that his name has been enlisted in the seniority list of PHC technician. That vide Notification dated 6.12.2013 the respondents issued seniority list due to which the appellant was enlisted at serial No.2 of the seniority list of PHC technician (BPS-12). That due to non inclusion of the name of appellant in the previous seniority list issued by the respondents the appellant was ignored from further promotion to the post of (BPS-14) and to the post of technologist (BPS-17) though his colleagues and junior colleagues were promoted vide order dated 29.8.2012. Copies of the letter, seniority list and promotion order are attached as annexure **E, F and G.**

- 6- That feeling aggrieved the appellant prefer Departmental appeal but the same was regretted by the respondent No.1 on no good grounds. Copies of the Departmental appeal, forwarding letter and rejection order are attached as annexure **H, I and J.**
- 7- That having no other remedy the appellant filed the instant appeal on the following grounds amongst the others.

GROUND:

- A- That the inaction of the respondents by not allowing/ granting promotion to the post of PHC Technologist multy purpose (BPS-17) is against the law, facts and norms of natural justice.
- B- That the impugned appellate order dated 24.8.2015 issued by the respondent No.1 is against the law, facts, norms of natural justice and materials on the record hence not tenable and liable to be set aside.
- C- That the appellant has not been treated by the respondent Department in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of the constitution of Islamic Republic of Pakistan 1973.
- D- That the respondent Department acted in arbitrary and malafide manner by not allowing/ granting promotion to the appellant to the post of PHC Technologist M.P (BPS-17).
- E- That the appellant has been discriminated by the respondent Department on the subject noted above and as such the respondent violated the principle of natural justice.
- F- That not allowing/ granting promotion to the appellant the respondents violated section-9 of the civil servant Act 1973 read with Rule-7 of the appointment, promotion and transfer Rules 1989.
- G- That according to Article 38 sub Article e the state is bound to reduce disparity in the income and earnings of individuals, including persons in the various classes of the service of Pakistan.
- H- That the appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore most humbly prayed that appeal of the appellant may be accepted as prayed for.








NOTIFICATION

NO. SOH-III /8-60/05 (Paramedics). In supersession of this Department's Notification of even number dated 10th May 2006 and in pursuance of the decision taken by the Provincial Cabinet in its meeting held on 27th December 2005, the Competent Authority is pleased to approve eight stage Paramedics Services Structure of NWFP as follows:-

- (1) The existing 57 different categories of Paramedics at annex A are restructured into 14 cadres as annexure B.

- (4) Seniority of the incumbents of the posts in the 14 cadres so merged shall be caused on the basis of scale wise seniority as well as date of regular appointment in the pay scale.
