SERVICE APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNALS ACT, 1974 AGAINST THE IMPUGNED NOTIFICATION DATED 24.08.2023 WHEREBY APPELLANT HAS BEEN IMPOSED UPON MAJOR PENALTY OF DISMISSAL FROM SERVICE AGAINST WHICH HE PREFERRED DEPARTMENTAL APPEAL BUT DISMISSAL FORM SERVICE WAS CONVERTED INTO REMOVAL FORM SERVICE VIDE IMPUGNED APPELLATE NOTIFICATION DATED 14.11.2023.

PRAYER:

On acceptance of the instant appeal, the impugned Notifications dated 24.08.2023 and 14.11.2023 may graciously be set aside and appellant may kindly be reinstated into service with all consequential back benefits.

Respectfully Sheweth,

Facts giving rise to the present appeal are as under:-

1. That appellant is law abiding citizen of the country and having all the fundamental rights which have been conferred by the constitution of Islamic Republic of Pakistan, 1973. The appellant having outstanding education carrier by possessing the degree of MSc in Chemistry and certificates of PTC, CT, B.Ed, and MEd vide Credentials (*Annex:-A*).
2. That numerous vacancies in different categories were laying vacant in the respondents office which were to be filled from amongst the eligible aspirants, therefore, a Public Notice was issued (*Annex:-B*) by soliciting applications. Appellant being eligible in terms of the advertisement applied for the numerous posts.
3. That thereafter, appellant was called to appear in written test conducted by the ETEA for the post of PST (BPS-12) to which he appeared and successfully qualified the written test by securing 126.056 marks vide merit list (*Annex:-C*). department also prepared first Tentative List and 2nd Tentative Merit List. It is further submitted that appellant was called for interview which was also qualified successfully. Moreover the first and the second Tentative Merit list as prepared by the Respondents Department has never ever been communicated to appellant.
4. That after observing the codal formalities, appellant was offered appointment against the post of PST (BPS-12) as is evident from the appointment order dated 05.08.2022 (*Annex:-D*). Appellant was medically examined by the authorized medical officer and was found fit for service vide Medical Certificate (*Annex:-E*) whereafter he took over the charge of his post vide Charge Report (*Annex:-F*) and starting performing duties to the entire satisfaction of the high ups.
5. That later on, the service of the appellant was regularized against the subject post by virtue of Notification dated 13.12.2022 (*Annex:-G*). Department prepared Service Book (*Annex:-H*) for the appellant wherein all the necessary entries were incorporated. It is further averred that appellant regularly attended the school vide extract from Attendance Register (*Annex:-I*). The respondent

departments also wrote a letter dated 08.02.2023 (*Annex:-J*) for releasing of salaries of the appellant.

6. That appellant while discharging his duties against the subject post was subjected to the Show Cause Notice dated 17.06.2023 (*Annex:-K*) by mentioning baseless, unfounded charges thereon, appellant was directed to furnish his reply within seven days. Appellant instantly submitted a detail reply to the Show Cause Notice on dated 26.06.2023 (*Annex:-L*) and refuted all the allegations.
7. That appellant was hopeful that he would be declare innocent from the false charges but vide impugned Notification dated 24.08.2023 (*Annex:-M*) he was inflicted upon the major penalty of dismissal from service against which appellant preferred Departmental Appeal on 28.08.2023 (*Annex:-N*) but the same was converted into that of removal from service vide Impugned Appellate Notification dated 14.11.2023 (*Annex:-O*)
8. That appellant being further aggrieved of the impugned Notifications dated 24.08.2023 and 14.11.2023 preferred the instant Service Appeal inter-alia on the following grounds:-

Grounds:

- A. That Respondents have not treated appellant in accordance with law, rules and policy on subject and acted in violation of Article 4 & 10-A of the Constitution of Islamic Republic of Pakistan, 1973 and unlawfully issued the impugned Notifications which are unjust, unfair and hence not sustainable in the eye of law.
- B. That it is an admitted fact that appellant didn't submit the fake degree of MEd of Peshawar University which is evident from the ETEA result and first tentative list prepared the by Department it-self. It is necessary to mention here that when appellant got recruited against the subject post he found out that his score was recorded in the appointment order as 129.730. Appellant promptly brought the matter into the notice of the high ups, wherein, appellant was informed that the score of the candidates / appointees has been taken from the

final merit list issued by ETEA authorities however, the concerned quarter told the appellant that it might be a clerical mistake and the same cannot hinder your appointment as you are coming in the selection zone even on 126.057 marks. Moreover, appellant did his MEd from the Bannu University which entry has been made in his Service Book.

- C. That it is important to add here that appellant from the very inception denied the charges as leveled against him. Para No. 6 of the reply to the Show Cause Notice is as under;

“dear sir why I submit fake degree to your office because I am one of the meritorious candidate of PST without of including my M.Ed degree numbers. I don't know who is submitted my fake degree to your office or your esteemed office is involved in illegal practice to pressurize me due to illegal way, I don't know that why he was pressurize me”

Therefore, there were factual controversy involved therefore the same could not be resolved without conducting a regular inquiry. Reliance is placed on 2019 PLC (CS) 224. It is further asserted that the MEd degree of the appellant got verified from the Bannu University on 17.11.2022, whereas the alleged degree from the Peshawar University verified on 13.06.2023 (*Annex:-P*) which clearly indicates the planted story against the appellant.

- D. That appellant was properly appointed in accordance with law on the recommendation of the properly constituted Selection Committee by the Competent Authority after meeting all the codal formalities. The appointment order of the appellant acted upon, carried into effect and now valuable rights have accrued in favor of appellant which cannot be taken away under the principle of local poenitentiae and for that matter principle of promissory estoppel.
- E. That the appointment process of the appellant was conducted according to the rules by the competent authority and no irregularity in the selection process and the appellant was pointed out. Therefore, the impugned Notifications are nullity in the eye of law and lible to be quashed.

F. That is added that proper mechanism has been catered in Rule-14 of the Khyber Pakhtunkhwa Government Civil Servants (Efficient and Discipline) Rules, 2011 read with Rule-5 of the Khyber Pakhtunkhwa Civil Servant (Appeals), 1986 maintains: -

i. "On receipt of report from the inquiry office or inquiry committee, as the case may be, the competent authority shall examine the report and the relevant case material and determine whether the inquiry has been conducted in accordance with the provisions of these rules"

ii. "If the competent authority is satisfied that the inquiry has been conducted in accordance with the provisions of these rules, it shall further determine whether the charge or charges have been proved against the accused or not"

iii. "Where the charge or charges have not been proved, the competent authority shall exonerate the accused by an order in writing, or it shall follow the procedure as given in sub-rule (6) of this rule"

G. That neither regular inquiry was conducted into the case nor any documentary or oral evidence was recorded in presence of the appellant nor he was awarded a chance of cross-examination and provided opportunity of hearing. The entire action was taken at the back of the appellant and thus he was condemned unheard, therefore, clear violation of Article-10A of the Constitution of the Islamic Republic of Pakistan, 1973 has been made.

H. That Article-10A of the Constitution of the Islamic Republic of Pakistan, 1973 read with Section-16 of the Khyber Pakhtunkhwa Civil Servants Act, 1973 provides for the right of fair trial as per prescribed law and Rules but the appellant was not fairly treated in disciplinary proceedings and the Impugned Notifications are void ab-initio as well as against the principle of natural justice. Moreover, no inquiry into the matter has been conducted which is also violation of natural justice.

I. That it is a settled legal principle that even in case of minor penalty regular inquiry is conducted where factual controversies are involved and accused must be associated with all stages of the enquiry including the collection of oral and documentary evidence in his presence and he/she must be confronted to the

same and must be afforded an opportunity of cross-examining the witnesses. In the case in hand no inquiry has been conducted. Thus the impugned Notifications are based thereon is nullity in the eye of law and hence liable to be set aside.

- J. That no opportunity of personal hearing was not afforded to the appellant by the Competent Authority. Which his repugnant of vested rights of appellants. Reliance is placed on 2003 SCMR 1126 which states that

"where the civil servant was not afforded a chance of personal hearing before passing of termination order, such order would be void ab-initio."

Further reliance is placed on PLD 2008 SC 412 which states as under:-

"Natural Justice, principles of Opportunity of hearing-Scope-order adverse to interest of a person cannot be passed without providing him an opportunity of hearing departure from such rule may render such order illegal"

Thus, appellant was condemned unheard as the action has been taken at the back of the appellant which is against the principle of natural justice.


- K. That the appellant has served the Department for about than 13 months and has consumed his precious life in the service and keeping in view his unblemished service the imposition of the major penalty in peculiar facts and circumstances of the case is harsh, excessive and does not commensurate with the guilt of the appellant.
- L. That appellant would like to offer some other additional grounds during the course of arguments when the stance of the Respondents is known to the appellant.

It is, therefore, humbly prayed that the instant appeal may graciously be accepted as prayed for above.

Any other relief as deemed appropriate in the circumstances of case not specifically asked for, may also be granted to appellant.

4. WHEREAS, he was proceeded under E&D Rules 2011 for the charges of concealment of facts, submitting a fake M.Ed degree, inefficiency and misconduct.
