#### JUDGMENT

**ATIO-UR-REHMAN WAZIR MEMBER (E)**:- Brief facts of the case are that the appellant was initially appointed as Junior Clerk on 16-09-1974 and was promoted to the post of Office Assistant on 24-01-2009. Due to a dispute of seniority with his colleagues. The appellant as well as his other colleague Mr. Muhammad Yousaf filed service appeals No. 989/2013 and 1095/2014 respectively, where one Mr. Imtiaz Hussain was private respondent in both the appeals and which were decided in the terms that representative of the official respondents had stated at the bar that the department has almost 9 vacant posts for promotion, but due to the status quo, the department cannot hold DPC meeting. The representative further stated that name of the appellants as well as private respondents, despite their

disputed seniority fails in the list, which would be forwarded for consideration to the DPC, hence it was jointly resolved that names of the appellants and private respondents may be forwarded to the DPC for consideration for promotion and if they are otherwise fit and entitled for promotion and if they are accordingly promoted, and if in case they still feel aggrieved with their seniority in the new assignment, they can move departmental appeals as well as service appeals, if so advised, hence both the appeals were disposed of on the above terms. The respondents however did not fulfill their commitment and case of the appellant was not considered for promotion well in time due to another status guo granted in service appeal No. 942/2015 in case of Noor Alam Khan, Office Assistant of the same office. Feeling aggrieved, the appellant filed departmental appeal, but in the meanwhile, the appellant reached his age of superannuation 01-05-2016 and retired from service. The appellant filed the instant service appeal in that continuation with prayers that the appellant may be granted ante-dated promotion to BPS-17 from the date, when he was eligible for promotion to the post of superintendent(BPS-17) alongwith all back benefits.

02. Learned counsel for the appellant has contended that the appellant has not been treated in accordance with law and actions of the respondents are malafide besides being discriminatory and harsh; that the respondents had stated at the bar that the department has almost 9 vacant posts for promotion and if status quo order was withdrawn, then the department would send the name of the appellant and respondents to DPC for promotion to the post of Superintendent (BPS-17), but the respondents did not convene meeting of DPC till retirement of the appellant; that the respondents issued correct seniority list in 2017, which transpires that the appellant if not retired would have been promoted in 2015, but the appellant was deprived of his promotion due to delay on part of the respondents; that the appellant was entitled for such promotion in every respect and inspite of commitment of the respondents, the appellant was kept deprived of his right of promotion, which was not warranted.

ΰŝ. Learned Deputy District Attorney for respondents has admitted to the fact that in service appeal No 989/2013 in respect of the appellant and that of Mr. Muhammad Yousaf in Service appeal No 1095/2017, the respondents had made commitment for consideration of the appellants as well as private respondents for promotion to the next grade as 9 such posts were lying vacant and all of them could be accommodated for promotion, but in the meanwhile one Mr. Noor Alam Khan vide service appeal No. 942/2015 was granted status quo, due to which the meeting of DPC could not be convened well in time and in the meanwhile, the appellant reached his age of superannuation on 01-05-2016; that such corrected seniority list was issued on the order of this honorable tribunal vide order sheet dated 29-08-2016, where name of the appellant was supposed to be at serial No. 7 of the seniority list, but since the appellant by the time retired from service, hence his name was not included in the seniority list issued in 2017, nor he was given promotion due to his retirement

04. We have heard learned counsel for the parties and have perused the record. Record reveals that respondents had committed at the bar that case of the appellant will be considered for promotion alongwith other appellant as well as private respondents, as enough vacant posts were available for promotion, but due to un-avoidable circumstances, the appellant could not be promoted, but it has been established that the appellant was entitled for such promotion and vacancy was also available, however the appellant was kept deprived of his right of promotion, which was beyond control of the appellant and for which appellant cannot be blamed. The entitlement of the appellant for promotion was not denied rather the process of promotion was withheld on the excuse of status quo granted by this Tribunal. The record, however shows that when the earlier service appeals were disposed of on the commitment of representative of the respondents on 27.07.2015, no status-quo was In filed till 06.09.2015 and status-quo was granted on 07.09.2015 in service appeal No. 925/2015 filed by one Noor Alam Khan. The respondents were thus having STED

12 Tribunal sufficient time for convening meeting of DPC, however it appears that the same was delayed malafidely. We have observed that the appellant was wrongly prevented to get next promotion and as a result of which he was not only deprived of the legitimate right of promotion but was also caused permanent loss of pensionary benefits of the higher grade. In similar circumstances, the Supreme Court of Pakistan in its judgment reported as 2008 SCMR 1537 has granted proforma promotion. Similarly in another judgment of the apex court reported as 1997 SCMR 515 and this Tribunal in Service Appeal No. 731/2015 announced on 25-10-2017 have granted similar relief.

05. In view of the foregoing discussion, the instant appeal is accepted with direction to the respondents to consider the case of the appellant for proforma promotion to the post of Superintendent (BPS-17) as per his entitlement in accordance with law and complete the process within two months. Parties are left to bear their own costs. File be consigned to record room.
