**Office order:**

1. *Whereas, Mr: Nisar Khan PST GPS Yaka Badesha was proceeded against the Khyber Pakhtunkhwa Government Servants Efficiency & Discipline, Rules 2011, for the charges mentioned in the show cause notice and was removed from service vide Notification Endst: No. 9752-58/P.F/M. Nisar/PST Dated 11.02.2016.*
2. *Whereas, he filed Departmental appeal before the Honorable Director E&SED Khyber Pakhtunkhwa Peshawar which was rejected by the appellate authority on 23.11.2017 being badly time barred.*
3. *Whereas, he filed service appeal No. 798/2022 before the Honorable Khyber Pakhtunkhwa Service Tribunal Camp Court Swat.*
4. *Whereas, the said service appeal was decided by the Honorable Khyber Pakhtunkhwa Service Tribunal Camp Court Swat dated 06.07.2023 with the direction to the respondents to re-instate the appellant & conduct a proper formal enquiry in accordance with the relevant law and rules.*
5. *Whereas, this office re-instated him in to service for the purpose of proper formal enquiry vide this office order Endst: No. 7272-73 dated 28.08.2023 & constituted an enquiry committee vide Endst: No. 7274-78 dated 28.08.2023.*
6. *Whereas, the enquiry committee conducted proper enquiry and submitted their detailed enquiry report to this office on 16.09.2023.*
7. *Whereas, as the enquiry committee found that he remained un-authorized absent w.e.f 15.06.2014 to 11.02.2016 & they recommended that the accused teacher may be proceeded in accordance with E&D Rules, 2011.*
8. *Whereas, show cause notice was served upon him vide this office Endst: No. 9290-95/P.F/Nisar Khan/Ex-PST Dated 04.10.2023.*
9. *Whereas, he filed reply to the show cause notice on 17.10.2023 through SDEO (M) Khwaza Khela Swat which was found unsatisfactory & wherein he requested that he may be heard in person.*
10. *Whereas, this office nominated SDEO (M) Barikot Swat as personal hearing officer vide this office Notification Endst: No. 10389-93/P.F/M. Nisar/PST dated 31.10.2023.*
11. *Whereas, the personal hearing officer having heard the accused teacher in person, submitted his report on 07.11.2023 wherein he submitted that the narration of the accused teacher is least satisfactory & concluded that "the undersigned is agreed with the recommendations of the enquiry committee submitted on 16.09.2023".*

*Now, Therefore I Muhammad Riaz, District Education Officer (M) Swat being the competent authority under the Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules 2011 do hereby intact upon him the already imposed penalty vide Endst: No. 9752-58/P.F/M. Nisar/PST Dated 11.02.2016 as "the major penalty of "REMOVAL FROM SERVICE" under 4 (b) (iii) of the ibid Rules in the interest of public service.*
