Appellant Jehanzeb was transferred from GPS, Zarif Shah Banda to GPS, Shah Haider Banda vide order dated 31.07.2013 against which his departmental appeal dated 05.08.2013 succeeded and resultantly appellant was posted in GPS Nashorro Kandow vide order dated 21.09.2013. In compliance of which order he took over charge on 25.09.2013. Unfortunately this last order was cancelled by the respondents vide impugned order dated 31.10.2013 against which appellant has instituted this appeal before Tribunal under Secion-4 of the Khyber Pakhtunkhwa Service Tribunal Act 1974. 3. The respondent-department have filed their para-wise comments which is also available on record.
	(a)	4. Arguments hared and record perused.
		5. Contention of learned counsel for the appellant is that cancelation impugned order dated 31.10.2013 caused pre-mature transfer of the appellant which is against the Government policy of Transfer and posting. It was further submitted that the impugned order was politically motivated for which the learned counsel for the appellant referred to letter dated 03.12.2013 from the office of District Education Office Malakand to the S.O Primary Govt: of Khyber Pakhtunkhwa E&SE Peshawar. Next it was submitted that this cancellation order tantamount to withdraw of the relief granted in the shape of the order which was cancelled and hence against the principle of Locus-potentia reliance was placed on 2000 SCMR 67, 2007 SCMR 599 and 2003 MLD 507 (H). The learned counsel for the appellant requested that the impugned cancellation order may be set aside
-		and the appellant may be let to perform his duty at GPS Nashorro Kandow which also falls within jurisdiction of his Union Council.

- 6. Contrary it was submitted by the learned Government Pleader on behalf of the respondent-department that the appellant has not filed any departmental appeal against cancellation order dated 31.10.2013, hence this appeal is not maintainable in the light of Section-4 of the Khyber Pakhtunkhwa Service Tribunal, ACT 1974. It was further submitted that the fact has been given to the impugned order on behalf of the appellant and he has taken charge at the relevant school, therefore, the order has been acted upon can not be disturbed. Reliance was placed on PLJ 1996 (S.C) 601.
- 7. The Tribunal heard the learned counsel for the parties at length and perused the record with their assistance. Appellant was posted at GPS Zarif Shah Banda as a result of promotion/up-gradation vide order dated 09.02.2013 wherefrom he was transferred after 5 months to GPS Shah Haider Banda vide order dated 31.07.2013. Since that place, as stated by learned counsel for the appellant fell in the jurisdiction of the Union Council Ghari Usmani Khel therefore the situation was rectified on the departmental appeal of the appellant. Resultantly appellant was posted in GPS Nashorro Kandow, situated in his Union Council but that order was cancelled by way of political interference. This situation reveals that the appellant is posted in a school which does not fall in the jurisdiction of his Union Council which is evidently against the law of Khyber Pakhtunkhwa (Appointments, Deputation, Posting and transfer of Teachers, Lecturers, Instructors and Doctors) Regulatory Act, 2011. The letter dated 03.12.2013 referred by learned counsel for the appellant also shows that the cancellation order was passed on the direction of the Chief Minister. As such the impugned cancellation order is defective which needs reconsideration. Since precious time of students is involved, therefore, the Tribunal would not directly interfere by seting-aside the impugned order. The Tribunal rather would refer the case to the competent authority to look into the matter in the light of Khyber Pakhtunkhwa (Appointments, Deputation, Posting and transfer of Teachers, Lecturers, Instructors and Doctors) Regulatory Act, 2011 within a time of one month after receipt of this judgment failing which the impugned order dated 31.10.2013 would be deemed to have been cancelled. Parties are left to bear their own costs. File be consigned to the record.

AN ACT to regulate by law appointments, postings and transfers of teachers serving in primary, middle, secondary and higher secondary schools, lecturers in colleges and instructors in technical institutions and doctors in health facilities.

Preemble.---WHEREAS it is expedient to regulate by law appointments, postings and transfers at local level, of teachers serving in primary, middle, secondary and higher secondary schools, lecturers in colleges and instructors in technical institutions and doctors in health facilities and to ensure the availability of teachers in schools, lecturers in colleges and instructors in technical institutions and the doctors in health facilities, and to regulate deputation of doctors abroad, and to provide for matters connected therewith or ancillary thereto;

It is hereby enacted as follows:

- 1. Short title, application and commencement.---(1) This Act may be called the Khyber Pakhtunkhwa (Appointment, Deputation, Posting and Transfer of Teachers, Lecturers, Instructors and Doctors) Regulatory Act, 2011.
- (2) It shall apply to teachers serving in primary, middle, secondary and higher secondary schools, lecturers in colleges as well as commerce colleges and instructors serving in technical institutions and doctors serving in the health facilities in the Province of the Khyber Pakhtunkhwa.
 - (3) It shall come into force at once.
- 2. Definitions.---(1) In this Act, unless the context otherwise requires, the following expressions shall have the meanings hereby respectively assigned to them that is to say,-
 - (a) "Commission" means the Khyber Pakhtunkhwa Public Service Commission;
 - (aa) "college" means a degree college;
 - (b) "doctor" means a doctor serving in the health facility;
 - (c) "Government" means the Government of the Khyber Pakhtunkhwa;
 - (d) "health facilities" mean all health facilities established and managed by Government to provide medical facilities to general public;
 - (e) "lecturer" and "instructor" respectively means a lecturer or an instructor serving in a Technical Institution as well as in a college, as the case may be;
 - (f) "prescribed" means prescribed by rules made under this Act;

Provided that the period of such training or long leave shall not be less than one year and no appointment on contract or contingent shall be made on the post which may fall vacant for a period less than one year.

- 5. Initial posting. --- (1) The doctors, lecturers, instructors subject specialist or teachers, upon their appointment shall be first posted in the periphery of the zone against whose quota they have been recruited, and they shall not be transferred for a period of at least three years.
- (2) Upon expiry of the tenure as referred to in sub-section (1), transfer shall be made only upon the availability of substitute.
- 5. Deputation of Doctors.---(1) Government may allow deputation abroad for all categories of doctors only once in their entire service, for a period not exceeding three years.
- (2) Deputation to "Foreign Service" within Pakistan shall be permissible only in respect of medical officers for a period not exceeding three years:

Provided that no further extension, on expiry of agreed tenure shall be given to the doctors who are already on deputation abroad or within Pakistan.

- 7. Postgraduate Medical Education.---(1) The Health Department, on the basis of objective need assessment and analysis, shall determine the intake number of Trainee Medical Officers (TMOs) in Postgraduate Medical Institute (PGMI) and Junior Registrars in Tertiary Care Hospitals every year. This stipulated number shall not exceed in any case.
- (2) Any doctor selected or permitted for postgraduate medical training shall be treated on leave without pay and may be entitled only for stipend fixed by Government from time to time for such training.
- (3) A doctor selected or permitted for postgraduate medical training shall provide surety bond prescribed by Government ensuring that upon completion of his studies for which he was initially selected, shall compulsorily serve for three years in the district of

- (h) "school" means school in the public sector including primary, middle, secondary school, higher secondary school or an institution of equivalent level imparting education through any system or medium of instruction in the public sector;

- (2) Words and phrases used in this Act, but not defined, shall have the same meanings as respectively assigned to them under the relevant federal law or provincial law or any other statutory order or rules for the time being in force.
- 3. Appointment, posting and transfer of primary school teachers.—
 (1) The vacancy of primary school teacher shall be filled in from the candidates belonging to the Union Council of their permanent residence mentioned in their Computerized National Identity Card and domicile, on merit and if no eligible candidate in that Union Council is available where the school is situate, such appointment shall be made on merit from amongst eligible candidates belonging to the adjacent Union Councils:

Provided that on availability of a vacancy, a primary school teacher, appointed from adjacent Union Council, as referred to in this sub-section, shall be transferred against a vacant post in a school of the Union Council of his residence within a period of fifteen days.

- (2) Upon marriage, the primary school teacher on request may be transferred to the school in the Union Council, where his spouse, ordinarily resides, subject to the availability of vacancy.
- (3) The primary school teacher shall be transferred to other school within the Union Council on completion of tenure as may be prescribed or before completion of tenure, subject to the policy of rationalization for maintaining certain students teachers ratio, if any.
- (4) Government shall, within a period not exceeding one year of the commencement of this Act, make arrangement for posting of all the primary school teachers appointed prior to coming into force of this Act, to the schools of their respective Union Councils or adjacent Union Councils, as the case may be:

Jurisdiction barred.---Save as provided under the Khyber Pakhtunkhwa Civil Servants Act, 1973 (Khyber Pakhtunkhwa Act No. XVIII of 1973), the Khyber Pakhtunkhwa Civil Servants (Appeal) Rules, 1986 and the Khyber Pakhtunkhwa Service Tribunal Act, 1974 (Khyber Pakhtunkhwa Act No. I of 1974), no order made or proceedings undertaken under this Act, or the rules made there under or any officer authorized by it shall be called into question in any Court, and no injunction shall be granted by any Court in respect of any decision made, or proceedings taken in pursuance or by any power conferred by or under this Act or the rules.
- 21. Removal of difficulties.—Government may, by order, provide for the removal of any difficulty which may arise in giving effect to the provisions of this Act.

The enquiry officer conducted enquiry in the matter and submit his recommendation and proposal to adjust the appellant at GPS Nashoro Kandow .The District Review Committee, Malakand agreed with the proposal/recommendations of the enquiry officer and the appellant was adjusted at GPS Nashoro Kandow on the recommendation/proposal of the enquiry officer and District Review Committee, Malakand vide order endst: No 5278-91 Dated 21-09-2013.(Copy of order and DRC annexed ad annexure C and D)
- 5. Incorrect. That the orders dated 31-09-2013 was cancelled vide office order Endst: No.6178-85 dated 31-10-2013 which is according to law and rules.
- 6. Incorrect The appellant has got no cause of action and this appeal is liable to be dismissed on the following grounds.

GROUND.

- A. Incorrect, that the orders dated 31-7-2013 and 31-10-2013 were issued under the rules policy, facts and according to natural justice.
- B. Incorrect, the appellant was treated in accordance with law, rules and respondents have not violated articles of constitution.
- C. Incorrect, the appellant was promoted from SPST BPS-14 to PSHT BPS-15 and adjusted on the basis of seniority nearest to his home station.
- D. Incorrect, Both the orders were issued on the recommendation/direction of the Departmental promotion committee/Departmental Review Committee.
- E. Incorrect, As explained in Para (D) above.
- F. Incorrect, the impugned order dated 31-07-2013 and subsequent order dated 31-10-2013 have been issued by the competent authority and are according to law and rules on the subject.
- G. Incorrect, the principle of LOCUS POENITENTIAE have not been violated As per section 10 of civil servant Act, He is bound to serve any where.
- H. Incorrect .The impugned orders are according to law and rules .
- I. As That the respondent seek permission to advance other grounds and proof at the time of arguments.

It is therefore most humbly prayed that the instant appeal may be dismissed with cost.

REJOINDER ON BEHALF OF APPELLANT IN RESPONSE TO THE REPLY SUBMITTED BY THE RESPONDENTS

R/ SHEWETH:

PRELIMINARY OBJECTIONS: (1 TO 5):

All the preliminary objections raised by the respondents are incorrect and baseless and not in accordance with law and rules rather the respondents are estopped due to their own conduct to raise any objection at this stage of the appeal.

ON FACTS:

- 1- Admitted correct hence need no comments.
- 2- Admitted correct hence need no comments.
- 3- Incorrect and not replied accordingly. That astonishingly just after six months stay at GPS Zarif Shah Banda the appellant was transferred pre-maturely to GPS Shah Haider Banda vide order dated 31.7.2013. That feeling aggrieved the appellant filed Departmental appeal against the order dated 31-07-2013 with the contention that being senior most employee of the Department and under the policy of the provincial Government the appellant should not be disturbed/transferred from GPS Zarif shah Banda.
- 4- Incorrect and not replied accordingly. That on the said Departmental appeal the respondent Department constituted inquiry in the matter which ended in favor of the appellant vide dated 21-09-2013 and the appellant was transferred to GPS Nashoro Kandow vide order dated 21.9.2013. That in result the appellant took over the charge of the said post vide dated 25-09-2013.
- 5- Incorrect and not replied accordingly. That respondent No.4 being blue eyed person to the local MPA of Tehsil Dargai was succeeded just after the laps of one month and ten days by canceling the order dated 21-09-2013.

6- Incorrect and not replied accordingly hence denied.

GROUNDS: (A TO I):

All the grounds of main appeal are correct and in accordance with law and prevailing rules and that of the respondents are incorrect and baseless hence denied. That being senior to private respondent No.4 the appellant has the right to be adjusted near to his home station under the law and prevailing policy of the Government of Khyber Pakhtunkhwa. That the impugned orders dated 31-07-2013 and 31-10-2013 are against the Notification dated 21-01-2013 of the respondent Department and also against the clause I, II and IV of the transfer/posting policy of the provincial Government of Khyber Pakhtunkhwa. Moreover the impugned order dated 31-10-2013 has been issued in violation of the principal of "LOCUS POENITENTIAE".

It is therefore most humbly prayed that on acceptance of this rejoinder the appeal of the appellant may be accepted as prayed for.
