Prayer:

On acceptance of this Appeal the concerned respondents
may please be directed to bring the name of the
appellant within the seniority list.

Respectfully Sheweth:

1. That the appellant was appointed I the year 1987 at the post of SET.

2. That since then the appellant is serving at the above said post and now-a-days he is serving at Government Higher Secondary School Korai D.I. Khan.
3. That the appellant has been serving the respondent department by heart and sole and has never given any chance of complaint to the department or to the students community.
4. That now when the service of the appellant is reaching to the tenure about 30 years his seniority/name is missing in the seniority lists.
5. That one seniority list was issued by the respondent department in the year 2012 whereby the name of the appellant was missing in the said seniority list. (Copy of the seniority list of 2012 is attached herewith as annexure 'A').
6. That another Tentative Seniority List of SETs for promotion to the Subject Specialist (S.S) was again published by the respondents, whereby the name of the appellant was fixed at Serial No.1. (Copy of the Tentative Seniority List is attached herewith as annexure 'B').
7. That to the astonishment of the appellant when the Final Seniority List was issued in the year 2015 the name of the appellant was totally missing from the said seniority list. (Copy of the Final Seniority List of 2015 is attached herewith as annexure 'C').
8. That being aggrieved of the said Final Seniority List the appellant then filed a Departmental Appeal on 27.01.2016, however, no heed

whatsoever was paid to the Departmental Appeal of the appellant.

(Copy of the Departmental Appeal dated 27.01.2016 is attached herewith as annexure 'D').

9. That there being no other remedy the appellant now approaches this Honourable Service Tribunal on the following grounds amongst the others:-

GROUND:

- a. That dropping name of the appellant from the Seniority List is an act illegal, unlawful, without authority/jurisdiction, as well as being based on the malafide intentions of the respondent department, is liable to be set aside.
- b. That it is very much strange to bring into the kind notice of this Honourable Tribunal that the name of the appellant was brought at Serial No.1 in the Tentative Seniority List, however, later on the name of the appellant was dropped from the Final Seniority List without mentioning any cogent reasons.
- c. That the respondents Department is doing all this on the malafide intention to oblige their blue eyed Teachers, hence after dropping the name of the appellant from the seniority list they have promoted other SE Teachers to the post of Subject Specialist (S.S), whereas name of the appellant has been dropped even from the above said promotion.

- d. That it is the Constitutional/legal right of the appellant that he should be given his due seniority, as the promotions are made on the Seniority-Cum-Fitness but the appellant has been deprived of his such seniority right without mentioning any cogent/lawful reasons.
- e. That if the name of the appellant is not brought within the seniority list he will be deprived of his right of promotion and other legal rights.

It is, therefore, humbly prayed that on acceptance of this Appeal the concerned respondents may please be directed to enter the name of the appellant at the proper placed of the seniority of the appellant as according to his service length and as well as according to his seniority under the relevant rules of seniority.

JOINT PARAWISE COMMENTS FOR & ON BEHALF OF RESPONDENTS No: 1-2.

Respectfully Sheweth :-

The Respondents submit as under:-

PRELIMINARY OBJECTIONS.

- 1 That the Appellant has got no cause of action locus standi.
- 2 That the instant Service Appeal is badly time barred.
- 3 That the Appellant has concealed material facts from this Honorable Tribunal.
- 4 That the instant service appeal is based on mala fide intentions.
- 5 That the Appellant has not come to this Honorable Tribunal with clean hands.
- 6 That the instant Service Appeal is against the prevailing law & rules.
- 7 That the Appellant has been treated as per law, rules & policy.
- 8 That the appeal is not maintainable in its present form.
- 9 That the appeal is bad for mis-joinder & non-joinder of the necessary parties.
- 10 That the instant Service Appeal is barred by law.
- 11 That the Appellant is not competent to file the instant appeal against the respondents.
- 12 That the Notification dated 31/7/2009, is legally competent & is liable to be maintained.

ON FACTS

- 1 That Para-I, needs no comments, being pertain to the service record of the appellant.
- 2 That Para-2 also needs no comments being pertains to the posting of the appellant against the SET post in the Respondent Department.
- 3 That Para-3 is irrelevant as every civil servant is legally & morally bound to serve his Department by heart & sole & in the interest of students community.

4 That Para-4 is incorrect & denied on the grounds that the appellant is basically hails from the SET (Tech:) cadre / Commerce & he could not be promoted alongwith General Cadre post. He has also awarded Selection Grade in BPS-17 on the strength of SET(Technical). However, prior to the said Selection Grade, the appellant has filed a Writ Petition before the Honorabel Peshawar High Court Peshawar for the inclusion of his name in the seniority list SET(G) for the purpose of his promotion in BPS-17 Headmaster post. His Writ Petition was decided with the directions to the Respondent Department for the inclusion of his name in the seniority list of SET(G) Cadre which was included vide Notification No: SO(PE)9-4/SET(Tech:) /Gen: /07/Court Cases dated 31/7/2009 with the conditions that the appellant shall submit an undertaking to the extent that after inclusion of his name in the seniority list of SET(G) he will not claim any other service benefits due to his name inclusion in the seniority list of SET(G) & in response to the said conditions only 45 out of 132 SET(Tech:) submitted the requisite undertaking excluding the appellant who filed a Writ Petition No: 656/2007 under case titled Jehanzeb SET(Tech:) GCMS Peshawar & 46 others VS Govt: before the Honorable Peshawar High Court Peshawar with the contention of inclusion of their names in the General Seniority List of SET, which is still pending adjudication before the Honorable Court.

Hence, the name of the appellant could not be included in seniority list of the SET(G) Cadre in the absence of the mentioned undertaking to be submitted by the appellant in terms of Para-III of the said Notification dated 31/7/2009. (Copies of letter dated 25/3/2016, 21/10/ 2009 & Notification dated 31/7/2009 are attached as annexed as Annexure A, B &C).


- 5 That Para-5 is incorrect & denied. Detailed reply of this Para has been given in Para-4. Hence needs no further comments.
- 6 That Para-6, is incorrect & denied. The inclusion of the name of the appellant in the Tentative seniority list does not accrue any vested right for promotion. Hence, the appellant has been treated in view of the above made submissions in Para-4 in the final revised seniority list for the year 2015, issued by the Respondent Department. Hence the plea of the appellant is liable to be struck down.
- 7 That Para-7 is correct that the name of the appellant has not been included in the seniority list as stood on 2015 for the reason as agitated in Para-4.
- 8 That Para-8 is incorrect & denied. No departmental appeal against the seniority list for the year 2015, has been filed by the appellant.
- 9 Para-9 needs no comments. The Respondents further submit on the following grounds inter alia :-

GRONDS


- a Incorrect & not admitted. The exclusion of the name of the appellant from the final revised seniority list for the year 2015 is within legal sphere in view of the submissions in Para-4 of the instant reply.

All the Preliminary Objections as raised are wrong and denied. The appellant has got locus-standi, no question of limitation, concealment, malafide, maintainability, mis-joinder, non-joinder could be raised against the appellant.

ON FACTS:

1. That para No.1 has been admitted correct, hence needs no reply.
2. That para No.2 has also been admitted correct.
3. Needs no comments.
4. Wrong and denied. The name of the appellant has never been entered into the seniority list as issued by the respondent department, even the seniority list issued for the year 2015 name of the appellant has not

been entered in the said list. (Copy of the Seniority List of SSTs issued on 31.12.2015 is attached herewith as annexure 'R/1'). Similarly the story of Selection Grade is baseless, the appellant has never been granted any Selection Grade. The appeal is simple to enter the name of the appellant in the seniority list as according to his seniority, so far as the question of SET (Tech) is concerned the other colleagues of the appellant namely Maday Jan who has passed his B.Ed alongwith the appellant on 22.12.1992 he has been entered into the seniority list and Maday Jan serial Number in the seniority list is 340 and now after promoting as Head Master he has been kept at serial No. 219. Similarly in serial No from 198 to 202, 5 Technical Teachers have been promoted to the post of Head Masters, whereas the appellant has neither been promoted nor his name has been entered into the seniority list anywhere, the remaining para is wrong and totally denied. However, in the said para the respondents have been clearly admitted that the name of the appellant has not been entered into the seniority list of the respondent departments. (Copy of the promotion of 5 Head Masters (Tech) alongwith the Maday Jan dated 17.03.2016 is attached herewith as annexure 'R/2').

5. Wrong and denied. All the reply which has been given in para No.4 is baseless, without any contents, hence is denied.
6. Wrong and denied. It is the vested right of the appellant that he should be knowing with regard to his seniority as well as his name must be entered into the seniority list of the teachers on the same footings,

hence the appellant has been treated illegally, unlawfully, against the prevailing rules and his plea with regard to entering his name into the seniority list is legal and genuine.

7. Wrong and denied. It is the legal and basic right of the appellant that his name must be entered into the seniority list.
8. Wrong and denied. The appellant has filed a Departmental Appeal as required under the law.
9. Needs no comments.

GROUND:

- a. Wrong and denied. Excluded the name of the appellant from the final seniority list is illegal, unlawful act on the respondents side.
- b. Wrong and denied. Again the respondents have tried to deceive this Honourable Tribunal by saying that that the name of the appellant was included in the tentative seniority list for the year 2012. It is pertinent to mention here that since the appointment of the appellant his name has never been entered in the seniority list.
- c. Wrong and denied.
- d. Wrong and denied. The appellant has not been treated as according to the law and rules and there is no policy that the

name of some Civil Servant should be excluded from the seniority list without mentioning any cogent reason.

- e. Wrong and denied. The appellant has been deprived from his promotions since long, whereas all his other colleagues have been promoted as Head Masters, whereas the appellant is still sitting in BPS-16 as SST.

It is, therefore, humbly prayed that keeping in view the above noted submissions the appeal of the appellant may please be accepted as prayed for as the appellant has not been promoted throughout his tenure of service extending over 30 years.

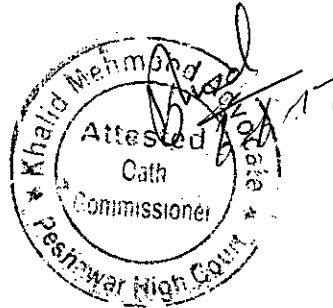




