



**Prayer in Appeal:**

On acceptance of the appeal the order of the respondent No.1; vide Endst No. 2992-9, dated: 26-10-2015 (Annexure "C"), may kindly be set aside / cancelled and the respondent No.1, may also be ordered to abstain from victimizing and torturing the appellant illegally without any justification for the same.

Respectfully Sheweth:-

**FACTS:**

1. That the appellant is a PSHT (BPS-15) and performing her duties at the Govt. Girls Primary School No. 1, Maneri Bala, U/C Maneri Bala (Swabi) and also a permanent resident of Maneri Bala, Union Council Maneri Bala (Distt: Swabi).
2. That the appellant was transferred on 13-08-2012 from GGPS No.1 Maneri Payan (Swabi) to GGPS No.1, Maneri Bala (Swabi) by the order of respondent No.1, copy of the Order is Annexure "A-1" while an affidavit qua Charge Report is Annexure "A-II".
3. That the appellant was performing her duties as PST at the GGPS No.1, Maneri Bala, and was promoted to BPS-15, vide Endst No. 1207-G, dated: 18-06-2013, and transferred / adjusted to GGPS Kandaro. Copy of the Order is Annexure "A-III", but the appellant was wrongly / shown as at the GGPS Maneri Payan and hence an appeal was preferred to respondent No. 1 for the correction, copy of which is Annexure "A-IV".
4. That at this juncture the respondents No.1 to 3, started victimizing and torturing the appellant by their acts of malafide and ill will.
5. That the above appeal for the correction of the order etc. was accepted and the appellant was again transferred to GGPS Maneri Bala (U/C Maneri Bala) as per U.C Act, 2011. Copy of the Order of respondent No.2 is Annexure "A-IV (I)" and "A-IV (II)", which reflects the admission of mistake in Annexure "A-III".
6. That once again, the appellant was victimized by transferring her on 24-08-2013 from GGPS Kandaro to GGPS No.2, Hund (U.C Hund). Copy of the Order is Annexure "A-V" and the appellant filed an application to respondent No.1 for the review of the Order, dated: 24-08-2013, Annexure "A-V" on the ground that the appellant being the resident of U/C Maneri Bala could not be transferred to GGPS-2 Hund as per the provision of the U.C Act, 2011. Copy of the application is Annexure "A-VI".
7. That to the utter surprise of the appellant, on 10-12-2013, the appellant was again transferred from GGPS Kandaro to GGPS No.1, Maneri Bala. Copy of the Order, dated: 10-12-2013 of the respondent No.1 is Annexure "A-VII", which copy of the Charge Report is Annexure "A-VIII".
8. That once again, the appellant was served with an order by respondent No.2, dated: 27-08-2015, alleging therein that appellant was working on a wrong post and directed the appellant to resume her duty at original school, but that was not given in the aforesaid order, dated: 27-08-2015. Copy of the order is Annexure "B".
9. That the appellant requested the respondent No.1, through an application for pointing out the "Original School". Copy of the application is Annexure "B-I".
10. That without replying the Annexure "B-I", on 26-10-2015, the respondent No.1, issued an order vide which the appellant has been transferred from GGPS No.1, Maneri Bala

(U/C Maneri Bala) to a far flung GGPS Said Shah Gari (Pabainin), U/C Pabaini. Copy of the order dated: 26-10-2015, of the respondent No.1 is Annexure "C".


- 11. That the appellant submitted an application to respondent No.1 for the review / withdrawal of the order, dated: 26-10-2015 Annexure "C" but in vain. (Copy is annexed C-1)
- 12. That the appellant preferred departmental appeal to respondent No.5, on 20-11-2015 personally which was received by the concerned clerk Mohammad Iqbal, who put office diary No. 640/20-11-2015 in token of its receipt. Copy of the departmental appeal is Annexure "D".
- 13. That the appellant awaited the response but he learned departmental Appellate Authority kept mum, hence, the appellant has approached this Honorable Tribunal through this appeal.
- 14. That the appellant has been mercilessly victimized and tortured psychologically by the respondents 1 to 3 at the instance of the local political elements so that she may surrender and enter the political arena as their worker but the appellant has resisted every such pressure so far.
- 15. That the impugned order is illegal, ultra-vires, and without any justification inter-alia on the following

**GROUND:-**

- (a) That the impugned order Annexure "C" is totally against the prevailing law and the rules, hence not tenable and liable to the set-aside / struck down.
- (b) That the impugned order as well as the other orders of the respondents as referred to above, are totally against the spirit of law, equity and justice and clearly reflect the victimization and malafides of respondents which ought to be curbed.
- (c) That the respondents totally have ignored the relevant laws and have willfully violated the rights of a civil servant hence the impugned order as well as the other orders / acts of respondents amount to gross illegality, mal-administration and it seems to be a denial of legal authority of the state.
- (d) That the respondent No.1 in particular, and others in general are bent upon to torture and humiliate the appellant which further amounts to violate for the appellant, rights guaranteed by the Constitution and the prevailing civil Servant Act.
- (e) That the impugned order as well as other orders mentioned afore, call for judicial notice and the respondents be sternly dealt with in accordance with law.
- (f) That the respondent No. 1 has acted as a despot and has awefully ignored his legal responsibilities and hence liable to be questioned for her such deplorable illegal acts / omissions / violations of the norms of law, the rules, equity and justice.
- (g) That the impugned order is also contrary to the spirit of law and the precedents as laid down by the Hounourable Superior Courts of Pakistan.


**Prayer:-**

**PRELIMINARY OBJECTIONS:**

- 1) That, the appellant has no cause of action to file the instant appeal.
- 2) That, the instant appeal is badly time barred.
- 3) That, the appellant has filed the instant appeal just to pressurize the respondents.
- 4) That the appellant has not come to the Tribunal with clean hands.
- 5) That the appellant has concealed material facts from Honourable Tribunal.
- 6) That appellant is stopped to file the appeal by his own conduct.
- 7) That upon concealment of facts, no one can claim any relief hence the instant appeal is liable to be dismissed.

**ON FACTS:**

1. Incorrect that the PSHT(B-15) is the District Level post not U/C and can be transfer at any school in District under the prevailing rules and policy. Under rules 10(a) of Govt: Servant 1973 any teacher can be transfer where deem necessary by the competent authority.
2. In correct that she was adjusted at GGPS NO:1 Maneri Bala on the acceptance of her appeal but there was no vacant PSHT post at the said school which was already occupied by Mst.Nasim Akhtar on seniority basis according the rules and policy.
3. Correct. She was promotion to PSHT B-15 and adjusted at GGPS Kandaro in her own UC vide order NO:1207-G dated 18/6/13 but she did not took over charge at the same station.
4. Denied and Incorrect. She was sitting wrongly on detailment at GGPS NO:1 Maneri Bala where the has already filled.
5. Incorrect and denied. That the appeal for the correction of her previous school correct. And the PSHT B-15 is the District level post on which cannot apply the UC Act; 2011.
6. That Mst.Nasim Akhtar PSHT was also the residence of the same UC(Maneri Bala) and on the seniority basis she was adjusted at GGPS NO:1 Maneri Bala while the appellant was adjusted against vacant post of PSHT at GGPS NO:2 Hund under the prevailing rules and policy.
7. As per reply at para No;2 above.
8. Incorrect, she was working on detailment at GGPS NO;1 Maneri Bala, which was against the rules and policy. As she was reported by the concerned SDEO(F)Swabi vide NO:682 dated 27/8/15.
9. That there was no vacant post at GGPS NO:1 Maneri Bala therefore her application/appeal was rejected.

Respectfully Sheweth:-

Preliminary objections:

1. In response to the 1<sup>st</sup> preliminary objection it is submitted that the appellant has a genuine cause of action. The so-called preliminary objection is denied.
2. Denied. The Appeal is within time.
3. Wrong, unfounded and baseless, hence denied.
4. Wrong, incorrect and baseless, hence denied.
5. Wrong, baseless, and incorrect hence denied.
6. Wrong, incorrect and unfound, therefore denied.
7. Wrong, unfounded and baseless, hence denied in toto. The appellant has not concealed any facts from the hon'ble court, has come to the court with clean hands and has got a genuine and legal cause of action, hence she is entitled to seek relief from the Hon'ble Tribunal in accordance with law.

**Facts:-**

- 1 In response to the reply of the respondents No: 1 to 4, it is submitted that the contents of the reply to para No: 1 of the appeal, are totally irrelevant. The appellant is PSHT ( BPS-15) and performing her duties as such and is the permanent resident of U/C Maneri Bala (Swabi). The reply being irrelevant is denied.
- 2 The reply to para No: 2 of the appeal, is also irrelevant and not at all the profer reply, hence denied. In fact the appellant was transfer on 13-08-2012, from GGPS Maneri Payan to GGPS No. 1 Maneri Bala. Annexure A-1 and A-II prove the fact.
- 3 Contents of the reply of the respondents No. 1 to 4, of the appeal are also irrelevant. The appellant when promoted to PSHT B-15 was already serving in GGPS No. 1 Maneri Bala (swabi) her own U/C and the order of promotion was quite legal.
- 4 The contents of the reply to para 4 of the appeal are also irrelevant. The order, annexure A-I and annexure A- VIII have nothing to mention the detail-ment at GGPS No: 1 Maneri Bala. Hence the reply to para No: 4 is denied in toto.
- 5 Again the contents of reply to para No: 5 of the appeal are totally irrelevant, hence denied. the order annexure A-1 was quite legal and the appellant was rightly transfer and posted at the GGPS No: 1 Maneri Bala in her own U/C in accordance with law.
- 6 Reply of the respondents to para No: 6 of the appeal is also not relevant and unfounded, hence denied. Nasim Akhtar PSHT belongs UC Maneri payan and was not transferred to GGPS NO: 1 Maneri Bala. In fact one Gulhar Begum respondents No – 3 was transferred from GGPS No.1 Maneri Bala to

- GGPS No: 1 Maneri Payan, vide annexure A-1 and was wrongly shown in GGPS No: 1 Maneri Bala and adjusted as such in GGPS No: 1 Maneri Bala.
- 7 Para No: 7 of the appeal has not been properly replied, hence no comments.
- 8 One again, the contents of the reply to para 7 of the appeal are irrelevant, hence denied. There was no such detailment order issued to the appellant rather the appellant was shown being on a wrong post, however, the same also proved incorrect and unfounded, which annexure B properly reflects.
- 9 Reply to para No: 9 of the appeal has also no relevancy at all. The respondents No: 2, vide order 27-08-2015 alleged appellant posting on a wrong post and direct to resume duties at the "Original school" but when requested to point out the same, it was not replied and transferred from GGPS No: 1 Maneri Bala to GGPS Said Shah Ghari Pabaini, (the impugned order), All the same reflect victimization of the appellant through out.
- 10 Reply to para No. 10 of the appeal is also not relevant hence denied. The appellant's posting at GGPS No. 1 Maneri Bala, UC, has been in accordance with the facts as well as the prevailing law. The impugned order being illegal, hence challenged.
- 11 Para No: 11 of the appeal has also not been replied properly and the reply is irrelevant hence denied.
- 12 No Comments.

- 14 The respondents have not denied the victimization of the appellant in their reply to the contents of para no: 14 of the appeal, hence it amounts to admission on the part of respondents No. 1 to 4, and the Hon'ble Tribunal is requested to take notice of the admission.
- 15 Again the respondents No: 1 to 4, have not clearly denied the contents of para no: 15 of the appeal which may also be deemed an admission of the respondents.
