



LAW AND RULES AND AGAINST NOT TAKING ACTION ON
THE DEPARTMENTAL APPEAL OF THE APPELLANT WITHIN
THE STATUTORY PERIOD OF THE NINETY DAYS.

PRAYER

THAT ON THE ACCEPTANCE OF THIS APPEAL, THE
IMPUGNED SENIORITY LIST DATED 06/06/2023 MAY BE
DECLARED ILLEGAL AND UNLAWFUL AND IN VIOLATION
OF SECTION-4 of REGULARIZATION ACT 2009 AND LARGER
BENCH JUDGMENT OF SUPREME COURT IN CA NO. 135-

P/2013 DATED 24.02.2016. THE RESPONDENTS MAY PLEASE BE DIRECTED TO CORRECT/RECAST THE IMPUGNED SENIORITY LIST DATED 06/06/2023 OF SUBJECT SPECIALIST AND PLACE THE NAME OF APPELLANT AT PROPER POSITION IN SENIORITY LIST AS PER SECTION-4 OF REGULARIZATION ACT 2009. ANY OTHER REMEDY WITH THIS AUGUST TRIBUNAL DEEMS FIT AND PROPER MAY ALSO BE AWARDED THE FAVOR OF THE APPELLANT.

RESPECTFULLY SHEWETH

FACTS

1. That the appellant joined the respondent Deptt: as on contract basis in year 2007 along with her colleagues later the contract was extended for one another year. The performance of the appellant was upto the mark. **Copy of appointment order and extension order is attached as Annexure-A).**
2. That in the year 2009 regularization act was promulgated whereby the services of the colleague of the appellant was regularized w.c.from 24/09/2009 vide order dated 31/05/2009 and appellant was also regularized with effect from 24/09/2009 vide order dated 28/04/2012. **Copy of the regularization order is attached as annexure-B.**
3. That the department issued tentative seniority list which is also against the Section-4 of the Regularization Act 2009 which was properly objected time to time but the deptt not response to objections and kept himself mum on objections. **Copy of tentative list and objections are attached as annexure-C & D.**
4. That now the deptt issued Final Seniority list notified on 06-06-2023 received by the appellant on 26/06/2023 which is also against the section -4 of the regularization act 2009 which is not sustainable, the appellant being feeling aggrieved filled departmental appeal against the impugned seniority list which was not responded in the statutory period of ninety days. **(Copy of seniority list and departmental appeal as annexure-E & F).**
5. That the appellant come to this august tribunal on the following grounds amongst others.

GROUNDS

- A. That not responding on Departmental appeal within the statutory period of 90 days and the impugned seniority list is against the law, illegal, unlawful, without and lawful authority, thus calling interference of this learned tribunal.
- B. That the appellant is senior in age and continuous officiation as appellant was appointed in year 2007 while the junior colleagues were appointed in year 2008 so, the impugned seniority list is against the law and rules.
- C. That in the terms and condition of regularization order clearly mentioned that the seniority shall be determined as per Section-4 of the Regularization ACT 2009 but despite that the seniority not prepared as per the same.
- D. That as per section 4 of the regularization act 2009 the seniority will be determined in manner following below:

“The seniority interse of the employees, whose services are regularized under this Act within the same service or cadre, shall be determined on the basis of their continuous officiation in such service or cadre.”

“Provided that if the date of continuous officiation in the case of two or more employees is the same, the employee older in age shall rank senior to the younger one.”

REGULARIZATION ACT 2009 is available in Esta Code KP.

- E. That the impugned seniority list is against the norms of service law and principles of natural justice and dictums of the apex courts.
- F. That the impugned seniority list is the worst example of favoritism, nepotism and colorful exercise of powers which is not warranted under law.
- G. That according to judgment of Larger Bench of Supreme Court of Pakistan held that “section 4A of 2009 Act Overriding effect “of this Act expressly excludes the application of any other law and declares that the provisions of this Act will have overriding effect, being a special enactment. In this background, the causes of respondents squarely fall within the ambit of the Act and their services were mandated to be regularized by the provisions of the Act 2009. But the impugned seniority list was not issued according to the regularization Act 2009,

which is against the law and rules and subject to correction of this Hon'able Tribunal. **Copy of larger bench SC Judgment is attached as annexure-G**


- II. That according to Section-8 of the Civil Servant Act 1973 and section-17 of APT Rules 1989, it is the legal right of every civil servant to properly placed in seniority list according to his seniority position, but the same benefits was not extended to the respondent which is the violation of law and rules.
- I. That some colleagues of the appellant junior in age from the appellant but placed senior to the appellant in violation of Sec-4 of the Regularization Act 2009. Which needs correction.
- J. That the impugned seniority list is against the norms of service law and principles of natural justice and dictums of the apex courts.
- K. That the impugned seniority list is the worst example of favoritism, nepotism and colorful exercise of powers which is not warranted under law.
- I.. That the impugned seniority list may be declared unlawful and not according to judgment of Larger Bench of Supreme Court of Pakistan i.e and not according to Regularization Act 2009.
- M. That according to Section-8 of the Civil Servant Act 1973 and section-17 of APT Rules 1989, it is the legal right of every civil servant to properly placed in seniority list according to his seniority position, but the same benefits was not extended to the appellant which is the violation of law and rules.
- N. That the appellant was treated according to the law and rules and has been deprived from his legal right of seniority in arbitrary manner without fault on his part.
- O. That the appellant craves permission of this honorable tribunal to rely on other grounds at the time of arguments and produce any additional document if required in support of instant service appeal.





DEPARTMENTAL APPEAL AGAINST THE FINAL SENIORITY LIST OF SUBJECT SPECIALIST WHICH WAS NOTIFIED ON 06/06/2023.

PRAYER:

ON ACCEPTANCE OF THIS DEPARTMENTAL APPEAL, THE IMPUGNED SENIORITY LIST MAY BE DELCAR4E ILLEGAL AND THE APPELLANT MAY BE PLACED AT PROPER PLACE OF HIS SENIORITY IN SENIORITY LIST ABOVE THE JUNIORS.

RESPECTFULLY SHEWETH:

FACTS:

1. That the appellant joined the respondent Deptt: as on contract basis in year 2007 along with her colleagues later the contract was extended for one another year. The performance of the appellant was upto the mark. Copy of appointment order and extension order is attached as Annexure-A)
2. That in the year 2009 regularization act was promulgated whereby the services of the appellant was regularized with effect from 24/09/2009 vide order dated 28/04/2012. Copy of the order is attached as annexure-B
3. That the department issued tentative seniority list which is also against the Section-4 of the Regularization Act 2009 which was properly objected time to time but the deptt not response to objections and kept himself mum on objections. Copy of tentative list and objections are attached as annexure -C & D.
4. That now the deptt issued Final Seniority list notified on 06-06-2023 which is also against the section -4 of

the regularization act 2009 which is not sustainable the appellant being feeling aggrieved filing this departmental appeal against the impugned seniority list dated 28.02.2015 on the following grounds.

GROUNDS:

- A. That the appellant is senior in age and continuous officiation as appellant was appointed in year 2007 while the junior colleagues were appointed in year 2008 so, the impugned seniority list is against the law and rules.
- B. That as per section 4 of the regularization act 2009 the seniority will be determined in manner following below:
"The seniority interse of the employees, whose services are regularized under this Act within the same service or cadre, shall be determined on the basis of their continuous officiation in such service or cadre."

"Provided that if the date of continuous officiation in the case of two or more employees is the same, the employee older in age shall rank senior to the younger one."
- C. That the impugned seniority list is against the norms of service law and principles of natural justice and dictums of the apex courts.
- D. That the impugned seniority list is the worst example of favoritism, nepotism and colorful exercise of powers which is not warranted under law.
- E. That according to judgment of Larger Bench of Supreme Court of Pakistan held that "section 4A of 2009 Act Overriding effect "of this Act expressly excludes the application of any other law and declares that the provisions of this Act will have overriding effect, being a special enactment.in this background, the causes of respondents squarely fall within the ambit of the Act and their services were mandated to be regularized by the provisions of the Act 2009. But the impugned seniority list was not issued according to the regularization Act 2009, which is against the law and rules and subject to correction of this Hon'able Tribunal.

- F. That according to Section-8 of the Civil Servant Act 1973 and section-17 of APT Rules 1989, it is the legal right of every civil servant to be properly placed in seniority list according to his seniority position, but the same benefits were not extended to the respondent which is the violation of law and rules.
- G. That some colleagues of the appellant junior in age than the appellant but placed senior to the appellant on violation of Sec-4 of the Regularization Act 2009. Which needs correction.

It is, therefore, most humbly prayed that the impugned seniority list may be set aside and recast the seniority list as per law and rules and placed the appellant on his right position in the seniority list.
